# 2018 Maximum Income Levels to Qualify for Subsidized Units

Eligibility for most programs is based on the Area Median Income, as identified in the table above. The Area Median Income is published each year by the U.S. Department of Housing and Urban Development (HUD). Income levels shown are based on HUD's information and are effective as of April 1, 2018.

\* Denotes special income limits published by the California Tax Credit Allocation Committee.

# What is Affordable Senior Housing?

Housing is deemed “affordable” if the mortgage or rent, plus an average utility cost, does not exceed 30% of a household’s gross monthly income. In Ventura County, a “very low-income” one-person household has a gross annual income of less than \$32,700 per year, or \$2,725 per month. Therefore, the mortgage or rent payment and utilities should not exceed \$817 to be considered affordable to that one-person household.

Whether or not a specific person or household can afford a subsidized unit is a question best answered by the individuals involved, depending on their other monthly expenses and priorities. Not everyone can afford to spend 30% of their monthly income on housing and utility expenses.

For those households with incomes under 50% of Area Median Income, the Section 8 Housing Choice Voucher program may help pay a portion of the rent. 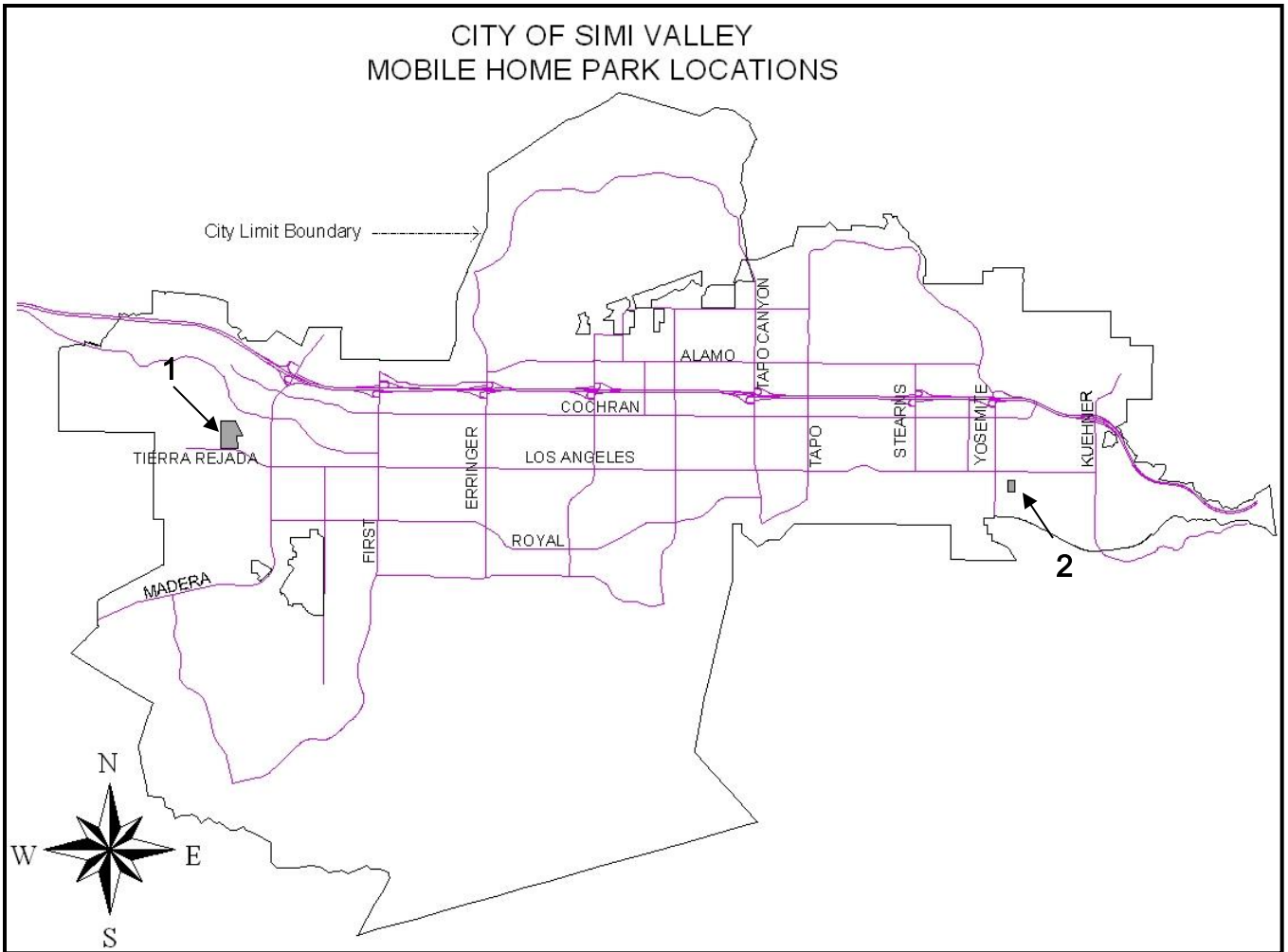
