1. Call to Order/Pledge of Allegiance/Welcome

2. Agenda Review

The agenda was approved as presented.

3. Approval of Minutes

<u>ACTION</u>: A motion to approve the March 17, 2015, minutes as written was made by Nicolas Mintzer and seconded by Leah Nohrenberg.

Youth Council vote: 17 Ayes; 0 Noes; 0 abstentions

The motion passed.

4. Correspondence

Ms. Tignac reported that correspondence was received on March 17, 2015, and March 24. 2015, thanking the Youth Council and 2015 Youth Summit participants for generously donating 250 pounds of "products and goodies".

5. Public Statements/Comments

No public statements or comments were made.

6. Informational Presentation

Jodi Regan, Volunteer and Marketing Coordinator with the Simi Valley Public Library, gave a brief overview of the Library's volunteer program, including types of volunteer opportunities, eligibility, and the application process. She stated that there are 60 student volunteer openings for the summer program requiring a volunteer commitment of 25 hours over a seven week period.

Ms. Regan announced upcoming teen events in April and May. She also promoted the bookmark art contest and stated that submissions are due no later than May 15, 2015.

7. New Business

a. Discussion of the Campaign for a Presidential Youth Council

Nick Steinwender gave a brief overview of the Campaign for a Presidential Youth Council, which was brought to the Youth Council's attention by Royal High School student Connor Kubeisy. The proposed Presidential Youth Council will consist of 24 youth ages 16 to 23. This bipartisan, privately funded, diverse group will meet four times per year to design solutions to some of America's most pressing problems.

Youth Council members discussed requesting permission from the City Council to send a letter of support of the Campaign for a Presidential Youth Council to Congressman Steve Knight.

<u>ACTION</u>: A motion to approve staff drafting a letter of support for the Campaign for a Presidential Youth Council was made by Kellie McManamon and seconded by Timothy Ho.

Youth Council vote: 19 Ayes; 0 Noes; 0 abstentions

The motion passed.

b. Discussion of Youth Council Recruitment

Ms. Tignac gave a brief overview of the Youth Council recruitment process. Youth Council applications were distributed for the 2015-16 term. Eligible Youth Council members interested in re-applying should submit their applications as soon as possible.

Ms. Tignac stated that all Youth Council members should be promoting the Youth Council recruitment and that applications may also be submitted online at www.simivalley.org/YouthCouncilApp. She announced that completed applications must be received no later than 5:00 p.m. on Friday, May 1, 2015.

As out-going Youth Council members, Nick Steinwender and Chris Busco volunteered to sit on the Interview Sub-committee.

c. Discussion Regarding Canceling the May 5, 2015, Youth Council Meeting After a brief discussion, members stated that they would be available to attend the May 5, 2015 Youth Council meeting.

Ms. Tignac stated that the Youth Council has traditionally reserved a table at the Job and Career Expo to promote civic engagement and volunteer opportunities, as well as, Youth Council recruitment.

Nick Steinwender recommended that the Youth Council form a committee early in the 2015-16 term to assist staff in drafting an application for the League of California Cities' Helen Putnam Award of Excellence program under the category "Ruth Vreeland Award for Engaging Youth in City Government".
