### 6. Informational Presentations

### a. National Public Works Week

Jim Langley, Deputy Director/Sanitation Services, and Barbara Langley, Laboratory Supervisor, gave a brief overview of services provided by the Public Works Department. They also discussed environmental compliance and waste water treatment challenges, such as improper prescription medication disposal and its negative effect on wildlife.

Ms. Langley discussed water conservation efforts, food and its water footprint.

They stated that due to impending retirements of those hired after the passing of the Clean Water Act, there is a great demand for jobs in their fields, such as engineering, chemists, biologists, operators and collection workers. They stated that they are piloting a new internship program for operations.

Ms. Langley invited all members to attend Public Works Day on May 21, 2015, from 9:00 a.m., to 3:00 p.m. at the Public Services Center, where there would be giveaways, plant tours and more.

### b. Simi Valley Public Library Teen Programming

Llyr Heller, Young Adult Librarian gave a brief overview of programs that would be offered this summer for teens at the Simi Valley Public Library, such as the teen reading program, special teen events, and interest clubs.
