1. Call to Order/Pledge of Allegiance

2. Welcome/Introduction of Youth Council Members

Ms. Tignac welcomed the 2015/16 Youth Council. All members participated in a brief icebreaker activity.

3. Agenda Review

Ms. Tignac recommended that the Youth Council be flexible with moving Agenda Items 7.b., 7.c., and 8.b. to accommodate guest presenters' schedules. There were no objections.

4. Approval of Minutes

ACTION: A motion to approve the June 8, 2015, minutes as written was made by Alex Judge and seconded by Leah Nohrenberg.

Youth Council vote: 20 Ayes; 0 Noes; 0 Abstentions

The motion passed.

5. Correspondence

No correspondence was received.

6. Public Statements/Comments

Council Member Mike Judge introduced himself as one of the City Council Liaisons to the Youth Council and briefly discussed his personal background. He emphasized the importance of the Youth Council to the City Council and as youth leaders.

8. New Business

b. Discussion of Proposed Changes to Transit Fares and Senior Service Age Anna Medina, Administrative Officer, gave an overview of the City's transit fare box recovery ratio and need leading up to the proposed transit fare increases.

Youth Council members discussed advertising options on buses to generate revenue, increasing promotion of transit at schools, and opposition to raising fares for handicapped and senior citizens.

ACTION: A motion to recommend increasing the adult/student rate and maintaining current rates for handicapped individuals, senior citizens and monthly student bus passes was made by Nicolas Mintzer and seconded by Gurvardaan Bal.

Youth Council vote: 20 Ayes; 0 Noes; 0 Abstentions The motion passed.

7. Informational Presentations

a. Youth Council Purpose, Goals, By-laws, Organization and Meetings

Ms. Tignac provided an overview of the Youth Council Purpose, Goals, By-Laws and Organization of the Youth Council and highlighted some of the Youth Council accomplishments to date.

Ms. Tignac also discussed the importance of the Youth Council's Work Plan in order to accomplish the Youth Council goals that members would set during the October Youth Council meetings.

- b. Overview of the Role of the City Attorney and Ralph M. Brown Act
 - City Attorney Lonnie Eldridge gave a brief overview of the role of the City Attorney's office and the purpose of the Ralph M. Brown Act. He emphasized that Youth Council members became public officials the moment they were appointed by the City Council and therefore under the City Attorney's auspices in their Youth Council roles.
- c. Code of Ethics and Conduct for Elected Officials and Members of Appointed Boards, Commissions and Committees

City Attorney Eldridge gave a brief overview of the City's Code of Ethics and Conduct for Elected Officials and Members of Appointed Boards, Commissions and Committees, including its purpose, who it applies to and the ethical principles in the code.

8. New Business

a. Officer Duties and Election of Youth Council Officers

Ms. Tignac gave a brief overview of the Youth Council Officer's duties and responsibilities. The following Youth Council members were nominated for the position of Chair: Kellie McManamon, Nicolas Mintzer and Emily Ramirez. Kellie McManamon received the most votes and was selected as Chair.

The following Youth Council members were nominated for the position of Vice Chair: Alex Judge, Elisabet Lindskog, Nicolas Mintzer, Leah Nohrenberg, Prachi Patel, Zalma Quezada, and Emily Ramirez. Nicolas Mintzer received the most votes and was selected as Vice Chair.

The following Youth Council members were nominated for the position of Sergeant-at-Arms: Gurvardaan Bal, Janhavi Damerla, Jeffrey Ho, Nicolas Judge, Elisabet Lindskog, Jasanpreet Pandher, and Marina Vicente. Gurvardaan Bal received the most votes and was selected as Sergeant-at-Arms.

The election of the Youth Council Secretary was continued until the September 15 Youth Council meeting.

e. Discussion of Suicide Prevention Awareness event in collaboration with the Simi Valley Public Library on Thursday, September 3, 2015

Ms. Tignac announced that the Youth Council had an opportunity to collaborate with the Simi Valley Public Library and Rancho Simi Recreation and Park District for a suicide prevention awareness event on Thursday, September 3, 2015. The event would include a film screening and discussion of the California Mental Health Services Authority (CalMHSA) Directing Change Student Public Service Announcement (PSA) Contest regional and statewide winners in the categories of suicide prevention and ending the silence of mental illness, along with details on the 2016 contest.

Ms. Tignac stated that six Youth Council members were present at the City Council Meeting on August 31, 2015, for the proclamation of September 2015 as Suicide Prevention Month.

<u>ACTION</u>: A motion to approve the Youth Council's involvement in cohosting a suicide prevention film screening and promotion of the 2016 California Mental Health Services Authority (CalMHSA) Directing Change Student PSA Contest was made by Alex Judge and seconded by Sal Gulino.

Youth Council vote: 20 Ayes; 0 Noes; 0 Abstentions The motion passed.
