6. Police Liaison Report

Officer Longdon, who is a School Resource Officer (SRO), gave a brief overview of what it is that he and the other SROs do during a school day. An SRO is responsible for campus safety at all Simi Valley Unified School District (SVUSD) schools, as well as private schools, that total to approximately 24,000 students. They deal with campus crimes such as drugs and violent crimes. They are especially concerned when they find stolen prescription pills at the schools because statistics show that prescription pills are a "gateway drug" to heroin use. He was asked about the funding of the positions and he informed the Executive Board that the positions are not funded by the School District, but rather by the Simi Valley Police Department.

7. Informational Presentations

a. The Samaritan Center- How They Help the Homeless Help Themselves

Betty Eskey, Executive Director of The Samaritan Center, which is located next to Madera Elementary School, gave a presentation on what the Samaritan Center does to assist the homeless. Prior to the recession of 2008, they were helping about 35-40 people per day. In the years

following, they helped as many as 130 per day. The center provides an array of services but requires that any person seeking assistance must work with their case manager to develop and follow an action plan to become productive members of the community and minimize their need for services. Ms. Eskey informed the Executive Board not to provide any money to a homeless person who is panhandling. Instead she suggested that you offer to buy that person a hot meal or donate to a charity. Ms. Eskey also provided a handout of items that are needed at the center.
