DRAFT MINUTES

- 1. Call to Order and Pledge of Allegiance Chair Toni Olson called the meeting to order at 1:00 p.m. John Schick led the Pledge of Allegiance.
- Roll Call Members present were Jean Cecil, Barbara Durham, Fred Goldberg, Sharon McCann, Toni Olson, Kenneth Sinn, June Marie Von Osinski and John H. Williams.
- 3. Agenda Review By consensus of the Executive Board item 7. A. and item 9. C.4. were deleted. The agenda was then approved as amended.
- 4. Approval of Minutes The minutes of October 12, 2015, were approved by a consensus of the Executive Board.
- 5. Report of COA Chair Toni Olson thanked Vice Chair Barbara Durham for chairing the meeting last month. She then reminded the members that the Senior Center would be closed on Wednesday, November 11, in honor of Veterans Day and asked members too recognize the veterans present at the meeting. Ms. Olson then reminded members about the jewelry sale November 16 20 at the Senior Center and the Senior Summit on November 14.

6. Representative Reports

- A. City Council Liaison Council Member Mike Judge informed members there will be a 20 year anniversary celebration of the Cultural Arts Center on November 8. He also mentioned the Christmas tree lighting ceremony that will be held at the Simi Valley Town Center this weekend. When members inquired about upcoming developments, he said several grocery stores have expressed interest in relocating into the empty storefronts in Simi Valley including Smart & Final, Stater Brothers, Sprouts, and Aldi's. Council Member Judge also said that Denny's is closing and Chick-fil-A is moving into its space. He then told members the Task Force on Homelessness would meet this Thursday.
- B. Deputy Director/Community Programs & Facilities Rob Bruce announced that a new library director, Matthew Hortt, has been hired.
- C. Senior Services Manager Robert Martin, Assistant Senior Services Manager, reported that the Rotary Club is not sponsoring a Thanksgiving Eve dinner anymore due to Health Department concerns. Instead, it is going to donate the funds they would have spent on the event to the COA to help fund an additional Meals On Wheels route, which will begin on

- December 1. Instead, the Senior Center will offer an expanded Thanksgiving menu for lunch that day for 100 seniors.
- D. Ventura County Area Agency on Aging Representative Toni Olson reported that the VCAAA will meet this Thursday. One of the agenda items addresses revising the formula to allocate funds for the Senior Nutrition Program.
- E. Task Force on Homelessness June Marie Von Osinski mentioned that the Task Force would meet this Thursday, November 12, at 3:30 p.m.

7. Presentations

- A. This item was deleted under item 3, Agenda Review.
- B. Senior Housing Josefina Aguilar, Department of Environmental Services, discussed some reasons for the lack of an adequate amount of affordable housing in the City of Simi Valley. She said although 434 affordable units are presently approved and under review, 360 units will go back to market rate by 2018 due to the affordable housing agreements expiring. In addition, there has been a 20% increase in rental rates simultaneously with reductions in median income which have resulted in long waiting lists. Ms. Aguilar told members there is a Senior Housing Guide for Simi Valley and also a Quarterly Development Summary which provides an overview of commercial and residential projects in review. Both are available on the City website under Environmental Services Department, Planning Services.

- 9. Officer, Liaison, Program Manager, and Ad Hoc Committee Reports

A. Officer Reports

- 1. Vice Chair No Report.
- Treasurer Sharon McCann reported that the budget continues to be in good shape. Then bookkeeper Don Novell gave a year-end report on COA expenditures made last year including the sound loops, window tinting, freezer for the Senior Share program, low vision keyboards, new sound system for the Multipurpose room, and new projectors for Classroom 106 and the Tech Lab.
- 3. Corresponding Secretary Ken Sinn reported responding to several Meals On Wheels donations.

B. Liaison & Program Manager Reports

- 1. Speakers Bureau Program Manager No Report.
- Senior Share Liaison Joe Beautz told the COA that the program is presently giving out 104 bags per week. The Fresh & Easy market closures have resulted in less donated food. He said Albertson's still donates and the Center for Spiritual Living is donating special baskets for Thanksgiving. He also said holding a food drive is a possibility. In response to a question about the agency Food Forward, he responded that he already accesses this resource.
- 3. Housing Liaison Judy Pepiot gave an update on current projects, including Runkle Canyon.
- 4. Lifeline Liaison No Report.
- Meals On Wheels Liaison Ed Mazeika reported that 2,616 meals were delivered in October. He also informed members they will be adding a new route December 1. There are presently 26 drivers with 3 more in training. They are presently looking for one additional driver.

C. Ad Hoc Committee Reports

- 1. Dance Committee Jean Cecil urged members to purchase their tickets to the New Year's Eve, Eve, dance before it is sold out.
- 2. Arts & Crafts Fair Committee Toni Olson announced that the Fair had been successful. Revenue for the COA was \$2,300 from the vendors, \$1,800 for the pancake breakfast, and \$2,100 for the rummage sale.
- 3. Annual Fund Drive Committee Sharon McCann reported that the drive was continuing on schedule and to date \$3,200 had been raised.
- 4. This item was deleted under item 3, Agenda Review.
- 5. Wayne Templeton Volunteer of the Year Committee John Williams stated that several nominations had been received.

Update on the sale of current Rancho Simi Recreation & Park District headquarters site:

Last month the district's board chose the Ventura County Area Housing Authority's bid to purchase their existing headquarters at 1692 Sycamore Drive. USA Properties will be the developing partner on this 13.2 acre site.

Before the sale can close, the parties have to negotiate final terms & both agencies' governing boards have to approve them, so at this point, a "potential buyer" has been selected.

The proposed project will demolish the decades-old buildings & construct two different areas of multifamily housing:

- 1. Up to 95 rental apartments for low income seniors (Section 8 vouchers accepted)
- 2. Up to 251 general-occupancy, market rate rental units in the other area
 - These market rate units would provide the cash flow to support the affordable senior units & also provide additional multifamily rental options in Simi Valley

If all final terms of the sale are successfully completed, the proposed project still must go through the city's planning process for approval.
