A. Update on ADA/DAR Capacity and Service Improvements

The changes have resulted in service to additional passengers, shorter wait times for the vehicle to arrive, and enhanced customer service including trip reminders the day prior to the scheduled trip.

A. Discussion of Proposed Changes to Transit Fares and Senior Service Age

A presentation was given by Sommer Barwick, Director of Community Services, regarding proposed increases to Transit Fares and Senior Service Age.

Questions and comments from the audience/responses from staff:

Gaylord Trubey suggested raising the fixed-route special fare from \$.50 to \$1.00.

Sommer Barwick said she would take that into consideration.

Why is there no shelter at the Chatsworth Metrolink Station bus stop?

There is no room at that location per ADA shelter regulations.

MOTION: Recommend that all fixed route bus fares be increased by \$0.25.

The following motion was made by Pauline Cabal and seconded by Rebecca McCann:

MOTION: Recommend that all seniors pay mandatory fare of \$1.50 or \$2.00 instead of donation.
