#### **DRAFT MINUTES**

- 1. Call to Order and Pledge of Allegiance Sharon McCann called the meeting to order at 1:02 p.m. Joe Beautz led the Pledge of Allegiance.
- 2. Roll Call John Williams called Roll Call. Members present were Jean Cecil, Karen Cline, Al Fournier, Fred Goldberg, Char Jackowitcz, Ed Mazeika, Sharon McCann, Stephanie Newbrook, and June-Marie von Osinski.
- 3. Agenda Review By consensus of the Executive Board, item 9. B. 2., the Senior Share Liaison's report, was moved to follow 6. E.
- 4. Approval of Minutes The minutes of February 8, 2016 were approved by a consensus of the Executive Board.
- 5. Report of COA Chair Sharon McCann recognized Judy Pepiot who was awarded Moving Seniors Forward's "Soaring Star Award". She read an Irish poem in honor of St. Patrick's Day. Sharon stated that a free Easter breakfast for seniors will be sponsored by the Kiwanis Club on Easter morning, and she offered Happy Easter wishes to all.
- 6. Representative Reports
  - A. City Council Liaison Council Member Mike Judge said that the results of the annual audit will be announced at this week's City Council meeting. Mike reported that a hearing will be held at tonight's City Council meeting addressing if marijuana can be grown in Simi Valley for medicinal purposes. He stated that the new Smart & Final at East Los Angeles Avenue and Stearns Street is planning to open at the end of April. He also reported that Dunkin' Donuts is coming to the Smart & Final mall on Erringer Street. The Town Center mall is downsizing the retail stores, and Marshall's and Ulta will be moving in. There will also be a Starbucks drive-thru opening in the mall parking lot.
  - B. Deputy Director/Community Programs & Facilities Rob Bruce reported that the City of Simi Valley is going solar. OpTerra Energy Services company will be discussed and the contract will be up for approval at tonight's City Council meeting. Solar panels are planned for the City Hall, the Public Library, and the Senior Center.
  - C. Senior Services Manager Laurie Dickinson announced the City of Simi Valley is recruiting volunteers for the Citizens Transportation Advisory Committee. There are six meetings per year and purple fliers giving more information are available on the table.

- D. Ventura County Area Agency on Aging Representative(s) Toni Olson reported that the Strategic Plan, which is a 5-year plan for the county, approved \$140,000 for home delivered meals in Simi Valley. She said information cards about VCAAA's services are available on the table.
- E. Task Force on Homelessness June-Marie von Osinski said the Task Force met on February 11. She stated that a sub-committee has been formed to try and help the community change their view of what homelessness looks like. She said several police officers have special training to deal with homeless people and that the focus is on housing people first, then "wrapping services" around that.

#### 7. Presentations

- A. Volunteer of the Month Ella Cranny was recognized for ten years of service teaching the Arthritis Chair Exercise class and for leading the Fibromyalgia Support Group.
- B. California Senior Legislature Senior Assembly member Bill Witt gave a PowerPoint presentation about the legislature. Bill went over some of the laws that the legislature is trying to get passed.
- 8. Public Statements Judy Pepiot reminded everyone that the Kiwanis are sponsoring the Easter breakfast for seniors. She also said that the Kiwanis Round Up fundraiser will be held April 16 and tickets are \$30 if purchased ahead of time or \$35 at the gate.
- 9. Officer, Liaison, Program Manager, and Ad Hoc Committee Reports
  - A. Officer Reports
    - 1. Vice Chair Al Fournier No Report.
    - Treasurer Karen Cline stated two significant differences between budgeted and actual amounts. Revenue is higher than budgeted because the COA held a Bingo Bonanza fundraiser which wasn't budgeted for early spring due to planned construction in the kitchen. She also noted that Meals On Wheels expenses are lower than budgeted because the COA has not received a bill from the City.
    - 3. Corresponding Secretary Stephanie Newbrook reported that ten thank you letters were sent out, two of them to sponsors of COA dances.

#### B. Liaison & Program Manager Reports

- 1. Speakers Bureau Program Manager No Report.
- 2. Senior Share Liaison Joe Beautz said that 95 people were currently receiving brown bags. In response to a question from the

last COA meeting, Mr. Beautz stated that if someone hasn't shown up for three weeks, they are contacted. The Food Share of Ventura County will refer to Joe before taking someone off the list. If they later return, Joe is also contacted for reinstatement.

- 3. Housing Liaison Judy Pepiot reported that the Cabrillo Economic Development project at 1384 Katherine Road South, known as Camino Esperanza, is starting construction. There will be 11 units for seniors with disabilities, 3 units for low-income seniors, and the remaining 16 units will be for qualifying seniors. There is no wait list yet.
- 4. Lifeline Liaison Don Novell said that Toni Olson is now a volunteer on the Lifeline Team. Phillips is the company monitoring the phones and its contract is coming up for renewal. The team is thinking about what they are going to do on this. There are 450 units that only work in homes with land lines. Because more and more people are just using cell phones, the Lifeline program is considering their options. They currently have only 12 units that work with cell phones. The Simi Valley Hospital wants to continue with this project. Lifeline charges are based on the client's ability to pay.
- 5. Meals On Wheels Liaison Ed Mazeika No Report.

#### C. Ad Hoc Committee Reports

- Dance Committee Helen Loring said that the last dance was held on a very rainy day, but 78 people still attended. The dance classes held before the dances have also been well attended.
- 2. Bingo Bonanza Committee Sharon McCann reported that the Bingo Bonanza netted \$5,300. A big thank you was given to Jean Cecil for chairing the food and to Fred Goldberg for obtaining door prizes for the event.
- 3. Wellness Expo Committee Karen Cline thanked Claudia Hapip, Senior Services Assistant Manager, for her help with this big project. There are fifty exhibitors and they still need volunteers to help at the event.

#### 10. Continued Business

Discussion/Action on holding a Senior Social Connection event on Friday, May 20, 2016.

The Vintage Senior Care Home is sponsoring this event and people should sign up at the front desk. Twenty women and twenty men can be accommodated, with the men moving from table to table.

Laurie Dickinson explained how the event would work and said the cost will be minimal.

Motion made by Sharon McCann and seconded by Fred Goldberg to sponsor a Senior Social Connection.

# VENTURA COUNTY AREA AGENCY ON AGING VCAAA Advisory Members

VCAAA Advisory Members are nominated by the local Council On Aging and appointed by the City Council for a two year term.

The VCAAA's mission is to serve Ventura County's aged 60+ population, adults with one or more disabilities and their unpaid caregivers by:

- Providing leadership in addressing issues that relate to older Californians, adults with disabilities and their caregivers.
- Developing and maintaining community based systems of care that provide services supporting independence within California's interdependent society, and which protect the quality of life of older persons and persons with functional impairments.
- Enhancing and supporting existing community based service providers systems of care and long term services and supports.
- Promoting citizens involvement in the planning and delivery of services for Ventura County's seniors and adults with disabilities and their caregivers.

This mission shall be accomplished through a network of Education, Advocacy, Problem Solving, Program Planning and Funding.

#### Regular/Mandatory Meetings:

- Verbal Report to the Simi Valley COA Executive Board on the 2<sup>nd</sup> Monday of each month, at the Simi Valley Senior Center.
- Attend/Participate the VCAAA Advisory Council meeting every other month on the 2<sup>nd</sup> Wednesday of every other month, at the VCAAA office in Ventura.
- Attend/Participate in at least two monthly VCAAA Advisory Council Committees Meetings, at the VCAAA offices in Ventura.

The VCAAA Advisory Council/Committee meetings are held at VCAAA Office 646 County Square Dr, Ventura, CA 93003.
