1. Call to Order/Welcome/Pledge of Allegiance

Chair Robert Sherman called the meeting to order at 7:30 p.m. Secretary Pamela Dean confirmed a quorum was present.

2. Agenda Review

By consensus of the Executive Board, the agenda was approved as presented.

3. Approval of Minutes

A motion was made by Andrew Gorden and seconded by Tracy Fessler to approve the March 10, 2016, minutes as presented. The motion passed unanimously.

5. Public Statements/Comments

Four residents expressed concern about the clean-up efforts of the nuclear waste contamination at the Santa Susana Field Lab site. Residents believe the clean-up efforts will still leave 98% of the site's contamination in place. The residents feel the contamination leaves the area's residents at an unacceptable risk of contracting cancer. The residents requested that the Executive Board urge the City Council to look into the matter.

8. New Business

a. Election of Interim Officers

By consensus of the Executive Board, Rob Sherman was elected Interim Chair, Kelly Tinker was elected Interim Vice Chair, and Pamela Dean was elected Interim Secretary.

9. Neighborhood Council Coordinator's Report

Emily Habib stated that the Neighborhood Councils are recruiting new Executive Board members and recruitment will ends this Friday, April 15. There are currently 13 applicants for four openings on Neighborhood Council #3.

She asked for feedback on who would be interested in starting future meetings at 7:00 p.m. instead of 7:30 p.m. Four people supported the idea and two did not.

10. Executive Board Member Comments

Shannon Johnson commented that the Boys and Girls Club will host a Job and Career Fair for Simi Valley youth on April 30 from 10:00 a.m. to 1:00 p.m. Approximately 45 employers will on hand. High school and college students looking for jobs are encouraged to come dressed professionally and ready for job interviews.

Ashley Chelonis commented that she is aware that an environmental team from UC Berkeley came down and verified that only a portion of the agreed upon clean up of the Santa Susanna Field Lab had actually been completed.

Robert Sherman commented that he is in agreement that the City Council should be urged to look into the matter of the SSFL clean up and should provide clarification as to what is happening regarding the site's clean up efforts. He also announced that the Rotary Club will hold its annual Gator run on April 24 and Joanna's Tea Party, on May 1. The event will support cancer research. He also announced that the Simi Valley Street Fair will be on May 14, and the Cajun Music Festival will be on May 30, during Memorial Day weekend.

Andrew Gorden commented that the new homes in Runkle Canyon are very nice and he would hate for owners to buy them without knowing the possible risk for contracting cancer due to the SSFL contamination.

Pamela Dean stated that the Community Development Block Grant committee recently awarded funding to Many Mansions, a provider of low-income housing for the homeless.
