1. Call to Order/Welcome/Pledge of Allegiance/Introductions

5. Public Statements/Comments

A resident who lives adjacent to Arcane Avenue between Royal Avenue and Erringer Road, inquired about a proposed two story assisted living facility that would be adjacent to the resident's backyard. The resident asked if the item would be reviewed by Neighborhood Council 2 in the near future. Emily Habib explained that the application is still being reviewed for completeness and suggested the resident subscribe to receive e-notifications for upcoming Neighborhood Council 2 meetings. Ms. Habib also stated that the Planning Division would be able to provide a detailed status about the application.

6. Informational Presentation

a. Coastal Cleanup Day

Kay Allen, Environmental Compliance Program Coordinator with the City of Simi Valley, gave a presentation on the California Coastal Commission's Coastal Cleanup Day. The purpose of this international event is to clean up the garbage along the coast and inland waterways to protect sea life and improve water quality. This event is held every year on the third Saturday in September. This year's event will be on September 17, 2016, from 9:00 a.m. to noon. Volunteers will meet at the

Rancho Simi Community Park at the corner of Royal Avenue and Erringer Road. The cleanup activities will take place along the Arroyo Simi between First Street and Sycamore Drive. Assistance from the Neighborhood Councils is being sought in order to promote the event and get more volunteers.

9. Neighborhood Council Coordinator's Report

Ms. Habib announced that the Living Green Expo will take place on September 24, 2016. Ms. Habib offered cards for Executive Board members to invite future attendees to a Neighborhood Council meeting. She also distributed copies of maps showing the Simi Valley Police Department Community Liaison Officer's assigned sections and office contact information for each of the officers.

10. Executive Board Comments

Rick Grossman stated that with the Citizen's Election Advisory Commission was beginning as the election season was progressing. He also felt that the special Neighborhood Council meeting on June 16, 2016, was very constructive and hoped that more citywide issues will be brought to the Neighborhood Councils in the future. He also stated that through the County Continuum of Care \$1.9 million came to Ventura County to address the issue of homelessness.

Kimberly Drewes stated that she participated in the annual Ventura County Point in Time Homeless Count and that it was a rewarding experience.

Robert McLaren requested information on the newly redone railroad crossings at both Sycamore Drive and Erringer Road. Specifically, he was concerned that no limit lines had been striped to keep cars from moving too close to the tracks. Ms. Habib will report back on this issue in August.
