5. Correspondence

Ms. Tignac stated that Youth Council Chair Emily Ramirez, along with members Zalma Quezada and Adrian Schemm, spoke with a reporter from the Simi Valley Acorn newspaper regarding an article on suicide prevention for the newspaper's September 23, 2016 edition.

6. Public Statements/Comments

7. Continued Business

a. Officer Duties and Election of Youth Council Officers

Ms. Tignac gave a brief overview of the Youth Council Officer's duties and responsibilities.

The following Youth Council members were nominated for the position of Vice Chair: Zalma Quezada and Adrian Schemm. Adrian Schemm received the most votes and was selected as Vice Chair.

The following Youth Council members were nominated for the position of Sergeant-at-Arms: Aditya Gaiki, Nick Judge and Leah Nohrenberg. Leah Nohrenberg received the most votes and was selected as Sergeant-at-Arms.

The following Youth Council members were nominated for the position of Secretary: Aditya Gaiki and Zalma Quezada. Zalma Quezada received the most votes and was selected as Secretary.

ACTION: A motion to approve Emily Ramirez as Chair, Adrian Schemm as Vice Chair, Leah Nohrenberg as Sergeant-at-arms and Zalma Quezada as Secretary was made by Aditya Gaiki and seconded by Aaron Williams.

8. New Business

b. Discussion of the Timeline for Partnered Events with the Walter and Leonore Annenberg Presidential Learning Center

Rebekah Harding, Educational Outreach Manager, announced that the Presidential Learning Center had a new official name. They are now the Ronald Reagan Presidential Foundation and Institute. Ms. Harding gave a brief overview of last year's Youth Town Hall event that was held at the Ronald Reagan Presidential Library and Museum with a panel that was comprised of; 25th Congressional District Congressman Steve Knight,

Simi Valley Mayor Bob Huber, Rancho Simi Recreation and Park District Board Member Dee Dee Cavanaugh and Simi Valley Unified School District Superintendent Dr. Jason Peplinski. She stated that last year more than 500 middle and high school students attended.

Ms. Harding stated that similar to last year, Youth Council would assist in coordinating this youth-driven event, including making recommendations on potential panel speakers.

Ms. Harding stated that Youth Council members would be included in the school visit polling sessions in December 2016. She stated that members could create a survey to poll classmates on what issues they would like to discuss with the panel speakers during the month of October.

Ms. Tignac stated that Youth Council members would discuss and develop a list of potential Youth Town Hall panel speakers' names during the October 4 Youth Council meeting.

Ms. Harding announced that the Ronald Reagan Presidential Foundation and Institute would hold a Women's Leadership Conference on Saturday, November 19, 2016, in honor of the 35th anniversary of Sandra Day O'Connor's appointment to the Supreme Court of the United States, as the first woman appointed to hold that honorable position. She invited all of the female Youth Council members to attend.

 Discussion of Volunteer Opportunities at the Free Clinic of Simi Valley's Tooth Fairy Run and Community Health Expo on Saturday, October 15, 2016

Nicolette Munoz, Volunteer Marketing Director for the Free Clinic of Simi Valley, gave a brief overview of services provided at the Free Clinic.

Ms. Munoz provided information about the Tooth Fairy Run and Community Health Expo scheduled on Saturday, October 15, 2016, from 7:30 a.m. to 12:00 p.m. Additionally, Ms. Munoz announced that they had multiple volunteer opportunities available for a "Social Media Team". Youth Council members signed up for various social media assignments.

Ms. Munoz also stated that they were offering the Youth Council a free booth space for the Community Health Expo. Ms. Tignac stated that last year the Youth Council had a Stop Bullying pledge banner for attendees to sign as part of the citywide Stop Bullying Pledge campaign.

Ms. Tignac stated that ideas for the booth would be discussed during the October 4 Youth Council meeting.

c. Discussion of Suicide Prevention Awareness event in collaboration with the Simi Valley Public Library on Thursday, September 28, 2016

Ms. Tignac stated that volunteers were needed to help lead group discussion during the Suicide Prevention event on Thursday, September 29, 2016. She reminded members that the event would include a film screening and discussion of the California Mental Health Services Authority (CalMHSA) Directing Change Student Public Service Announcement (PSA) Contest regional and statewide winners in the categories of suicide prevention and ending the silence of mental illness, along with details on the 2017 contest.
