6. Informational Presentation

a. How to Protect Yourself from Identity Theft

Detective Ryan Brennan from the Simi Valley Police Department made the presentation. He discussed the two main types of identity theft: credit card fraud and actual stealing of someone's identity. He advised Executive Board members to set up alerts on charges on their cards and to check their credit card statements carefully on a regular basis. The new credit cards have a Radio Frequency ID chip in them which can be read by devices and have the information stolen. There are protectors that be purchased inexpensively that will keep that from happening.

With true identity theft, personal information is stolen and can be used to create a false identity. Such thefts can occur on an individual basis or when the security of major websites is breached. The stolen identity can be used to purchase a home and cars, and even used by the person as their identity if they are arrested.

Joyce Erdman noted that the wall at Royal Avenue and Sinaloa Street is still in poor shape, though it had initially appeared that the City was in the process of fixing it. She will talk to her contact at the City and report back to the Executive Board.
