By consensus of the Executive Board, Karen Diaz was nominated as the Neighborhood Council #1 representative.

a. Review of proposed revisions to the City's Tree Preservation Ordinance

Lauren Funaiole, Senior Planner from the City's Environmental Services Department, made the presentation. She described the pertinent sections of the existing Tree Preservation Ordinance, which involve the protection of healthy mature trees on developed commercial, industrial and multifamily properties. If an applicant wishes to remove these trees, their value, as determined by an Arborist, is required to be replanted on the site in the form of specimen-size trees or deposited in a City beautification fund. This can be extremely costly, into the hundreds of thousands of dollars.

The proposed revisions would remove healthy mature trees on developed commercial, industrial and multi-family properties from the protected category. This would allow developers to remove these trees and only replace them with the much smaller size of tree required by their landscape plan.

Two alternatives were offered to the Executive Board: recommend that the existing Tree Preservation Ordinance be maintained or that the scope of the Ordinance be reduced.

The following motion was made by Steve Kahle and seconded by Dennis Lea:

MOTION: Recommend to the Planning Commission that the existing Tree Preservation Ordinance be maintained.

Executive Board vote: 8 Ayes; 4 Noes; 0 Abstentions Audience vote: 3 Ayes; 0 Noes; 1 Abstention Unincorporated Area vote: None

The motion carried.

8. Neighborhood Council Coordinator's Report

Emily Habib welcomed the seven new Executive Board members and gave them information on various Neighborhood Council procedures. She also reported that the Landsea project for 209 townhomes at the corner of Los Angeles Avenue and Madera Road came before the Planning Commission in February. The Commission instructed them to redesign a number of aspects of the project and return at a future date.

9. Executive Board Member Comments

Don Diamond reported that a number of projects that Neighborhood Council #1 had reviewed were under construction. Executive Board members introduced themselves and spoke about why they joined the Neighborhood Council Executive Board.
