# 4. Correspondence

Ms. Tignac stated that she had received a meeting request from Congressman Steve Knight's Office to discuss youth issues.

Ms. Tignac stated that the Youth Council received a thank you card from Ventura County Community College District Trustee Bernardo Perez congratulating them on another successful Youth Summit. He also thanked the Youth Council for the opportunity to participate in the breakout group and luncheon discussions.

## 5. Public Statements/Comments

Jacob Strellner introduced himself and stated that he was interested in learning more about what the Youth Council does.

Pranav Krishnamoorthi and Christian Sanders both introduced themselves and stated that they both felt the Youth Summit went really well.

Michelle Karamooz, former Valley View Middle School and Simi Valley High School alumnus stated that she was representing the non-profit group All It Takes. She stated that All It Takes offers camps designed to develop leadership skills and provides an opportunity for high school students to serve as mentors to middle school students.

Ms. Tignac reported that per the Youth Summit participant evaluations, 99% of the participants felt that the Youth Summit was meaningful to them, which was a strong statement towards the value of the event. Also, all non-graduating participants stated that they were planning on attending the Summit again next year. A few student participant quotes included:

- "The event was perfect!"

- "Made me feel my opinions and ideas are worthwhile and will be considered."

Members shared two positives and one idea to make next year's summit even better.

Youth Summit small group leaders met and reviewed their breakout sessions and lunch discussion ideas. Each team compiled notes from each breakout session and lunch discussion.
