1. Call to Order/Welcome/Pledge of Allegiance

Ms. Tignac shared the Economic Development Update presented to City Council on April 24, 2017.

6. Continued Business

Discussion of Internships, Job Shadowing, and Other Ideas for Career Exposure

Ms. Tignac stated that the Simi Valley Senior Center computer lab had been reserved on both November 8 and November 15, 2017, for the fall Scholarship Workshop.

Beth Dooley stated that students and adults seeking community service hours had an opportunity to volunteer at the Cops and Cruisers event on June 25, 2017.

John Baxter stated that volunteer opportunities were also available at the Rotary Clubs of Simi Valley's Cajun and Blues Festival on May 27 and 28, 2017.

7. New Business

a. Debrief of the 2017 YES Job and Career Expo

Ms. Tignac thanked all Board members and volunteers for their hard work organizing the 30th Annual YES Job and Career Expo. Event evaluation results were given. Members discussed low youth attendance and higher business participation citing the current local economy as a factor with many businesses promoting entry level job openings. Members also discussed ways to reach youth with event promotion and to incentivize participation.

Gloria Bowman stated that positive feedback was received from both youth and employers that participated.

Brian Miller stated that even with the lower youth turnout, business representatives at the event were still happy with the event and quality of candidates.

b. Discussion of the YES Summer Programming at the Simi Valley Public Library

Ms. Tignac gave an update of the planned YES summer programming, including an Entering the Workforce Workshop in July and a Resume Writing Workshop in August. Board members stated that September and October were impacted with school related events and to hold off scheduling more events until after the start of the school year.

c. Discussion of the Cancellation of the June 21, 2017, YES Advisory Board Meeting

Acting Chair Gloria Bowman stated that the YES Advisory Board traditionally cancels its June meeting as it falls after the end of the school year.

Rob West stated that Sub Zero Ice Cream's business model included offering STEM curriculum for students. He announced that he was hiring an employee to manage the coordination of Sub Zero Ice Cream's science-based school assemblies.
