DRAFT MINUTES

- 1. Call to Order and Pledge of Allegiance Sharon McCann called the meeting to order at 1:03 p.m. Dale Kaufman led the Pledge of Allegiance.
- 2. Roll Call Stephanie Newbrook called Roll Call. Members present were Karen Cline, Al Fournier, Ed Mazeika, Sharon McCann, Stephanie Newbrook, Antoinette Olson and Ken Sinn. Jean Cecil and Char Jackowitcz were excused. Recording Secretary Stephanie Newbrook verified there was a quorum present.
- 3. Agenda Review By consensus of the Executive Board, the agenda was approved as presented.
- 4. Approval of Minutes The minutes of September 11, 2017 were approved by a consensus of the Executive Board.
- 5. Report of COA Chair Sharon McCann announced that the COA is now accepting applications for COA Executive Board members and application forms are available. Nomination forms are also available for the Wayne Templeton Volunteer of the Year Award. Both application and nomination periods close on November 30. She also announced the 2017 Senior Summit. "Seniors in the Digital Age" will take place on Saturday, October 21, at CSU-Channel Islands. Interested seniors can register online to attend the Summit and for free bus transportation from the Senior Center online.

6. Representative Reports

- A. City Council Mayor Pro Tem Mike Judge mentioned the strong winds and asked audience members to call the City's Public Works Department to report downed trees and abandoned shopping carts at (805) 583-6400. He said Chick-fil-A is still planning to build a new restaurant at the Denny's site. The owners of the Town Center have bought the Macy's "box" store location and would like to replace it with a housing element if the area can be successfully rezoned.
- B. Community Services Mara Malch announced that Angel Sierra will be the Senior Services Manager beginning October 30. Community Services Director Sommer Barwick recognized Senior Center staff members for their outstanding performance over the last year while the Center has been without a Senior Services Manager.
- C. Senior Center Robert Martin announced there will be a welcome reception for Angel Sierra following the November 13 COA meeting. He highlighted upcoming Senior Center events. There will be a "Changes to Medicare" presentation on October 17, a "One-Stop Medicare Shop"

workshop on October 24, a free downsizing and organizing presentation on October 26, and a free presentation about in-home caregiving services on October 10. There will also be an Oktoberfest celebration sponsored by the Simi Valley Kiwanis on October 19. Senior Concerns will host a showing of the movie "Gen Silent" about LGBT seniors on October 18 in Camarillo.

D. Ventura County Area Agency on Aging - Toni Olson said that a group in Thousand Oaks has created a dementia-simulation van so that visitors to the van can experience first-hand what it is like to have dementia. She said VCAAA members recently participated in this eye-opening dementia demonstration experience.

7. Presentations

- A. Area Housing Authority of the County of Ventura re: Sycamore Senior Development Royce Patch with USA Properties and Linda Fisher-Helton from the Area Housing Authority presented slides, information, and handouts about "Sycamore Landing" located at 1692 Sycamore. There will be 212 market rate units in phase one. In phase two there will be 98 senior units, all of which will be affordable. At "Vintage at Sycamore," a senior community, the rent charged for all units will be approximately 30% of the tenants' incomes. Ms. Patch described a beautiful environment with Italianate architecture, landscaping, walking trails, and many amenities. For more information, attendees of the meeting were invited to take a card from the Area Housing Authority and sign up for e-mail announcements at http://www.ahacv.org The occupancy date is June 2020.
- 8. Public Statements A senior inquired about the Senior Kit program and it was noted that the Senior Kit Liaison will give a report under Agenda Item 10.B.5.

- 10. Officer, Liaison, Program Manager, and Ad Hoc Committee Reports

A. Officer Reports

- 1. Vice Chair Char Jackowitcz had no report.
- 2. Treasurer Karen Cline explained Contributed Support (\$10,000) on Page 7 of the agenda packet is from a large donation from an organization. She said the COA is in "good shape" and has no debt.
- 3. Corresponding Secretary Kenneth Sinn reported that he sent out two thank you letters last month.

B. Liaison & Program Manager Reports

- 1. Senior Share Liaison Joe Beautz referred to Page 11 of the agenda packet, a memo from Robert Martin to the COA. This memorandum explains why additional financial support is needed from the COA to establish a closed food pantry at the Senior Center to replace the current Senior Share program.
- 2. Lifeline Liaison Don Novell had no report.
- 3. Meals On Wheels Liaison John Williams referred members to Page 9 of the agenda packet. He also said there are seven routes that serve 158 meals a day. To be eligible for the program, individuals must be over the age of 60 and homebound.
- 4. Housing Liaison Sharon McCann reported for Judy Pepiot and referred to the report included in the agenda packet. She said that Mountain View Apartments, a 50-unit senior complex with five affordable units, is nearing completion. To be placed on the interest list, prospective tenants should contact the manager at (805) 416-0019. Occupancy should begin around the first of December.
- 5. Senior Kits Toni Olson reported that last month a total of 120 senior kits were distributed, up from 80 kits the previous month. The goal is to distribute 150 kits per month. Since receiving the grant money for this program is dependent on participation, she encouraged everyone to help spread the word about the program.

C. Ad Hoc Committee Reports

- 1. Dance Committee Stephanie Newbrook reported that the next COA dance will be held this Friday, October 13. She invited audience members to attend, reminding them that the cost is only \$7.00 per ticket and that the evening includes a free ballroom dance lesson, a light meal, and a live band! Stephanie also mentioned that the Committee is still looking for volunteers. New Year's Eve Eve tickets will be available around November 1.
- 2. Senior Support Committee Karen Cline had no report.
- 3. Arts & Crafts Fair Toni Olson talked about the Fair and the Pancake Breakfast and encouraged members to post flyers around the community. Breakfast tickets are \$5.00 each. The COA needs a volunteer to place directional signs to the Senior Center on the day of the events. Volunteers are also needed for the rummage sale and to help with hospitality and vendors. The fifty available vendor booths have sold out.

4. Annual Fund Drive - Sharon McCann stated that the Annual Fund Drive begins in October and runs through December. She said that donation forms are available at the sign-in table.

Council on Aging – Housing Liaison Report

Pepper Tree Court Apartments – 1415 Patricia Avenue

Existing 38 studio, 1 & 2 bedroom units – 22 affordable & 16 market rate is in the process of being sold to the Area Housing Authority of the County of Ventura. The existing Affordable Housing agreement is set to expire in 2020 however the buyer's plan is to execute a new agreement & extend the life of Pepper Tree Court's affordability, as well as do some rehabilitation of the aging complex.

New Proposed Senior Apartments – 1424 Patricia Avenue

A new 28 unit complex for age 62+ has cleared the Planning Commission on Oct. 18th. It is a 3 story building with parking as the first floor, on a 1.17 acre lot that backs the Arroyo.

The plans include (20) 1 bedroom, (8) 2 bedroom, 36 total parking places & lots of amenities including washer/dryer in units. (25) units will rent at market rate - (2) 1 bedroom & (1) 2 bedroom unit will be affordable to lower-income (60% of the Area Median Income). A density bonus will be granted for the 3 affordable units but no financial incentives through the City to fund those units. City Council approval is required before the project goes forward.

Note: This is the 2nd upscale senior project in the workings, with Mountain View Apartments located at 4862 Cochran expecting occupancy by Jan. 2018

<u>Sycamore Landing – Proposed 99 senior affordable apartments</u> – scheduled for Neighborhood Council 2 & 3 in November.

Glass Fusion Kiln

Hi Sharon.

Great event this weekend. So much fun!

Here are the details on the glass kiln we would love to have. There are 2 models that would work. One is larger than the other (and slightly more expensive), the smaller version will work as well, it will just accommodate fewer glass pieces for each firing. The Paragon Fusion 14, is 14 square inches, the cost is \$845.00 including shipping. The Paragon Fusion 16, is 16 square inches at a cost of \$1,036.00 including shipping. I will drop the photos and specifications in your office mailbox.

My lesson plan would be to schedule 2 classes per day - definitely on Tuesdays). Each class will be one 1/2 hours long with 6 students per class. One class will be for beginners, the other would be for continuing students. With 12 students per day and 6 sessions per year that would teach 72 students. Each session would coincide with the ceramics sessions which are 7 weeks long. When I offered the glass fusion class in January (I was firing the pieces at my home studio) the classes had a wait list because of the interest. With a kiln at the Senior Center, I could continue teaching the glass fusion and believe it would be a very popular class.


