Ms. Tignac provided an update on the Interview Skills Workshops dates, class times and open presenter time slots.

Board members reviewed the Interview Skills Workshop follow-up questions, developed by John Baxter, that would be given to students after each workshop.

b. Discussion of YES Job and Career Expo Outreach

Ms. Tignac gave an update of businesses and organizations registered to attend the Job and Career Expo (Expo) and the outreach efforts completed. Due to the interest at the 2017 Job and Career Expo, Board members discussed offering mock interviews for interested Expo attendees.

Board members discussed additional outreach ideas to recruit employers and youth to participate and attend the Job and Career Expo, such as a social media campaign.

Board members volunteered to do follow-up calls to businesses that had participated in past Job and Career Expos. A call script was given out to serve as a guide for the follow-up calls.

Mrs. Bowman reported that she had learned about a filming company that had an interest in filming local community events.

c. Discussion of Internships, Job Shadowing, and Other Ideas for Career Exposure

John Baxter stated that he had attended the City's Youth Service Providers' Meet and Greet on February 13, 2018, and made positive comments on the information and resources shared.

John Baxter gave a brief overview of the Incubator Committee meetings held on the second and fourth Monday of each month beginning at 4:30 p.m., at the Simi Valley Chamber of Commerce office.

Mr. Baxter also discussed Simi Valley High School's website for internships. He stated that the site needed some content updates. He stated that he was working on making it accessible to other schools. Board members discussed ideas on marketing the internship website and how to screen students for internships and job shadowing opportunities.
