2. Agenda Review

By consensus of the Executive Board, the agenda was approved as presented.

3. Approval of Minutes

A motion was made by Dave Mummert and seconded by Megan Story to approve the February 15, 2018 minutes as presented. The motion passed unanimously.

5. Public Statements/Comments

Wanda Moyer, Environmental Compliance Program Coordinator, informed the Executive Board about turf removal and drip irrigation classes in April.

6. Informational Presentations

a. The CERT Program: Community Emergency Response Training

Theresa Ramirez, Emergency Services Coordinator for the Simi Valley Police Department, discussed the CERT (Community Emergency Response Training) Program. Its name is deliberately different from the Federal program, called the Community Emergency Response Team. The Federal program was created in 1993 with the intent of training citizens in disaster response so they could join professional responders in the event of a disaster.

Simi Valley adopted its program in 1994 after the Northridge earthquake. The intent of Simi Valley's program is not to train citizens so they could join professional responders. It is instead to train citizens in basic disaster response skills in order to assist others in their neighborhood or workplace following an event when professional responders are not immediately available. Since the program began, there have been 38 CERT

Academies, with nearly 1,500 citizens completing the program. There are normally three academies per year, with the next one beginning in April.

7. New Business

- a. Nomination of a representative and one alternate to serve on the Community Projects Grant (CPG) Review Committee

By consensus of the Executive Board, Amin Maghsoodi was nominated as the Neighborhood Council #3 representative and Ian Davis as the alternate.

8. Neighborhood Council Coordinator's Report

Emily Habib informed the Executive Board that the recruitment for the July 2018 term opened on March 5 and Neighborhood Council #3 currently had 12 applicants for five openings. She also noted that off-street vehicle parking regulations, including recreational vehicle (RV) parking on residential properties would be discussed at the April 2018 meeting.

9. Executive Board Comments

Dave Mummert discussed his visit to the Free Farmers Market at the Simi Valley Community Garden. He felt that, in spite of rainy weather, the event was very successful. The next date will be March 27, 2018. Ian Davis noted that he and his daughter volunteered at the garden by pulling weeds.

Pepper Aarvold informed the Executive Board that a new exhibit on Genghis Khan was open at the Reagan Library and she encouraged them to attend.

Megan Story announced that she would be moving out of town in the near future and that this was her last meeting.
