d. Discussion of the 2018-19 Youth Council Work Plan

Youth Council members discussed issues and problems that Simi Valley youth are faced with that Youth Council can tackle. Nick Judge led members in a brainstorm activity. Members then completed a dot vote, highlighting the top problems thought most important.

After much discussion, the following seven issues were voted as the most prominent for Youth Council to consider including in their work plan:

1. Overall Health (mental and physical)

- 2. Education (high school and college)
- 3. Employment
- 4. Drug and Alcohol Awareness
- 5. Racism
- 6. Bullying/Cyberbullying

Other issues that did not receive as many votes, but are still notable are as follows; physical violence, lack of Youth Council Advertisement (awareness), natural disaster relief, homelessness, extracurricular activities, crime, litter/trash, graffiti, smoking on school campuses, and fundraisers.
