DRAFT MINUTES

1. Call to Order/Welcome/Pledge of Allegiance

Chair Gloria Bowman called the meeting to order at 7:30 p.m. She also confirmed that a quorum was present.

Mayor Keith Mashburn was in attendance and welcomed the Executive Board members. He emphasized the importance of the Neighborhood Councils, as they provide the City Council with invaluable information in the decision making process. He provided a brief overview of some of the focus areas of the City Council, including economic development, housing, and homelessness. He concluded by thanking the Executive Board members for their service to the City.

2. Agenda Review

By consensus of the Executive Board, the agenda was approved as presented.

3. Approval of Minutes

A motion was made by Sherri Rangel and seconded by Susan Barney to approve the February 19, 2019 minutes as presented. The motion passed by a vote of 6-0-4.

5. Public Statements/Comments

A resident, who is a member of Simi Valley Residents for Responsible Growth, spoke about the dangers of the new 5G telecommunication antennas that will soon be installed around the City. She discussed the group's beliefs that the new technology will increase cancer rates and damage DNA on a cellular level, that it has the capability to collect people's personal information, and will decrease home values. She urged the City to adopt a protective Wireless Telecommunication Facilities ordinance.

6. Informational Presentation

a. City Youth Programs: Youth Council and Youth Employment Service (YES)

YES Advisory Board member Gloria Bowman began the informational presentation. She discussed the Youth Employment Service and its

mission to prepare young people in Simi Valley to enter the workforce. This is done through one-on-one advisement sessions, resume writing and interview skill workshops, and an annual Job and Career Expo.

Community Services Coordinator Kristin Tignac discussed the Youth Council program, which is an advisory board that reports all local matters concerning youth to the City Council. The Youth Council coordinates the Youth Town Hall, the Youth Summit, and awareness campaigns in areas like teen suicide prevention and anti-bullying.

Emily Habib informed the Executive Board that revisions to the City's Wireless Telecommunication Facilities ordinance would be discussed at the March 25, 2019 meeting and suggested that they read the staff report and attend the meeting. She also discussed general meeting protocol and that the Neighborhood Councils would be participating in the Emergency Preparedness Expo again this year on Saturday, May 4.

Each Executive Board member in attendance briefly introduced themselves to the rest of the Board. Gloria Bowman discussed the upcoming Simi Valley Cultural Arts Center Foundation 2019 Spotlight Awards, which will take place on May 11, 2019.
