6. Informational Presentation

Center for Entrepreneurship and HUB101 by Greg Monterrosa, Community Relations Manager

YES Business Incubator Committee Chair Rob West introduced Greg Monterrosa. Mr. Monterrosa gave an overview of the HUB101's purpose, programs and events offered, success stories, and answered board member questions.

Mr. Monterrosa also shared his recommendations for the YES Advisory Board for collaborating with existing organizations in the region that bring value to entrepreneurism. He also stated that rallying the community would be essential, then identifying community leaders that can help with establishing a start-up incubator.
