## 4. Correspondence

Ms. Tignac stated that she had spoken with Royal High School teacher Brian Dennert who stated that they needed to reschedule the date for the Youth Council members from Royal High School to lead one of the school's Brown Bag Lunch Speaker series.

Ms. Tignac reported that she had received a phone call from Alex Walker, member of the Simi Valley Historical Society requesting volunteers for the Dia de los Muertos event on Sunday, October 27, 2019, at Strathearn Historical Park.

#### 5. Public Statements/Comments

Dave DeMaio, Recreation Coordinator with Rancho Simi Recreation and Park District, announced that their annual Simi Valley Snowfest would be held on Sunday, November 3, 2019, from 10:00 a.m. to 3:00 p.m., at Rancho Madera Community Park. He stated that volunteers were needed for this event beginning at 9:00 a.m. for set-up.
