What percentage of the jobs created by the project will be sourced locally?

They plan to hire as many Simi Valley residents as possible, but they will also be bringing in experienced upper and middle management from other nearby locations to get the operation up and functioning smoothly.

Are any retail uses being proposed?

No traditional retail uses are being proposed. However, a component of the facility will be a small area where items can be picked up.

Will drones be employed for deliveries?

There are no plans to use drones at this time.

What will the second floor of the building be used for?

Amazon has no plans to utilize the second floor. However, the entire building is being retrofitted in the event that another user may purchase the building in the future.

Comments: Executive Board members commented that this project would be a welcome addition to the city. One Executive Board member recommended that Amazon contact the City's Office of Emergency Services to discuss the facility being utilized in the event of a disaster.

Upon conclusion of the discussion, the following motion was made by Howard Glober and seconded by CC Bowman:
