  - a. Discussion of Near-Term COVID-19 Action Plan

Board members on both COVID-19 Impact Employer and Job Seeker focused committee reported on the progress of their committees.

Members also reviewed a Strength Weaknesses Opportunity and Threat (SWOT) analysis from the results of COVID-19 Impact survey. Highlights

from the Board's strengths are the Board adaptability on creating workshops on areas of needs and experience and skills on presenting subject matter.

Samantha Shapiro reported that the employer focused committee would be hosting a focus group tentatively on November 30, 2020, with representatives from two primary industries; restaurants and retailers.

Ms. Tignac currently meets with youth that have barriers to employment and works with them via Zoom to provide intensive services to address specific challenges.

The Job Seeker and Employed Youth Focus group would be held at 4:00 p.m. on December 2, 2020, with youth representatives Ashley Kilmnick and Peter Wang as facilitators.

Both COVID-19 committees to meet after the focus groups were held to review and brainstorm training modules needed to address identified areas of need.

Board suggestions to increase awareness and incentivize youth viewing the YES training modules, included: issuing a press release with survey outcomes and training available; and incentives such as a raffle drawing for those that watch the training and then complete a follow-up survey.
