7. New Business

a. Discussion/Action on Municipal Code amendments for establishing standards for bee keeping (Apiculture) activities in single-family zones

Questions/comments from the Executive Board and responses from the applicant:

Will the permit fees cover all additional costs?

Yes, the permit fees will cover all additional costs. The Planning Division will issue permits, which are only anticipated to be 2-4 per year, as part of its regular duties. The fees would cover the \$500 annual cost to join Bee City USA.

Has a study been done on any increases in bee stings in the area of permitted bee hives in other cities?

No, such a study has not been done.

If a neighbor with bee allergies is stung, what are the legal/fiscal consequences, if any, to the City/beekeeper?

The City is currently exploring this.

Why did the City choose to require that the hive opening face the interior of the lot as opposed to merely requiring that it not face a neighbor?

Having the hive opening facing the interior serves to guide the bees away from the edges of the property and any neighboring properties.

Comments:

A number of Executive Board members commented that bees are an important part of the ecosystem.

An Executive Board member commented that the City should apply for the Bee City USA program.

An Executive Board member commented that neighbors on all sides of a property should agree on the issuance of the permit. They also commented that an inspection of the property should be required every year as a condition of renewal of the permit.

Upon conclusion of the discussion, the following motion was made by Howie Glober and seconded by Rick Norris:

Recommend that the Planning Commission approve the Municipal Code amendments for establishing standards for bee keeping (Apiculture) activities in single-family zones with the following recommendation:

Any Municipal Code amendments are budget neutral.

Executive Board vote: 11 Ayes; 0 Noes; 0 Abstentions

The motion passed.

b. Election of Officers

By consensus of the Executive Board, Jan Smith was elected Chair, Gary King was elected Vice Chair, and Sofya Bagdasaryan was elected Secretary.

Emily Habib noted that the Neighborhood Councils would most likely not be meeting in December. She informed Executive Board members that the recruitment for the March 2021 term would begin shortly. She also discussed a press release on an upcoming Metrolink upgrade of approximately two miles of railroad tracks in the city.

Executive Board members introduced themselves. Sofya Bagdasaryan informed members that the Rancho Simi Recreation and Park District would be holding its Junk in the Trunk sale on December 5, 2020.
