6. Informational Presentation

Simi Valley Transit: How does it run?

Ben Gonzales, Deputy Public Works Director (Transit), and Christopher Latham, Transit Operations Manager, made the presentation. They gave an overview of Simi Valley Transit, which has provided fixed-route buses and Americans with Disabilities Act Paratransit/Dial-A-Ride (ADA/DAR) service vans throughout Simi Valley for 40 years. The current bus routes run from the Chatsworth Metrolink Station to Moorpark College. Upcoming service improvements include text messaging software which will call Dial-A-Ride users to inform them when their ride is five minutes away. This will allow them to wait in the comfort of their home until they need to get their ride. Also upcoming is countywide mobile ticketing for all forms of public transportation. Once COVID restrictions are lifted, the very popular quarterly transit travel training for seniors will begin again.

7. New Business

By consensus of the Executive Board, Ken Dickerson was elected Chair, Carol Thomaier was elected Vice Chair, and Bernadine Schache was elected Secretary.

8. Community Services Coordinator's Report

Emily Habib updated the Executive Board members on recruitment for the March 2021 term. She noted that interviews for NCs 1 & 3 would take place on February 10, with both NCs expected have the available seats filled. She also informed the Executive Board that the City's Housing Element was being updated and there were opportunities for citizens to participate in the process.

Executive Board members discussed cars racing loudly in various parts of town late at night, and the disruptions they cause. Emily Habib told them that she would try to obtain information from the Simi Valley Police Department on what efforts they are able to undertake to stop the racing.
