2. Agenda Review

- 6. Continued Business
 - a. Discussion of the Content and Production of the Interview Skills Videos

Content Committee member Gloria Bowman stated that the initial videos had been recorded, but the audio wasn't optimal and would need to be redone. She announced that Ashley Kilmnick and Tim Harrington had already re-filmed their videos and that Ryan Fowler and Gloria Bowman were scheduled to redo their videos on March 18, 2021. The videos were mentioned by Mayor Keith Mashburn during the annual State of the City

address. The videos will be shown during the next YES Advisory Board meeting. Additionally, Ryan Fowler will be recording the Job Expo orientation video.

Gloria Bowman thanked former YES Advisory Board member Gregory Seymour for his work pre- and post-production of the videos.

b. Discussion of a 2021 Job Expo Event

Chair Ryan Fowler stated that the Job and Career Expo Planning Committee was requesting that, as in past years, the entire YES Advisory Board help with making following up contacts to the employers who had yet to respond to staff's initial event invitation. Ms. Tignac stated that she would share the employer call lists with the Board, as well as provide call scripts. Gloria Bowman reported that she had a conflict and will be abstaining from volunteering with the follow up calls. Tim Harrington offered to do more calls if needed.

Rita Longo and Tammy Harter suggested displaying two banners at each of the local high schools to advertise the event, in addition to announcements in the schools' newsletters.

Rocky Rhodes had contacted the Rotary Club of Simi Sunrise and reported that they will pay for an ad in the Simi Valley Acorn.
