6. Informational Presentation

The Free Clinic of Simi Valley: 50 Years of Service

Fred Bauermeister, Executive Director, gave a virtual tour of the facility. The Free Clinic opened on March 1, 1971. They recently relocated to a new 14,000 square foot building. Services offered by volunteers at the Free Clinic include: dental, chiropractic, pharmaceutical, behavioral health, legal, family therapy, and after school programs.

7. New Business

Request to construct six Single Family homes on the east side of Ralston Avenue, between Industrial and Leeds Streets

Questions/comments from the audience and responses from the applicant:

Questions/comments from the Executive Board and responses from the applicant:

Did they consider multi-family housing, especially due to the property's proximity to other multifamily developments?

Yes. However, to build a multi-family development, a larger developer would be necessary. The subject property and adjacent properties would have to be purchased in order to develop a comparable development to those nearby. The property owners cannot afford to do this.

How many of the six dwellings be for sale?

Three of the six will be for sale. The other three are for the property owners.

What type of parking is being provided?

The project will provide the covered parking in the garages. The visitor parking will be provided in driveways and on the street.

How will fire access to the two back houses be provided?

The access driveway and the area in front of these houses will be sized to enable trucks to turn around, per Fire Department standards.

Per the following sentence from the Project Overview: "Staff has advised the applicant that the design of the houses have to be improved in order to meet the City's Architectural Design Guidelines, which include a four-sided architecture, more vertical and horizontal articulation, varied materials, etc."- What specific design improvements have been suggested?

The applicant has not received staff feedback yet.

Comments:

Three Executive Board members stated that they could not support the project because it did not have a multi-family housing component.

Upon conclusion of the discussion, the following motion was made by Alan Barkwill and seconded by Richard Moore:

Recommend that the Planning Commission approve the request to construct six Single Family homes on the east side of Ralston Avenue, between Industrial and Leeds Streets

Executive Board vote: 6 Ayes; 3 Noes; 0 Abstentions Audience vote: 1 Aye; 0 Noes; 1 Abstention

Unincorporated Area vote: None

The motion passed.
