3. Agenda Review

No Revisions were made to the agenda.

4. Approval of Minutes

The minutes of January 21, 2021, January 16, 2020 and October 17, 2019 were approved, as submitted.

5. Report of the ADA Paratransit Advisory Committee Chair (Not appointed)

No report was submitted.

6. Representative Reports

A. Mayor (Keith Mashburn)

No report was submitted, but Mayor Mashburn stated this may be the last zoom meeting for the Committee, as he anticipates that the Senior Center will be re-opened by the July 15, 2021 meeting.

B. Deputy Public Works Director (Transit), Ben Gonzales:

Ben Gonzales reported that the scheduling system, Passenger SMS text messaging software, was implemented to text passengers seven minutes prior to the Dial-A-Ride vehicle arriving for their pick up. He stated this service is available to anyone with a cellular device.

Eric Molina added that individuals were placed in the system and could opt out if they did not want to receive the text. He added that the "seven-minute window" is an approximate time.

Theresa Lewis inquired if information regarding the SMS systems was sent out to passengers or posted somewhere.

Eric Molina responded that the information would be posted on Dial-A-Ride vehicles.

8. Reports:

A. Update on Passenger Statistics

Eric Molina reported low ridership due to Covid-19. There is no passenger statistic report at this time.

B. Travel Training Update

Eric Molina reported that due to Covid-19, travel training has been temporarily suspended.

9. New Business

A. ADA Paratransit Advisory Committee Appointment of Elected Positions.

Theresa Lewis nominated Donna Delaney to Chair the Committee and Rebecca McCann seconded the nomination. No other nominations were presented for the position of Chair, and Donna Delaney was appointed by a unanimous vote by the Committee. Theresa Lewis volunteered to Vice Chair. Steven Dean motioned to approve and Rebecca McCann seconded the motion. Theresa Lewis was appointed as Vice Chair by a unanimous vote. There were no other nominations for Vice Chair.

10. ADA Paratransit Advisory Committee Member Comments

Committee member Steven Dean asked how Transit was being funded with the absence of collecting fares.

Ben Gonzales stated that the Federal Transportation Administration (FTA) provided funding to transit agencies through the Cares Act. This funding assists in helping agencies make up shortfalls in fare collections and ridership due to the Covid-19 pandemic.
