8. Reports:

A. Update on Passenger Statistics

Eric Molina, Transit Supervisor, went over the statistical rider data for the last quarter and reported ridership increasing compared to last quarter.

Committee Member Steven Dean inquired about ridership numbers to compare to the previous year.

Eric Molina provided ridership data information.

B. Travel Training Update

Eric Molina reported that due to Covid-19, travel training continues to be temporarily suspended.

9. New Business

A. ADA Paratransit Advisory Committee Recruitment

Christopher Latham, Transit Operations Manager, reported on recruitment which occurred in mid-June to replace one committee member whose term ended in April, and one vacant alternate spot. Christopher introduced and welcomed Karen Bobango (member) and Rosalie Berger (alternate) to the committee.

B. New Rider's Guide Mailing Update

Eric Molina stated that the Rider's Guide mailing had been completed. Rider's Guides are also available on all Dial-A-Ride vehicles in the event that passengers may want one while on board.

Committee Member Rebecca McCann inquired about Simi Valley Transit (SVT) charging fares.

Eric Molina stated that as of September 1, 2021, SVT will start charging fares.

Christopher Latham added that notices advising riders that fares will be charged will be posted on ADA vehicles prior to that date.

10. ADA Paratransit Advisory Committee Members Comments

Committee member Ruth Lauro inquired about the new dispatcher in the Transit Department.

Eric Molina stated that Alyssa Moody is the newest dispatcher, and advised that Transit is in the process of hiring a new dispatcher, possibly starting on August 2, 2021.

Alternate Committee member Rebecca McCann requested that informational notices posted in the buses be printed in a bigger font.

Eric Molina indicated that staff would look into it.

Ms. McCann inquired about people not being picked up when there is a driver nearby, or at the location where the passenger is waiting for pick up. She inquired as to why a driver can't just pick up passengers and transport them since the drivers are there. She also stated that there are no benches at most locations for passengers to sit while waiting.

Committee member Karen Bobango commented that the seven-minute text pick up notice is a good option to use because people don't have to wait outside in the heat or rain for the van to arrive.

Committee member Steve Dean inquired about creating a scheduling system which included a mileage optimizing function.

Eric Molina will follow up with Rebecca McCann and Steven Dean.
