## **DRAFT MINUTES**

- 1. Call to Order and Pledge of Allegiance Janet Plant called the meeting to order at 1:33 p.m. Janet Plant led the Pledge of Allegiance.
- 2. Roll Call Jeanie Mortensen called Roll Call. Members present were Jean Cecil, Jeanie Mortensen, Bill Oliver, Janet Plant, Suzanne Robertson, Ed Tingstrom. Linda Allen and Pete Stong were absent. Jeanie Mortensen verified there was a quorum present.
- 3. Agenda Review By consensus of the Executive Board, the agenda was approved as presented.
- 4. Approval of Minutes Ed Tingstrom moved to approve the minutes of the meeting on June 14, 2021, and Suzanne Robertson seconded the motion. The motion passed unanimously.
- 5. Report of COA Chair

Janet Plant expressed a tribute to Jerie St. Germain, who recently passed away. She stated he was always volunteering to help the COA and always the first to say "yes". Ed Tingstrom recommended that as a memorial, a plaque be purchased in his memory and if possible, a room at the Senior Center be named for him. A formal presentation of the plaque was also recommended. Angel Sierra clarified that this would need to be added as an agenda item at a future COA meeting and that staff will look into the possibility of naming a room in his honor. Ms. Plant also recognized the Senior Center Staff for their tireless efforts serving meals to seniors during the pandemic over the last 18 months.

## 6. Representative Reports

## a. City Council

Council Member Mike Judge expressed his desire to get back to in-person meetings. He stated that a lot of new construction is going on in the city, including a project on Sycamore and Los Angeles Avenue. The COVID statistics within the city have not been as bad as other parts of the county. Also, the City is doing fine financially and encouraged everyone to support local businesses in Simi Valley.

Council Member Elaine Litster stated the construction on Sycamore Drive and Los Angeles Avenue will have 84 senior units within the five large buildings. The waiting list is currently being prepared. The Cultural Arts Center has received a large grant in the amount of \$232,700 as part of COVID relief. The police department also received a grant to help with DUI checkpoints and other community safety measures.

## b. Community Services

Anna Medina explained that the City is very grateful for the Cultural Arts Center's grant which was significantly more than expected. She welcomed everybody back.

#### c. Senior Center

Angel Sierra stated that the Senior Center opened on September 7, 2021, and that masks were required indoors. Rancho Simi Recreation and Park District classes at the Senior Center will resume in October. Mr. Sierra said a new software system is being rolled out that will track patrons. There were very few seniors who participated in the indoor dining option this past week. However, many of the individuals who were picking up meals have expressed interest in continuing the "Grab and Go" option. Staff will continue to provide the "Grab and Go" service if the need for pickup meals continues. The painting and carpeting projects have been completed and staff is in the process of looking for new furniture. Seniors have expressed their gratitude to be able to return to the Senior Center.

Carol Martin has been appointed to be the COA Liaison to FAST. She was unanimously confirmed by the Board.

1. Treasurer

Bill Oliver reviewed the financials for July and August. Even with the recent expenditures for the Senior Center, the COA is still in a good financial standing. Mr. Sierra clarified that the software expense shown on the report was for the renewal of the QuickBooks license.

## b. Liaison Reports

1. Housing Liaison (see attached)

Bob Cottle reported that there will be Planning Commission meeting, followed by a City Council meeting regarding the City Housing Element. Mr. Cottle asked that the COA recommend that the City prioritize housing for very low income seniors. He also said that there are only about 200 senior-owned for-sale housing units in Simi Valley. There are over 33,000 total homes in the city with few options for seniors who want to sell their current homes and purchase smaller homes in the area. He suggested that the recommendation be prepared by the Ad Hoc Housing Committee for the mid-October meeting. Ms. Plant asked that Mr. Cottle draft a statement that can be approved by the COA. An emergency COA meeting might need to be called in order to approve the recommendation prior the City Council meeting which is scheduled for October 11, 2021. Mr. Sierra

will see what options are available to the COA to ensure a statement can be submitted for the meeting.

## 2. Community Senior Needs Assessment Ad Hoc Committee

Jeanie Mortensen stated that there was nothing new to report but would provide an update on the status of the survey at the next meeting.

## 3. Wellness Expo 2021

SUBJECT: COUNCIL ON AGING RECOMMENDATIONS FOR CITY COUNCIL TO

CONSIDER ON THE PROPOSED HOUSING ELEMENT

On June 14, 2021, the Council on Aging (COA) appointed an ad hoc housing subcommittee to review the draft Housing Element and prepare recommendations for the COA to review and forward to the City Council. On June 18, 2021, the subcommittee held an online meeting to discuss the draft Housing Element, but due to unforeseen circumstances was unable to hold additional meetings. At the September 13, 2021 COA meeting, the Housing Liaison discussed possible recommendations for the COA to consider. However, no action was taken since additional time was needed to review the recommendations.

The City Council is scheduled to hold a public hearing in November 2021 to receive public comments on the draft Housing Element and authorize City staff to forward the document to the California Department of Housing and Community Development for approval. It is recommended that the COA make the following recommendations to the City Council regarding the future development of senior housing projects in the City.

- 1. Senior Apartments: The draft Housing Element provides Quantified Objectives for the development of 50 new extremely low-income units and 50 very low-income units during the next eight years (Housing Element p. 4-106). This means that an average of 12.5 extremely low and low-income apartments would be developed annually, even though the Regional Housing Needs Assessment (RHNA) projections show 750 are needed. Achieving the RHNA projections would result in the addition of approximately 94 new units per year. Since the population of seniors 65 years and above increased by 114.21% in Simi Valley from 2000 to 2008 (Draft Housing Element p. 4-6), the need for extremely low and very low-income apartments is substantial. The COA therefore recommends that the City Council increase the number of extremely low and very low-income units in its Quantified Objectives listed on page 4-106 of the Draft Housing Element to a number that is much closer to the RHNA projections for those two income categories.
- 2. Senior For-Sale Housing: There are only three existing senior housing developments in the City containing 197 units. An additional 138 senior condominiums were approved in the Runkle Canyon Specific Plan but remain unbuilt. The limited number of for-sale senior housing has resulted in few options for seniors seeking to sell their existing home and downsize into a smaller home in the City, which in many cases forces them to move away. The Quantified Objectives listed on page 4-106 of the Draft Housing Element indicates that 2,100 low, moderate, and above-moderate income units will be built during the next eight years. The COA recommends that at least 15% of those 2,100 units, or 315, be designated for occupancy by seniors 55 years and above.
