2. Agenda Review

There being no changes, the agenda was approved as presented.

3. Approval of Minutes from November 2, 2021

Youth Council Chair Rahul Naveen asked members if they had reviewed the minutes from November 2, 2021 and then requested a motion for approval.

ACTION: A motion to approve the November 2, 2021 minutes as written was made by lan Nelson and seconded by Abhishek Jagannathan.

Youth Council Vote: 20 Ayes; 0 Noes; 0 Abstentions

The motion passed.

4. Correspondence

Youth Council Coordinator Kristin Tignac stated that she had received an email from David Rosenberg, Young Adult Librarian with the Simi Valley Public Library thanking the Youth Council for the discussion questions submitted for their Community Reads' Rising Strong book discussions. Ms. Tignac reminded members that they could still add questions for the discussion to the Google share

file. Additionally, Ms. Tignac asked members to save the date on December 11, 2021 for the Community Reads event finale.

Ms. Tignac also stated that she had received correspondence from Simi Valley Public Library Director Kelly Behle inviting members to participate in the Library's Strategic Planning sessions. Since the sessions were during regular school hours, Ms. Behle will attend the December 7, 2021 Youth Council meeting to discuss ideas for future teen programming.

Public Statements/Comments

Youth Council Chair Rahul Naveen reviewed the public statement and comment procedure.

City Council Member Elaine Lister commended the Youth Council on all they have done and thanked the members who volunteered at the Simi Valley Street Fair and City Expo. She also reported that the City Council announced that the interim City Attorney, David Caceres, had been selected as the new City Attorney.

6. Continued Business

a. Discussion of the 2021-22 Youth Council Work Plan

Youth Council Chair Rahul Naveen reviewed the results of the dot vote completed during the November 2 Youth Council Meeting. The top five solutions were as follows:

- To decrease the stigma surrounding mental health issues and allow for selfcare when needed, request that the Simi Valley Unified School District (District) consider allowing three to five excused absences specifically for mental health (26 votes);
- To decrease sexual assaults, request school assemblies at the middle school level to address the issue and to educate students on what constitutes as sexual assault and harassment (17 votes);
- To help upgrade school infrastructure (specifically Wi-Fi/internet access), encourage the District to apply for grant funding or to prioritize infrastructure upgrades when utilizing current funding (15 votes);
- To reduce discrimination and facilitate inclusion, request that the District consider adding or repurposing facilities with more gender inclusive school infrastructure, e.g. gender inclusive bathrooms (10 votes);
- To help those that may have been victims of sexual assault or harassment, request offering support groups on each campus that could lead awareness and prevention activities, such as spirit weeks and social media content. (10 votes).

ACTION: A motion to approve the Youth Council 2021-22 Work Plan as listed above was made by Rikka Tignac and seconded by Jacob Salvanera.

Youth Council Vote: 20 Ayes; 0 Noes; 0 Abstentions

The motion passed.
