- 1. Call to Order and Pledge of Allegiance Janet Plant called the meeting to order at 1:00 p.m. and led the Pledge of Allegiance.
- 2. Roll Call Raquel Wirth called Roll Call. Members present were Jean Cecil, Jeanie Mortensen, Bill Oliver, Janet Plant, Suzanne Robertson, Pete Stong and Ed Tingstrom. Linda Allen and Jeanie Mortensen were excused absences. Raquel Wirth verified there was a quorum present.

The Profit and Loss (P&L) reports (attached) are a summary of the COA's total income and total expenses for the month of December 2021 and Year-to-date (YTD).

The COA received \$3,216.00 in contributions from various private donors and organizations, Senior Center clubs like the Bingo and Duplicate Bridge, as well as sales from the NYEE Dance, all in support of its programs. The COA also incurred expenses in the amount of \$4,437.63, which included the purchase of additional MySeniorCenter key tags, costs associated with the purchase of promotional items for the COA, subsidies to augment the Senior Share bags for the Holidays, and meal site entertainment costs.

SUBJECT: SENIOR NUTRITION PROGRAM REPORT

The Senior Nutrition Program (SNP) at the Simi Valley Senior Center offers a home delivered meal (Meals On Wheels) and congregate meal options. Both of these programs offer a hot, nutritious noontime meal Monday through Friday to seniors 60 years of age and over. All SNP participants are given the opportunity to make a donation, however donations are not required, but are used to offset the cost of the program.

Below is an overview of the number of meals served in these programs for the first two quarters of Fiscal Year 2021-22.

For the period of July 1, 2021 through December 31, 2021, a total of approximately 20,463 home delivered meals were provided to eligible seniors and a total of 24,143 congregate meals were served to eligible seniors. The report includes a breakdown by month.

Staff and the COA Senior Nutrition Program Liaison will be available to answer any questions at the January 10, 2022 meeting.
