2. Agenda Review

3. Approval of Minutes from February 15, 2022

Youth Council Chair Rahul Naveen asked members if they had reviewed the minutes from February 15, 2022 and then requested a motion for approval.

4. Correspondence

Ms. Tignac reported she had received correspondence from Simi Valley Public Library Director Kelly Behle regarding an opportunity for female students in 8th through 12th grades to attend the Soroptimist International of Simi Valley's Dream it, Be it annual girls' conference on Saturday, March 5, 2022.

Ms. Tignac also reported that she had received a phone call from Mary Poitier, Moorpark College's Associated Student Body President, to inquire about the Youth Council's interest in assisting with a mental health forum to be hosted at Moorpark College on Wednesday, March 16, 2022. Ms. Tignac stated that the time of the event, 11:00 a.m., would unfortunately conflict with student school schedules.

5. Public Statements/Comments

Royal High School student Serena Jetely stated that she was in attendance to observe the meeting.

6. Informational Presentation

a. Simi Valley Unified School District's School Social Worker Role by Serena Nguyen, Licensed Clinical Social Worker (LCSW)

Ms. Serena Nguyen, LCSW, gave a brief background on her school and career journey, then presented an overview of her newly created position with the SVUSD as the School Social Worker. She reported that she is meeting with different community organizations to complete a needs assessment. After the needs assessment is completed, she will begin work on connecting resources where gaps may be occurring.

Ms. Nguyen also offered to work with Youth Council members in areas related to mental health.

Ms. Tignac will provide Ms. Nguyen the Zoom link for the upcoming Sexual Assault Awareness and Prevention and the Mental Health committee meetings.

8. New Business

a. Discussion of the Rancho Simi Recreation Park District's Art Festival on Saturday, May 21, 2022

Danielle June, Recreation Coordinator, gave a brief overview of the new Art Festival event the RSRPD plans to hold on Saturday, May 21, 2022. Ms. June discussed the available volunteer opportunities, including coordinating a makerspace booth.

Ashlyn Ro stated that Simi Valley High School's ArtBeat Club would like to run the makerspace booth along with student Serena Jetely.

Matheus Brocchi recommended contacting art teachers to give extra credit for students that submit artwork to be displayed at the event. He also offered to be the liaison to Santa Susana High School's art teachers.

Mrs. June also announced the RSRPD's hopes to build a teen hub area at the Activity Center.

Mrs. June discussed alternate facilities available to host teen events, such as the Youth Council's Escape Room Fundraiser. Ms. Tignac to coordinate a date for the Fundraising Committee to tour the Berylwood Park's former teen gaming building.
