

2. Agenda Review

There being no changes, the agenda was approved as presented.

3. Approval of Minutes from March 1, 2022

Youth Council Chair Rahul Naveen asked members if they had reviewed the minutes from March 1, 2022 and then requested a motion for approval.

ACTION: A motion to approve the March 1, 2022 minutes as written was made by Rikka Tignac and seconded by Isaac Tieu.

The motion passed.

4. Correspondence

Ms. Tignac reported she had received correspondence from Tony Pennay and Tyler McAnany, with the Ronald Reagan Presidential Foundation and Institute, regarding the Youth Symposium then shared their thank you emails.

5. Public Statements/Comments

Students Serena Jetely, Nandhiha Krishnamoorthi, and Maya Maizland complimented the Youth Council on the Youth Symposium event at which all three had attended.

Mayor Keith Mashburn expressed his happiness to be at the meeting.

Mayor Pro Tem Elaine Lister congratulated the Youth Council on their work leading the 2022 Youth Symposium.

Paul, Frank and Christian Castillo, with Boy Scout Troop 698, introduced themselves and stated they were attending the meeting as a requirement for earning a Communication Badge.

6. Continued Business

a. Updates on Youth Council Fundraising Efforts

Fundraising Committee Chair Abhishek Jagannathan updated the Youth Council about ongoing fundraisers. Mr. Jagannathan reminded members to continue selling their initial five Jamba Juice fundraiser cards.

7. New Business

a. Debrief of the Simi Valley Youth Symposium on Thursday, March 10, 2022 in Collaboration with the Ronald Reagan Presidential Foundation and Institute

Youth Summit Committee Chair Ian Nelson led the event debrief. After briefly meeting in small groups, one member from each group presented the action plan their group decided on. Mr. Nelson will present the action plans to the City Council at a May City Council meeting.

Youth Council members discussed their experiences and thoughts on what went well and what could be improved, including allocating more time during the Youth Town Hall to pose audience questions.

Everyone was proud of the event, but agreed that it would be beneficial to have the Youth Summit and Youth Town Hall separate in future years.

- b. Discussion of the Tobacco Use Prevention Education (TUPE) Service Learning Project on Friday, April 8, 2022 at the Simi Valley Public Library
 - Chair and TUPE Committee Member Rahul Naveen gave a brief update on the committee's progress with planning the event. He stated that volunteers would be needed to help at the event and that community service hours would be offered.
- Discussion of the Youth Council's Participation at the Simi Valley Street Fair on Saturday, April 30, 2022

Youth Council Coordinator Kristin Tignac asked members if the Youth Council would be interested in having a booth at the upcoming Simi Valley Street Fair. Members who previously attended the Street Fair said that it was a fun event. Ms. Tignac told members the Youth Council could promote the Talent Show,

provide mental health awareness resources, and promote following all of the Youth Council's social media accounts.

ACTION: A motion to approve the Youth Council attending the Simi Valley Street Fair on April 30, 2022 was made by Joshua Chandran and seconded by Jordan Downey.

The motion passed.

Nandhiha Krishnamoorthi and Maya Maizland stated that they would be available to volunteer to help run the Youth Council booth.

d. Discussion of the Youth Council Talent Show on Friday, May 20, 2022

Talent Show Committee Chair Jacob Salvanera reminded members that applications for the Youth Council Talent Show are open at www.bit.ly/yctalentreg. He also reminded members to pass out all five of their sponsorship letters to businesses.

AJ Jagannathan reported that he had received a three month membership gift certificate from the Simi Valley Family YMCA and that Trader Joe's had agreed to donate a basket for the Talent Show's silent auction and raffle.

Isaac Tieu, member of the School Infrastructure Committee, commented on how the committee met with the Simi Valley Unified School District and that a full report would be given during the April 5th Youth Council meeting.
