6. Informational Presentation

The City's Traffic Engineering Division

Justin Link, Principal Traffic Engineer, gave a presentation. He discussed the primary functions of his division which are: installing, programming and synchronizing traffic signals; installing, maintaining and replacing street signs; maintaining street lights; setting speed limits; and evaluating traffic impacts from new development on the existing system. Additionally, the Traffic Division responds to resident requests including signs; pavement delineations; speed humps; and crosswalks.

7. New Business

a. Consideration of Cannabis Businesses in Simi Valley

Deputy City Manager Samantha Argabrite made a presentation. At their February 28, 2022 meeting, the City Council reviewed the history of cannabis consideration in the City. They directed staff to poll the Neighborhood Councils regarding the sales of cannabis in the City. Questionnaires were distributed prior to the meeting on the following cannabis related topics: retail and medical dispensaries, manufacturing facilities, testing laboratories, cultivation and distribution businesses, lounges/events that allow cannabis consumption on site, and recreational activities. Executive Board members submitted feedback. The feedback from all four Executive Boards will be presented to the City Council in May.

b. Nomination of a Representative to the Program for Public Information (PPI)
Committee

A representative was not nominated because the previously nominated representative was able to resolve a date conflict. However, a second person volunteered to serve on the committee. Therefore, by consensus of the Executive Board, Dalila Minter was nominated as the alternate to the Program for Public Information (PPI) Committee.

8. Community Services Coordinator's Report

Emily Habib announced that a Joint Councils meeting is tentatively planned for the end of June. She also informed the Executive Board that new members would be appointed and retiring members would be recognized at the June 27, 2022, City Council meeting.
