## City Budget Update

Carolyn Johnson, Budget Officer, gave a presentation on the City budget. She reviewed the 2021-22 budget, the year-end forecast and the economic outlook. She discussed what a budget is and various types of budgets. She noted the differences between annual and long term budgets. The 2022-23 budget is currently being developed. A public budget meeting is tentatively scheduled for June 1, 2022, with the City Council scheduled to adopt the budget on June 13, 2022.

#### 7. New Business

Consideration of Cannabis Businesses in Simi Valley

Deputy City Manager Samantha Argabrite made a presentation. At their February 28, 2022 meeting, the City Council reviewed the history of cannabis consideration in the City. They directed staff to poll the Neighborhood Councils regarding the sales of cannabis in the City. Questionnaires were distributed prior to the meeting on the following cannabis related topics: retail and medical dispensaries, manufacturing facilities, testing laboratories, cultivation and distribution businesses, lounges/events that allow cannabis consumption on site, and recreational activities. Executive Board members submitted feedback. The feedback from all four Executive Boards will be presented to the City Council in May.

# 8. Community Services Coordinator's Report

Emily Habib announced that a Joint Councils meeting is tentatively planned for the end of June. She also informed the Executive Board that new members would be appointed and retiring members would be recognized at the June 27, 2022, City Council meeting.

## 9. Executive Board Comments

James Bartholomew expressed concern that the City would have inadequate infrastructure in the future. Tammy Wirtz discussed upcoming Earth Day cleanups at the Samaritan Center on May 16, 2022, and at Hummingbird Ranch on May 23, 2022.
