2. Agenda Review

3. Approval of Minutes

A motion was made by David Mosso and seconded by Debbie Gainey to approve the September 8, 2022 minutes as presented. The motion passed unanimously.

6. Informational Presentation

The National Flood Insurance Program (NFIP) and the Program for Public Information (PPI) Committee

Brent Siemer, Deputy Public Works Director, gave the presentation. The City is part of the National Flood Insurance Program (NFIP), which allows it to receive Federal funds to implement flood control programs. Part of this program are the Flood Insurance Rate Maps, which show the areas that are predicted to flood in a "100 year storm." Anyone who lives in these zones is required to buy flood insurance. However these maps were created in the 1980's and are not entirely accurate. The City Council recently allocated \$700,000 to update them. Once completed, it is expected that a majority of the homes currently in the flood areas will be removed.

The City is part of the Community Rating System. The ratings run from 9 (worst) to 1 (best). By implementing specific improvements, an entity can raise its community rating. The City is at a 5, which puts it in the top 3 percent nationwide. This rating decreases the amount affected residents have to pay the Federal government for flood insurance by 25 percent. There is also the Program for Public Information (PPI) Committee, which includes eight Executive Board members, a

representative and an alternate from each Neighborhood Council. It meets once a year to review and comment on City flood control efforts.

7. New Business

Appointment of a representative to the Special Events Support Review Committee By consensus of the Executive Board, Dalila Minter was appointed as the representative to the Special Events Support Review Committee.

8. Community Services Coordinator's Report

Emily Habib discussed the current Neighborhood Council recruitment. She also noted that no development projects were expected to be reviewed before the end of the year. She informed the Executive Board members that Alberto Vazquez-Dzul had resigned.

9. Executive Board Comments

Elsa Dreckman stated that she had seen a homeless person camping near the intersection of Cochran and Alamo Streets. Dalila Minter informed the Executive Board that Simi High School would be holding its homecoming football game on Friday, October 7, 2022. Theresa Lewis noted that the Simi Valley Senior Center was currently holding its annual Community Games. Executive Board members expressed their frustration with the current water restrictions.
