DRAFT SPECIAL MEETING MINUTES

1. Call To Order/Pledge of Allegiance/Roll Call

Council Member Judge called the meeting to order at 3:33 p.m. Jennifer Del Toro, Management Analyst, noted that a quorum was present. The attendance detail is available on the last page of the minutes.

2. Agenda Review

The agenda was accepted as presented.

3. Approval of Minutes

A motion was made by Council Member Luevanos and seconded by John Tolson to approve the May 12, 2022 minutes. The motion passed unanimously.

- 6. Informational Presentations

a. Ventura County Project Roomkey Transition Plan

Jennifer Harkey, Program Administrator for the County of Ventura's Chief Executive Office and the Ventura County Continuum of Care provided an overview of the Project Roomkey (PRK) Transition Plan. The County has sheltered over 730 homeless individuals in PRK. A total of 320 remain in the program. Case managers have assisted 133 with exits to permanent housing. PRK will end if FEMA terminates funding or if the County exhausts its available funds by early 2023. County supports the expansion of shelters and Permanent Supportive Housing and is working with partner agencies as opportunities arise. Council Member Luevanos shared that she was previously aware of a hotel owner within the City that was interested in participating in Project Roomkey and asked who the best contact is for future interest. Jennifer Harkey expressed to send those interested her way.

b. The Samaritan Center of Simi Valley Update

Annika Sumby, Executive Director for the Samaritan Center of Simi Valley provided an overview of services provided to the community and current needs. Services include meals, pantry items, showers, laundry services, clothing items, case management services, and the Winter Overnight Shelter (PADS) program. Council Member Judge encouraged the Samaritan Center to contact City staff for

funding opportunities through COVID-19 relief funds for some of the expressed needs.

7. Task Force Member Comments

John Tolson, from the Simi Valley Chamber of Commerce, shared the Chamber in collaboration with the City of Simi Valley is hosting a Job Fair on Tuesday, August 30, 2022 with over 100 employers expected to be in attendance.

Council Member Luevanos requested two items for the November Task Force meeting: a discussion to consider the renaming of the Task Force to reflect the unhoused and an overview of the Dignity Moves project in Santa Barbara.

Council Member Luevanos expressed participation barriers with the City's Safe Park program and requested feedback if the City should consider reinstating the program. Jennifer Harkey shared additional information regarding the City of Ventura's Safe Park program with similar participation requirements including all vehicles must have current registration. Mara Malch, Deputy Environmental Services Director, added that the Task Force were previously provided an update on the Safe Park program and received a joint recommendation from City staff and the Samaritan Center of Simi Valley to not reinstate the pilot program.

8. Task Force on Homelessness Coordinator's Report

Jennifer Del Toro, Management Analyst, announced that the Annual Snapshot for Fiscal Year 2020-21 focused on housing and various programs for vulnerable populations has been updated on the City's Task Force on Homelessness webpage.
