6. Informational Presentation

Karen Fraser, Executive Director, gave the presentation. Housing Opportunities Made Easier (HOME) was formed in 2001 as a housing committee of the Ventura County Economic Development Association (VCEDA) to promote a diversity of housing opportunities, essential for a healthy and sustainable quality of life in Ventura County. Each year HOME organizes the Ventura County Housing Conference, which addresses key housing-related focus areas such as availability, affordability, policies, economics, challenges, opportunities, etc. HOME also presents quarterly educational Housing Issues Forums, with guest speakers, presentations, and discussions surrounding pertinent housing issues and trends in Ventura County.

7. New Business

a. Amendment to the Simi Valley Municipal Code to allow cargo containers as residential storage structures

Questions and comments from the audience and responses from City staff:

Questions and comments from the Executive Board and responses from City staff:

How can people living in a container be prevented?

There is no way to prevent this. Residents should report any concerns to the City's Code Compliance Division, which will investigate the complaint.

Is there a requirement for some kind of foundation under the cargo container?

No. there is not.

If someone wanted to add a pitched roof to the container, that could make it taller than 10 feet. Would that be allowed?

Not under the proposed ordinance amendments. At that point, a building permit for a structure would become necessary, which Building and Safety would have to issue.

Will the bottoms of the containers be removed and replaced in case there are any toxins still present from previous uses?

There is nothing in the proposed ordinance that requires that, however, a recommendation could be made.

If someone moves, will they be required to remove the container?

No, the container would be a matter discussed between the buyer and the seller.

Can the entire height of the container be screened?

The City only allows for six-foot (6') high walls, which would not screen the entire container. This is why a five-foot (5') setback is being proposed.

Is the City pushing for adoption of the ordinance amendments?

No, requests were made by residents to City Council members and they asked that staff look further into the issue.

Is the City's intention for these amendments to be the first steps to allowing people to live in them?

No, they are not. The amendments specifically say that these containers are not habitable structures.

Comments:

- A number of Executive Board members expressed concern that the City does not proactively enforce City codes. They felt that containers could be dangerous, become eyesores or people could live in them, and the City would be able to do very little about it.
- An Executive Board member felt that 10,000 square feet was too small a lot size.

Upon conclusion of the discussion, the following motion was made by Jeremy Yablan and seconded by Andy Hanna:

MOTION: Recommend that the Planning Commission deny the Amendment to the Simi Valley Municipal Code to allow cargo containers as residential storage structures.

Executive Board vote: 9 Ayes; 0 Noes; 0 Abstentions Audience vote: 0 Ayes; 0 Noes; 0 Abstentions Unincorporated Area vote: 0 Ayes; 0 Noes; 0 Abstentions

The motion passed.
