5. Public Statements/Comments

A resident of the 2200 block of Stow Street wanted to address a grievance his neighborhood of about 17 homes has with Simi Valley High School. The high school is renting out rooms to groups from Simi Valley to as far away as the San Fernando Valley on afternoons, evenings, and weekends. During many of these events, residents cannot park in the street because parking is taken by visitors. These people leave trash, block driveways, and are sometimes rude. They also move bins from in front of homes, so residents sometimes don't get their trash picked up.

He said he's spoken with the Simi High administration and the Simi Valley Unified School District, but they are indifferent to his grievance. It was suggested that the group of residents attend School District meetings, contact the police on parking enforcement, and/or speak with the City Manager's office.

6. Informational Presentation

The City's Traffic Engineering Division/"Safe Streets and Roads for All Project"

Justin Link, Principal Traffic Engineer, gave the presentation. He discussed the primary functions of his division which are: installing, programming and synchronizing traffic signals; installing, maintaining, and replacing street signs; maintaining street lights; setting speed limits; and evaluating traffic impacts of

proposed developments on the existing system. Additionally, the Traffic Division responds to resident requests on matters that included signs, pavement delineations, speed humps, and crosswalks.

The Safe Streets and Roads for All Project, which is part of the federal Bipartisan Infrastructure Law, provides funding for local agency initiatives to reduce or eliminate roadway deaths and serious injuries. The City has applied for over \$7,000,000 to install new traffic signal controllers with video detection systems, and new reflective back plates on signals.
