6. Informational Presentation

Rancho Simi Recreation and Park District

Richard Lemmo of the Rancho Simi Recreation and Park District gave an oral presentation and shared a PowerPoint slideshow. He talked about the agency's history, staffing, annual budget, services/amenities, and future proposed capital projects. He shared brochures and his business card with all in attendance.

The City's Traffic Engineering Division/"Safe Street and Roads for All Project"

Justin Link, Principal Traffic Engineer, gave the presentation. He discussed the primary functions of his division which are installing, programming, and synchronizing traffic signals; installing, maintaining, and replacing street signs; maintaining street lights; setting speed limits; and evaluating traffic impacts of proposed developments on the existing system. Additionally, the Traffic Division responds to resident requests on matters that included signs, pavement delineations, speed humps, and crosswalks.

The Safe Streets and Roads for All Project, which is part of the federal Bipartisan Infrastructure Law, provides funding for local agency initiatives to reduce or eliminate roadway deaths and serious injuries. The City has applied for over \$7,000,000 to install new traffic signal controllers with video detection systems and new reflective back plates on signals.
