3. Approval of Minutes

A motion was made by Pete Stong and seconded by Theresa Ramirez to approve the February 13, 2024 minutes as presented. The motion passed unanimously.

 - Road Harmony Safeguarding Streets and Curbing Micro-Mobility and Car Collisions

Sergeant Josh McAlister with the Police Department Traffic Bureau outlined various initiatives and programs aimed at enhancing public safety. These include educational efforts such as the Every 15 Minutes Program, Adult Driver Education, and bicycle safety presentations. Enforcement programs targeting distracted driving, DUIs, and compliance with traffic laws were also highlighted. He informed the Executive Board of relevant bicycle laws, emphasizing that 18 of 21 bicycle collisions found bicyclists at fault and detailing regulations regarding lights, reflectors, and riding behavior. Additionally, he explained electric bicycle classifications and regulations, as well as laws about motorized scooters, including age requirements, helmet mandates, and usage restrictions. The Police Department's overall goal is to reduce traffic fatalities, with the city reporting 10 fatalities in 2023.

b. State of the Region

Samantha Argabrite, Assistant City Manager, delivered the State of the Region Report, distributing State of the Region books to attendees. In 2021,

the county's population was 845,225 with a median age of 38.7. Birth rates are decreasing in Ventura County with 8,785 babies born in 2021. Public school and community college enrollments are declining. Income disparities persist, with men earning more than women across all education levels. In 2021, the per capita income was \$41,863, and the median household income was \$94,150. Political affiliation leans towards Democrats, except in Simi Valley, where Republican hold the majority. Ventura County's gross product was \$58.3 billion in 2021, yet the high cost of living persists, with soaring home prices exceeding \$1 million in some areas of the county. Rental rates remain steep and remote work is on the rise. Agriculture remains a significant sector, with strawberries generating \$662.7 million in revenue in 2022. Employment trends show a strong recovery from pandemic losses. After a 7% decline in jobs from 2019 to 2020, the county saw two years of solid job growth, capped by 4% growth in 2022; the best single year of the 21st century. Despite job growth post-pandemic, industries with higher compensations are shrinking. The county's nonprofit sector employs over 10,000 individuals but offers below-average wages. The county faces challenges, including high rates of opioid deaths, COVID-19 fatalities, and a growing population experiencing housing insecurity or homelessness. Despite these challenges, Ventura County maintains a low crime rate, making it one of the safest large counties in California.
