The motion failed with one vote in favor and six opposed.

The Review Committee will review all funding requests thoroughly prior to the meeting on May 8, 2024. Each member will complete preliminary point rankings of the requests based on his/her perspective and come with an open mind to hear the benefits and needs for each program or project from the applying agencies. Members of the public will be able to speak during the Public Statements/Comments period. The time allotted to each speaker will be limited to one minute. Each applicant will be allotted three minutes to present under the New Business section of the meeting.

Upon further discussion, Sam Cohen moved with a second from Spencer Ross to use a ranking of one through five for a total max score of 20 for each organization, using the following four categories: community need (e.g., overall impact and urgency to the community); new or previous recipient (e.g., number of years and most recent year of funding); number of people served (e.g., explicit number of members in the community being served); community investment type (e.g., infrastructure consistent of clinics or events, direct services, or capital project), and to use these initial rankings to inform the discussion after applicant presentations to develop the funding recommendation.

The motion passed with six votes in favor and one opposed.

**SUBJECT: DISCUSSION AND RECOMMENDATION OF FY 2024-25 COMMUNITY PROJECTS GRANT FUNDING REQUESTS**

At its April 24, 2024 meeting, the Review Committee established a process to guide them in formulating a funding recommendation. The Review Committee will review all funding requests thoroughly and complete preliminary rankings prior to the May 8, 2024 meeting. The Review Committee will focus on the following four factors to guide them in ranking the applications:

1. Community Need (e.g., Overall impact and urgency to the community)
2. New or Previous Recipient (e.g., Number of years and most recent year of funding)
3. Number of people served (e.g., Explicit number of members in the community being served)
4. Community Investment Type (e.g., Infrastructure consistent of clinics or events, direct services, or capital project)

Each applicant will be allotted three minutes to present during the May 8, 2024 meeting. Presentations will be heard under the New Business section of the meeting. The Review Committee has asked that the applicants incorporate the factors as referenced above into their presentations.

Upon conclusion of the presentations, the Review Committee members will be able to ask follow-up questions and then discuss the merits of the applications. The Review Committee members will then identify the common rankings and use the discussion to narrow down to a final list recommended for funding.

The Review Committee's recommendations will be presented to the City Council at one of its June 2024 meetings.

### **Scope of Work**

After former First Lady Nancy Reagan won her battle against breast cancer, she gave her name to Adventist Health Simi Valley's breast center. That was nearly 30 years ago. Since then, thousands of women have sought treatment at the center, and the need for mammograms continues to rise. In 2021, the center performed nearly 9,500 mammograms. The following year, more than 10,200 women had mammograms at the center, an increase of 700! Breast mammography and screenings are proven to reduce breast cancer mortality. Routine 3-D mammography is the number one way to find cancer early and initiate appropriate treatment.

To continue Nancy Reagan's mission to ensure women across Ventura County receive expert breast care, the Adventist Health Simi Valley Foundation is raising \$2 million for a beautiful renovation and expansion of the Nancy Reagan Breast Center.

The expansion will allow us to:

- Create a welcoming space designed with comfort and elegance in mind
- Accommodate advanced technology, including an additional 3D mammography unit and ultrasound machine

## Simi Valley Community Project Grant Proposal 2024 SCOPE OF WORK

Big Brothers Big Sisters of Ventura County (BBSVC) is respectfully requesting a Community Project Grant in the amount of \$30,000 for its *High School Mentor Program (Simi Valley)* project proposal.

### Helpful BBSVC definitions for this project

- **High School Mentors** – a youth mentoring program where high school students (and some middle school students) work one-to-one with elementary school students.
- **Facilitated** – indicating a program that is fully supervised by a professional case manager.
- **Site-Based** - Describes a supervised program that is a group of Bigs and Littles who meet as a group at a common location (a “site”), during a common time, but still engage in activities in a one-to-one mentoring approach within that dynamic.
- **Big** - a high-school or middle-school student who is a peer mentor to an elementary-school student.
- **Little** – an elementary-school student who is a mentee to a high-school Big.
- **Match** - a one-to-one mentoring partnership between a Big and Little.
- **Mentor Academy** – a optional program available for Bigs (high school students and some middle school students) participating in the High School Mentor Program, where students may access speakers, resources, educational stipends, and internship opportunities

### Project Proposal Summary

Big Brothers Big Sisters of Ventura County (BBSVC) is seeking funding of \$30,000 for the launch of a *High School Mentor Program* at its Simi Valley Youth Room. This project will introduce a successful youth mentoring model into the community that has demonstrated positive impact in other regions that BBSVC already serves, where high school and middle school youth take the position of role model for younger children.

While this initial funding request would cover a single-year period, it would be integrated into ongoing, sustainable programming efforts as awareness of the project grows among area partners and supporters. The *High School Mentor Program (Simi Valley)* delivers three primary



goals that contribute to introducing positive cycles of mentoring, community-building, social-emotional intelligence, and early skill development:

1. Identifying elementary-age youth who face an increased prevalence for ACES or increased need for literacy/social-emotional development, and matching them in pro-social, 1-to-1, long-term mentorships with carefully assessed, professionally-supported high school or middle school volunteers;
2. Encouraging High School and Middle School Bigs to participate in BBSVC's Mentor Academy, exposing students to age-appropriate enrichment that better prepares them for life after high school, and better illuminates their personal goal pathway;
3. Providing ongoing, professional case management for all participants – Bigs and Littles – that supports:
  - on-site program involvement;
  - youth safety on-site, at home, at school, online, and in other environments;
  - identification of external resources (food security, housing, medical, educational, etc) needed for participants, and warm referrals provided to close these gaps;
  - demonstrable social-emotional growth and youth-led goal-setting, as tracked through BBSVC surveys conducted at enrollment, quarterly, and annually

Positive mentoring experiences demonstrate healthy behaviors and reduce youth involvement with gangs, drugs or alcohol, or resorting to violent behaviors on campus, in their neighborhood, or at home – experiencing social disconnect and isolation during COVID shutdowns, a gap in social-emotional development emerged that caused youth to have difficulty building healthy social connections and skills. This has placed youth at a higher risk of engaging in unhealthy, negative behaviors. Mentoring programs are proven to help youth build coping skills, emotional regulation strategies, and other positive behaviors that build resilience, avoid risk, and create environments where youth can develop a better sense of future focus.

High School and Middle School Bigs participating in the program would be given access to BBSVC's Mentor Academy (<https://www.bbsvc.org/academy>): this program is a combination of (1) a guaranteed spot in the agency's social services internship, completed for campus credit, service hours, or a letter of recommendation from the agency's CEO, (2) the opportunity to be matched with a career mentor in an industry of the youth's choice, and (3) hands-on trade development experience. To make this option for student participants best accessible (and not overwhelming), Mentor Academy tracks in a timeframe that aligns with each student's existing schedules, and campus or coursework requirements. Whether exploring a future in the nonprofit sector, corporate industries, or learning a union trade, every student who participates in Mentor Academy earns improved professional skills that carry them along their pathway after graduation.

*All High School Mentor Program (Simi Valley)* participants would be supervised and moderated by professional case management staff, but would support the youth-led development of

communication and social skills, and would solicit suggestions of STEAM-based enrichment activities that youth are actively interested in or would like to explore. BBSVC would work in a high degree through existing partnerships such as SVUSD counselors and educators, Vista Real Charter School, Ventura County Probation, Many Mansions and other fellow nonprofits to receive referrals of local youth who are seeking positive opportunities of leadership, talent-sharing, and role-modeling. Recruitment of student Bigs will be conducted by a commitment to participate – not grade levels or financial ability – helping to break down inequities in community leadership and decision-making and will encourage youth to become active changemakers. In doing so, BBSVC's *High School Mentor Program (Simi Valley)* encourages healthy investment into one's own community at a young age that will persevere and continue to grow through adulthood.

### **Participant Demographics**

If funded, 100% of the youth and families served through this project proposal will reside and attend school within the city of Simi Valley.

The identification of stable, safe, positive role models in a young person's life is critical to healthy youth development. BBSVC specializes in matching youth with carefully assessed, trained volunteers, where each mentoring match is supported by ongoing, professional case management and connectivity to wraparound services. While access to BBSVC's programs is not contingent upon financial or socioeconomic status, the agency intentionally outreaches to marginalized populations that face a higher prevalence of ACEs (Adverse Childhood Experiences) and risk behaviors. These are populations where youth could likely benefit from the introduction of mentorship, primarily: households living under the poverty line, single-parent households, monolingual non-English-speaking households, the LGBTQ+ community, foster youth, et cetera. Any labeling of youth experiencing adversity perpetuates trauma that contributes to cycles of negative behavior and the school-to-prison pipeline. BBSVC guides youth to see themselves in a different light by empowering them to achieve success and be "heard," not only in their own peer groups but by an ecosystem of support that can help dismantle barriers that young people experience today.

Prior to acceptance into the program, all student applicants will be assessed by professional case management staff for commitment, readiness, and program safety. If BBSVC staff feels that the *High School Mentor Program (Simi Valley)* is not the right fit for a student at this time, they will be offered alternative program options within BBSVC or referred to a partner program. BBSVC best practices is to ensure that youth are never "rejected" from agency services, but may be redirected to other opportunities that better fit their own needs or goals.

**Services to be Delivered / Numbers Served / Cost per Number**

The average cost of professionally-supporting a mentoring match (including within facilitated site programs) is \$1,500 per year. We anticipate identifying and serving within the city of Simi Valley at least 15 new 1-to-1 High School Mentoring matches during the grant funding period.

In addition to estimates of matches served, BBSVC anticipates that other youth in households served will benefit from the increased awareness of – and accessibility to – the BBSVC Youth Room in Simi Valley; those figures are not reflected here nor included in the request for funding, but BBSVC looks forward to the opportunity to serve these youth as well.

*Staff Coverage Costs: case management and program facilitation are directly attributable – and critical – to the implementation of BBSVC’s professionally-supported mentoring programs. No grant funds are attributable to administrative/executive salaries or overhead costs in this proposal. These considerations are aligned with HUD definitions of direct and indirect costs.*

**BBSVC’S MEASURABLE IMPACT ON SIMI VALLEY**

In the spring of 2023, BBSVC staff met Alexis\* when she was referred to the BBSVC Youth Room in Simi Valley by Ventura County Probation Agency’s Juvenile Field Supervision officers. Alexis had been arrested for a first-time, non-safety-related, low-level offense. After her assessment by their offices, it was determined that she realized her mistake and was being accountable for her actions. As such, Alexis was given the opportunity to engage at BBSVC’s

Youth Room for facilitated, pro-social activities on informal probation. She was asked to use her required time at the site to set and achieve a goal for herself – Alexis decided to set the goal of organizing and running an enrichment activity with her peer group, and she successfully oversaw a day of arts and crafts that benefitted the other youth in the room with a creative experience.

Following the completion of her required hours with BBSVC, Alexis had the opportunity to “graduate” from the Youth Room or continue attending. Sharing with BBSVC program managers that she felt safe and welcome, Alexis chose to continue attending the Youth Room on a regular basis. As she emotionally settled from her court experiences, BBSVC staff introduced the idea of Mentor Academy to Alexis. At first only jumping in on occasion, Alexis soon became a regular attendee on the Mentor Academy weekly zooms. She learned about how to build a resume, interview etiquette, what it takes to establish (and be accountable for) one’s “personal brand,” and more. In December 2023, Alexis attended BBSVC’s Holiday Party where she met her career mentor in person for the first time...and was pleasantly surprised when their mentor gifted her a book they had talked about in their zoom rooms. She finished the book before their next Mentor Academy meetup!

In January 2024 - as BBSVC staff began discussing the launch of a High School Mentor Program at the Simi Valley Youth Room to include elementary school Littles - Alexis overheard and chimed in to say, “And don’t forget that I can do painting with them too!”

### **Partnerships Critical to the Success of the Project**

BBSVC partners with **VC STEM, Ventura County Behavioral Health, Ventura County Human Services Agency, Ventura County Probation Agency**, and **numerous other non-profits** that also serve Simi Valley. Through these partnerships we are able to leverage services that families need to help them overcome whatever obstacles they encounter.

BBSVC will also be working with counselors and educators at **Vista Real Charter School** and **Simi Valley Unified** for referrals of children in need of BBSVC services. The site will be in the Simi Valley Multi-Services Center, overseen by the Free Clinic of Simi Valley, where additional tenants also regularly offer their support with referral needs, enrichment, and networking opportunities for program youth.

Ongoing resource and wraparound referrals come from a wide network of nonprofit and service partnerships across the region, based on individual needs of youth and families.

### **Previous Years’ Impact**

- BBSVC has not only demonstrated the ability to exceed grant expectations (services provided, reporting completed, funds expended on schedule, etc.) with all previous Simi Valley CPG awards, it has retained and progressed youth to become community leaders and participants.
- With support from this grant in previous years, BBSVC has been able to create two new permanent job opportunities for Simi residents, with a pathway for professional development and career growth. Two former Simi Youth Room Program Coordinators have each been promoted through BBSVC to management positions.
- Utilizing CPG funding (2017) for the foundations of BBSVC’s presence and site here in the city, BBSVC solicited an additional annual grant of now \$199,000 that is invested through Simi-local enrichment activities, businesses, and salaries. This grant is ongoing and also in great standing, continuing to meet expectations year over year.

## Community Grant Request Scope Of Work

### Body Brain Train

There are approximately 19 thousand senior citizens currently residing in Simi Valley, and the numbers continue to increase with 50+ senior living facilities located in our city. Getting these seniors moving with proper fitness and wellness routines has been crucial, especially in the past few years post-pandemic.

**Body Brain Train** is a 501c3 non-profit dedicated to bringing fitness and wellness to the Simi Valley Senior Community. The organization does not only address the physical and Neuro-fitness of their clients, they address the social aspect of the health triangle as well. Seniors sometimes have a hard time socializing and tend to isolate themselves. BBT is dedicated to helping change that so seniors can live their best quality of life.

Nikki Lian and Gabby Sifuentes are the co-owners and creators of Body Brain Train and have worked with seniors for several years, as well as seniors with special needs such as Parkinson's Disease, Dementia, Multiple Sclerosis and other neurological disorders. Body Brain Train is a member of the Simi Valley Chamber of Commerce and it's Senior Service Alliance Group. Nikki sits on the Board of Directors for the Chamber of Commerce, and Gabby is the committee chair for the Simi Valley Chamber Hispanic Business Alliance. She also teaches Fit Boxing in Spanish to people living with Parkinson's Disease two times per week in over 15 different countries.

Over 70 percent of their seniors that currently take classes at the BBT facility are living with Parkinson's Disease. So they also started programs such as a Parkinson's support group, which is currently the only support group active in Simi Valley and is open to all.

Body Brain Train has already helped so many seniors and will continue the mission until every senior in Simi Valley knows they can benefit from the program. They believe that movement makes miracles and see it in their members and out in the community every day. Their program includes classes such as Box and Balance, Jungshin Fitness (Sword Fitness), Tai Chi, Weight Training and Fit Drumming, as well as other activities to improve their brain and fine motor skills.

Last year with grant funding they were able to add an extra class at the gym with two trainers per class, which helped to focus more on serving the needs of each member according to their ability level. They also added free events throughout the year such as Drumming in the Park, Jungshin Fitness at the Park, and two free classes per month at the senior center. They also have had the privilege of working with the Parkinson's Foundation and doing exercise demonstrations at their local events.

This year BBT is focusing on continuing to maintain 4 classes per week at their gym and run 5 free events per month in the Simi Valley Community. For example, free classes in the park, at the Senior Center, at a church, etc. They are aiming to use a variety of locations to reach more people.

### Scope of Work

Standard pay to continue to run in-house classes is \$60 per class (two trainers):

*\$60 x 4 times per week is \$240. \$240 x 52 weeks is **\$12,480.***

Standard cost to run an outdoor/free event is \$100 per event (two trainers):

*\$100 x 5 times per month is **\$6000***

We are asking for a total of **\$18,480** to fund our classes.

All classes are taking place in Simi Valley, so BBT is serving the Simi Valley Community 100% with this funding. Gabby and Nikki believe they will reach at least 200-300 more seniors and people living with Parkinson's Disease this year.

## Scope of Work

This funding request of \$10,000 will ensure that the Simi Valley community impacted by cancer are empowered by knowledge, strengthened by action, and sustained by community. Cancer Support Community Valley/Ventura/Santa Barbara's (CSCVVS) programs and services are free of charge to the participants and, of those that have indicated their income class, about 60% are moderate-to-low-income. The proposed funding will directly support CSCVVS's delivery of programs and ensure that no one faces cancer alone.

### **Overview and History of Cancer Support Community Valley/Ventura/Santa Barbara**

In 2007, the Institute of Medicine released its "Cancer Care for the Whole Patient: Meeting Psychosocial Health Needs," a groundbreaking report on the importance of addressing the social and emotional needs of individuals facing cancer, rather than just the physical needs. This idea had been implemented for years at The Wellness Community, now Cancer Support Community.

The services we provide AT NO COST to participants include professionally-lead support groups by a licensed mental health professional, individual counseling, educational workshops, wellness classes and social events. Some participants come to one support group and most participate in a variety of groups, classes and workshops. These groups and classes are delivered to the community both in-person and online via Zoom. Post-pandemic, the majority of our participants prefer the online model of service, so we've maintained both formats to meet the needs of our community.

Through our healthcare partners, other community non-profit groups, outreach events, marketing efforts and word-of-mouth, people learn about Cancer Support Community and the services we provide.

CSCVVS, a 501(c)(3) non-profit organization located in Westlake Village, California, has been independently operated and funded since 1991. CSCVVS is the local affiliate of the nation's leading provider of social and emotional support for those dealing with cancer. While following a common mission, each affiliate is independently operated and funded. Recognizing that a cancer diagnosis is very stressful for individuals and families, it is a core principle of CSC that all programs are offered at no cost to the participants. CSCVVS's work is funded through the generosity of individual, corporate, foundations and fundraising events.

CSCVVS's goal is to help all people impacted by cancer strengthen their physical, emotional, and social health through participation in professionally facilitated programs offering emotional support, education, and hope. During its 33 years of service, CSCVVS has helped more than 30,000 members of the community face and cope with this often-devastating diagnosis. In 2023, CSCVVS served the community with 124 health and wellness classes, 37 educational workshops; over 600 support group

sessions; and 943 individual and family counseling sessions. In all, we provided over 9,000 service hours to patients and their families. CSCVVSBS's programs serve the residents of Ventura County, Santa Barbara County, and West San Fernando Valley ages five and up. Our programs have built strong partnerships with outstanding facilities such as Dignity Health St. John's Hospital in Oxnard, and Dignity Health Camarillo Hospital.

### **Purpose of Request and Anticipated Results**

Stress and anxiety created by a cancer diagnosis may cause or increase family and personal problems and interfere with well-being during treatment and recovery. Those with the diagnosis often experience feelings of isolation, depression, helplessness, confusion, and inability to cope. Cancer can impact the quality of life of family caregivers in many ways, but particularly in the psychological domain (e.g., anxiety, depression, feelings of helplessness and loss of control, and difficulty coping with caregiver roles), which can impact the quality of caregiving, the caregiver's health, and the patient's anxiety level.

Primary objectives for proposed request: 1) Provide reliable and objective information about specific cancers, treatment and side effects, nutrition, exercise, and community resources by engaging top oncology professionals within the community who donate their time and partner with us to educate our members. 2) Empower cancer patients to participate in their fight for recovery by increasing patient and caregiver knowledge through cancer education. 3) Teach cancer patients and their caregivers coping, decision-making and communication skills, stress reduction and emotional self-regulation techniques, cost of care and insurance issues, and maintaining physical and emotional wellness during and post-cancer treatment. 4) Provide therapist-led support groups focused on the psycho-social health of cancer patients and their families. 5) Increase awareness about CSCVVSBS programs and services available to cancer patients and their families within the Simi Valley community.

### **Target Population and How They Will Benefit from the Proposed Program**

CSCVVSBS serves anyone impacted by cancer. In our experience, people are more willing to attend an in-person support group or class, if it is near and convenient to their home. Through this grant, Cancer Support Community will be able to offer in-person support groups and classes in the Simi Valley community. The funds requested will help people like Jessica:

***"Thank goodness for CSCVVSBS's online support groups, which I was able to attend from my hospital bed. I connected with others who were going through similar experiences. It was so incredibly validating to hear the stories of others my age and to be able to laugh together in a safe space. No matter how terrible I was feeling, I always made it a point to attend because it made me feel hopeful and less isolated."***

CSCVVSBS expects to positively impact the Simi Valley community by offering a select menu of programs within minimal driving distance to their home or work. Surveyed participants in our programs and services experienced overwhelmingly positive outcomes, per our 2023 survey:

- **76% gained useful treatment information**
- **90 % felt more connected**
- **74% felt empowered to manage their illness**
- **88% experienced better quality of life**
- **81 % felt better able to cope with distress**
- **96% would recommend CSCVVSBS to others impacted by cancer**

In 2023, CSCVVSBS provided at least one support group and/or support service to 47 Simi Valley residents, approximately 7% of our total participants. Through this grant, our goal will be to have significant impact on those results for the period of July, 2024 – June, 2025.

### **Simi Valley Action Plans for July 2024 – June 2025**

CSCVVSBS will provide a specific support group facilitated by a licensed mental health professional who is extensively trained to serve this unique population. The small group setting provides an atmosphere of safety and comfort where cancer participants and family members can express their fears, exchange information, and share concerns with others who are undergoing many of the same experiences. Support groups we currently offer include:

- 1) Patient and survivor support groups, primarily for emotional support, are available for those dealing with mutual (common) concerns such as side-effect management, how to cope with a “new normal,” and fear of recurrence. Some groups are cancer specific (e.g., gynecological, breast, prostate), while others are for participants with uniting common life experiences (e.g., kids & teens, young adults with cancer, Spanish speakers with cancer).
- 2) For family members and friends, CSCVVSBS offers caregiver groups (including parents of children with cancer) and bereavement groups.
- 3) Networking groups are primarily informational for specific cancer types (e.g., prostate cancer, blood cancers, brain cancer, etc.) that cancer survivors and families/friends attend together.

#### ***Healthy Lifestyle Classes:***

Exercise, relaxation techniques, and creative outlets help calm the mind and may help reduce symptoms and side effects (e.g., pain, fatigue, sleep issues, and depression) associated with cancer treatment. With the goal of supporting all aspects of cancer treatment, CSCVVSBS provides a range of mind/body classes including:

- 1) Yoga, and Reiki
- 2) Watercolor, knitting, and journaling
- 3) Stress management, visualization, and guided imagery

***Cancer Education Workshops:*** CSCVVSBS conducts health and wellness monthly educational workshops to provide the latest educational opportunities for CSCVVSBS participants. Workshop topics include:

- 1) Cancer-specific topics led by healthcare professionals (e.g., oncologists, psychologists, surgeons, radiologists) covering issues such as cancer treatment side effects, new treatment options, and new studies and research.



- 2) Psycho-oncology professionals address a wide array of topics relevant to cancer patients and their loved ones, including death and dying, sexuality and intimacy after cancer, metastatic, and chronic cancer.
- 3) Health and wellness topics such as nutrition, physical therapy, healthy lifestyles and exercise, and meditation and stress reduction.
- 4) Related topics such as the cost of cancer care, legal issues, in-home service and respite care, and returning to the workforce after cancer treatment.

All workshops offer the chance for members of the CSCVVS community to ask the experts questions about their unique situations and concerns.

**Counseling Services – Peer-led vs. Professionally-led:** Licensed and pre-licensed (under licensed supervision) mental health professionals offer adults more than 900 short-term individual and family counseling sessions annually. While we understand that many grants will not consider staff salaries as part of the funded budget, it is important to understand the value of our program and clinical staff.

In 2007, the Institute of Medicine released “Cancer Care for the Whole Patient: Meeting Psychosocial Health Needs,” emphasizing the importance of addressing the social and emotional needs of individuals facing cancer, rather than just their physical needs.

Mental health is at a critical level in our community and throughout the country. During the pandemic, our participants expressed increased levels of isolation, depression and feelings of hopelessness. We are also seeing increased suicidal ideations. Quite often, new participants come to us in a state of extreme distress. Utilizing trained and professional mental health professionals to assess these stressors and facilitate our support groups is the preferred model, per proven research when dealing with a cancer diagnosis, for both the patient and their families.

Mental health professionals are increasingly overwhelmed by the needs in the community. Cancer Support Community is very fortunate to have a team of 9 licensed therapists to deliver our services. Many of our therapists also maintain their private practice but continue to facilitate support groups for us. Although we pay our therapists for group facilitation, the rate we pay them is only a small percentage of their private practice rate. It is because they are so dedicated to our mission and our participants that they continue to work for us. Therefore, it is a very high-level quality of care delivered to our support groups. We do not limit the length of time a participant or family can attend our groups, unlike many insurance companies.

***Outreach and marketing:***

To build awareness and participation in this new in-person, Simi Valley support group and classes/workshops, we will build a marketing and outreach plan, utilizing our Outreach Coordinator. Our Outreach Coordinator will schedule monthly and weekly visits to Simi Valley oncology offices, healthcare providers and other related organizations to inform them of new local programs and support groups. The plan will include participation in large Simi Valley community events and activities, including Chamber events. We will also execute a social media and email campaign to reach our targeted market and demographics. We will also utilize our existing media sponsor support from Simi-based radio station 99.1 The Ranch for on-air promotion.

***Evaluation and Implementation:***

CSCVVSBS gathers process and outcome data to measure the success of Cancer Support and Education services. CSCVVSBS evaluation tools (available in Spanish and English) include: 1) Workshop Evaluations, 2) Participation Satisfaction Surveys capture participant opinions about programs and support received as it affects their well-being, recovery, and quality of life; 3) Attendance logs and participant demographics from workshops, classes, support groups; 4) anecdotal evidence about the impact of the workshops, classes and support group as documented by facilitators. The Program Director oversees the support group facilitators and troubleshoots concerns. The Program Director works closely with the Executive Director, who reports to the Board monthly. Outcome measures are tracked to determine if interim goals are being met and mid-course program adjustments are made accordingly. The Executive Director and board members use quantitative and qualitative data to outline future goals and next steps for programs. Outcomes are shared with donors and publicized on the e-newsletter, website, and social media accounts.

**Qualifications of Staff to Ensure Success of Program**

Executive Director: Monica Murrietta has a strong background in successful fundraising, donor stewardship, volunteer management and staff development. Monica has over 15 years of nonprofit experience in the Central Coast from Ventura County to Monterey County, including 10 years at American Cancer Society and 3 years as the Executive Director at American Heart Association. Monica is a four-year breast cancer survivor and brings that additional perspective to our work at CSCVVSBS. Because of her cancer journey, she has a deep appreciation for the support CSCVVSBS provides to participants living with cancer and their families.

Clinical and Program Director: Kayo Matsumoto, MS, LMFT (License #94640), oversees all clinical programs and supervises clinical staff and interns, adjunct staff, workshop speakers, and participant-related services.

Support Group Facilitators: CSCVVSBS has nine licensed mental health professionals (Ph.D., LMFT, LCSW, RN) as support group facilitators who are also psycho-oncology specialists with about 126 years of combined experience.

Outreach Coordinator – well-versed in CSC programs and services, our coordinator spends most of her time in the community visiting healthcare offices/clinics, at various health fairs, expos, Chamber events and networking events.

## **Simi Valley Scope of Work**

On behalf of CAREGIVERS, our Board of Directors, and the hundreds of seniors we serve each year, thank you for this opportunity to apply for the Community Projects Grants Program. Since CAREGIVERS' founding in 1984, through a grant by the Robert Wood Johnson Foundation, dedicated volunteers have served frail homebound seniors through a one-on-one match between a senior and a volunteer. This caregiving model has served as a national model of excellence for senior caregiver organizations throughout the country.

Our volunteer, one-on-one match program, provides non-medical, in-home support services and transportation for homebound, frail elders, preventing their premature placement into board and care facilities and making it possible for them to continue to live in the comfort and security of their own homes. For Simi Valley, this relatively new and quickly growing program has seen volunteer efforts and activity double just in the last year. This program offers a tremendous benefit of hope and caring for the homebound seniors of Simi Valley.

CAREGIVERS' volunteers provide free in-home services and transportation assistance to low-income, homebound, frail, and often lonely elders, for 2-4 hours a week, allowing seniors to age in place with dignity. Our amazing, dedicated volunteers are the lifeblood of our organization, and angels to the seniors we serve.

Over the years we have added additional support for our seniors like Shop and Drop, Phone Friends, the Building Bridges intergenerational program, and access to 150 other county resources like mental health aid and emergency food. Our Building Bridges program, for example, trains high school students to assist isolated, mostly low-income, frail elders, in their homes, under adult supervision. These students, from all walks of life, economic and racial backgrounds, learn to work together to help an elder in need. Participation improves students' confidence, communication skills, leadership qualities and maturity. Students earn community service credits, which they need to graduate, and enhance their opportunities for colleges and scholarships.

Once a senior enrolls with us, they remain part of the CAREGIVERS family through end-of-life. We are proud to say that 90.26% of our seniors remain living independently, with dignity, thanks to this forward-thinking model of service, and 63.01% of our seniors remain independent for five or more years.

This past year CAREGIVERS:

- Served 575 unique seniors through our programs throughout the county.
- Served 37 unique Simi Valley seniors, 4 of whom transitioned.
- Engaged a total of 32 Simi Valley volunteers.
- Provided 50,065 total volunteer hours for the county, 2,500 of which were dedicated to Simi Valley.

- Provided 48,122 miles in transportation for the county, with 3,000 miles of transportation within Simi Valley.
- Provided phone or email counseling (referrals to services).

Our need for continued funding is to address the growing needs and the plight of our underserved, frail, homebound seniors. Every day, we work to serve these low-income, homebound seniors living in Ventura County, who are long past retirement but are not at the end of life. There are often no adult children to take them to the doctor, nor spouses to prepare dinner. There may be no friends to offer a respite in their day – to make them laugh or provide conversation. We are able to help each of these seniors through a volunteer caregiving structure. But, we are unable to reach every senior who needs our help, despite this expanding population. And with the increasing ongoing costs for general support, the demands to our organization are formidable.

Since July 1, 2023, CAREGIVERS has received 37 inquiries from homebound seniors in Simi Valley. This show of interest makes it likely that we will surpass our goal of serving 50 seniors this year. If this rate continues, we are likely to have over 80 inquiries with an enrollment potential of 20% over last year.

Each senior enrolled in our program costs us approximately \$742.00 each year. With 37 currently supported, less 4 who recently moved or died, we have had a total annual cost to us of \$27, 454.00. With 33 currently enrolled, our goal for this grant period is to serve 50 Simi Valley homebound seniors, adding 17 to our current enrollment. Although enrollment may increase higher than 17, we are requesting funds to cover the anticipated enrollment of 17, for a total of \$12,600.00. As our program in Simi Valley continues to expand, we are confident we will be able to expend these funds through the grant period.

CAREGIVERS' services are offered free to our seniors, providing for a community of seniors who are transformed by well trained, caring volunteers who provide the senior a sense of peace of mind, kindness, and support. CAREGIVERS understands that a ride to the doctor, picking up pharmaceuticals, or a trip to the grocery store is essential for a vulnerable senior's well being. These are components critical to the success of healthy individuals, particularly those returning from a hospital visit or undergoing treatment. We are grateful to be able to provide these life-assuring services to the frail, homebound seniors of Simi Valley.

I hope this letter finds you well. As a valued member of our community, I am reaching out to share an important initiative undertaken by Eagle Vision Outreach, a 501(c)(3) non-profit organization dedicated to serving the needs of veterans, the homeless, disaster relief efforts, and the disadvantaged in our area.

In light of the unpredictable nature of emergencies and disasters, it has become increasingly imperative for us to bolster our preparedness efforts. Our current focus lies in assembling emergency food and toiletry kits, which will serve as vital resources for individuals and families in times of crisis.

I am pleased to provide you with details regarding our one-day emergency food kits and toiletry kits, as well as our plans for distribution. Each emergency food kit contains approximately 13 essential items, carefully curated to sustain an individual or family for up to 4 to 6 days, depending on usage and family size. These kits include staple items such as spaghetti and sauce, rice, beans, canned fruits and vegetables, protein sources, snacks or desserts, and beverages. While the specific contents may vary slightly from kit to kit, each one is designed to provide nourishment and sustenance during challenging times.

Our estimated cost for each emergency food kit ranges from \$13.00 to \$16.77, based on retail prices of \$1.00 to \$1.29 per item. With a goal of assembling 1000 kits, our projected budget falls between \$13,000 to \$16,770. However, through strategic bulk purchasing, we are confident in our ability to reduce costs and produce even more kits to meet the needs of our community.

Similarly, our toiletry kits are thoughtfully curated to address personal hygiene needs during emergencies. These kits contain approximately 15 essential items, including deodorant, soap, wipes, shampoo and conditioner, toothpaste and toothbrushes, lotion, sunscreen, sewing kits, tissues, and more. With an estimated cost of \$15.00 to \$22.50 per kit, totaling \$15,000 to \$22,500 for 1000 kits, we aim to ensure that individuals have access to basic hygiene necessities during challenging times.

In addition to these kits, we will also be distributing pallets of water, animal food, diapers, women's hygiene products, and other essential supplies to further support our community during emergencies and disasters.

I am pleased to attach photos of our emergency food and toiletry kits for your reference. These images capture the essence of our commitment to providing quality resources to those in need.

We believe that by working together with partners like you, we can make a meaningful difference in the lives of our neighbors and contribute to the resilience of our community during times of crisis. Your support and collaboration are invaluable to the success of this endeavor.

Project Overview:

The Free Clinic of Simi Valley (FCSV) Dental Program Equipment Upgrade Project would enhance our Dental Program’s diagnostic capabilities and increase the efficiency of our program. We would be upgrading to new laptops and digital sensors from older more dated systems. This upgrade will produce better quality images, help to streamline our diagnostic process and capabilities, and will benefit the patients of the Free Clinic of Simi Valley. Last year we served 1,421 patients across all of our programs, of those patients 710 or 49.96% of those we served are local Simi Valley residents. Last year in 2023 alone we saw 409 visits to our Dental Program ranging from simple cleanings to extractions to dentures.

Law Enforcement Exploring is an immersive, hands-on program for individuals interested in a career in law enforcement or a related field in the criminal justice system. GiGi's Playhouse Simi Valley Grant Proposal**

**Our Mission:**

The GiGi's Playhouse mission is to change the way the world views Down syndrome and send a global message of acceptance for all. Upon opening our physical location, Simi Valley's GiGi's Playhouse will be the newest playhouse in a network of 58 brick-and-mortar Down syndrome achievement center locations across North America. We will also be only the fourth location in all of California. We are profoundly changing lives through free, educational, and therapeutic-based programs for individuals with Ds of all ages, from infancy through their full adult life.

**Who we serve:**

**Individuals with Down Syndrome:**

Down syndrome (Ds) is the most common chromosomal disorder in the U.S. according to the National Institutes of Health. There is an urgent need to improve the lives of those with Down syndrome and those touched by it. Ds can cause a variety of delays in physical and intellectual development. People with Down syndrome are born with life-altering conditions that confront them from birth through every stage of life.

People with Down syndrome are also born with hypotonia, or low muscle tone, which poses significant challenges in every area of their lives including speech, digestion, fitness, motor skills, and more. Hypotonia can be described as muscles not having stamina, responsiveness, or resistance in the muscle. Individuals with Ds also have higher rates of obesity than their peers.

Individuals with Down syndrome may require continued support with daily tasks once they reach adulthood. A supportive family, community, and interactive programming that supports healthy lifestyles are important for adults with Ds.

**Proposed Community Project:**

We are seeking \$30,288.73 to support GiGiFIT Programs. This is an ongoing health and wellness program and uses our signature GiGiFIT curriculum. This programming supports strength training and cardio workouts that are helpful in combating hypotonia and obesity. We are seeking equipment, furnishings for our GiGiFIT gym area, materials for training volunteers, and print materials for participants. Individuals with Ds are encouraged and supported to participate in GiGiFIT Programs independently, however, a member of their household is required to stay on site during the program. Due to this requirement, we are also seeking to furnish our family waiting room area. If funded, the items in this proposal will support both teen and adult clients with Ds.

Our goals for the grant term are to:

1. Purchase supplies to create training manuals for program volunteers.
2. Train 12 volunteers to run GiGiFIT (two co-leaders, seven program assistants, two greeters, and one host family).
3. Market GiGiFIT programs. Recruit students for six GiGiFIT cohorts per calendar year (three for teens, and three for adults).
4. Serve a minimum of 75 clients with GiGiFIT Programming.

5. Increase new families recruited by 10%.
6. Support clients with Ds in reaching their personal health goals identified in program pre-survey.

### **Benefits to Simi Valley:**

The benefits of GiGiFIT programming to Simi Valley are many.

#### **Individuals with Down Syndrome:**

In the 1980s, the life expectancy for an individual with Down syndrome was 25 years old. Today, individuals with Ds are living to age 60+. We see a need to broaden opportunities for adults with Down syndrome. GiGiFIT supports exercise, healthy eating, and healthy lifestyle choices that contribute to a longer, healthier life. There is also a social aspect to group fitness classes that is fun and exciting.

#### **Family Members:**

Our recent client survey indicates that parents of adult children with Ds are looking for more ways for their adult children to engage in the community. It also shows that parents of teens with Ds worry about what opportunities are available for their children once they graduate from high school. Parents whose children are in day programs currently express a desire for their children to have more activities in which to participate. While these activities are fine, not every adult with Ds enjoys these activities to the same extent. Inclement weather requires more indoor spaces for individuals with Ds when their outdoor activities that currently exist stopped due to rain or excessive heat. GiGiFIT will add programming to our community giving families of adults with Ds more choices about how to spend their time, get much needed exercise, and make new friends. Families will know that their loved one with Ds is in quality programming at a safe place.

#### **Community Members:**

Potential volunteers who completed our Volunteer Interest Form have expressed a desire to work with an adult population. We want to increase our adult programming to make sure that volunteers are matched with their volunteer activity of choice. There is a sincere desire on the part of potential volunteers to support adults with Ds in a meaningful way. GiGiFIT is the program that will allow us to match skilled volunteers with adults with Ds that are ready for new career skills.

#### **Sustainability:**

GiGi's Playhouse Simi Valley hired a Site manager, Catey Franklin, in January of 2024. This full-time staff person, along with our Volunteer Coordinator (a volunteer position) and our Programs Chair (a volunteer position) are adept at working together to recruit both skilled volunteers and clients to participate in GiGiFIT.

Our organization is steadily building a name for ourselves in the community. Attendance to our events grows annually. We hold volunteer orientation monthly for new volunteers, and a solid, comprehensive volunteer training program.

We will work alongside other organizations that serve individuals with Down syndrome, such as The ARC of Ventura County, local Parks & Rec Departments, the Tri-Counties Regional Center, and special education programs at schools and universities to deliver quality programming to Simi Valley residents with Ds and their families. Our mission is unique to other programs in our area, and all programs are free.

Our Board of Directors consists of parents of children with Down syndrome, a physical therapist who has worked with clients with Ds for 20+ years, grandparents of children with special needs, teachers, a retired lawyer, administrative professionals, and a nonprofit executive.

The original GiGi's Playhouse, Inc., headquartered location in Hoffman Estates, IL, provides administrative support so that we can focus on programming that meets the needs of our local Ds population. Additionally, we have a network of 58+ playhouse locations that we can reach out to with questions and advice as we plan and serve.

## Scope of Work

### Program Overview

#### Request

As a leading provider of affordable housing and services in Ventura County, Many Mansions proposes to address the immediate challenge of homelessness in the City of Simi Valley through our Supportive Services Program. Our approach is informed by a best-practices framework focused on increasing access to permanent housing, while delivering coordinated services to promote housing stability and improved quality of life.

In partnership with the City of Simi Valley, we request \$15,000 for our Supportive Services program at three Simi Valley affordable housing communities: Casa de Paz Apartments, La Rahada Apartments, and Peppertree Apartments. **Funds will be directed toward program operations, including salaries for on-site Case Managers, to support 32 extremely low-income households (30% area median income).**

#### Services Provided

Providing more than just housing, Many Mansions develops communities where residents thrive. Tailored to those who have experienced chronic homelessness (1+ years), the Supportive Services program guides residents' transition from homelessness into housing while also addressing the root causes of homelessness. Provided onsite and free of charge, we adapt the program to meet the needs of each community. In Simi Valley, for example, one-third of our population are senior citizens and all live with a disabling condition.

Core elements of the Supportive Services program include:

- **Individual Case Management** - Case managers serve as the cornerstone of the program, providing wraparound services, such as one-on-one counseling, service coordination, and intensive support as needed. Using evidence-based practices (such as trauma-informed care, motivational interviewing, etc.), case managers work with residents to set goals and create individualized plans to achieve them.
- **Life Skills Workshops** - Our monthly workshops are designed to build practical skills and promote independence. Topics include health & wellness, general first aid, natural disaster preparation, household cleaning, etc. We also offer training to support economic resiliency, such as smart budgeting, banking, and tax preparation. Our three-part money management series, delivered in collaboration with Financial Beginnings California (a

non-profit financial counseling organization), focuses on money saving strategies and making sound financial decisions.

- **Community Building Activities & Events** - Staff host regular community-building activities to reduce isolation and develop support networks. Examples include property anniversaries, holiday celebrations, open mics, game nights, coffee socials and much more. Residents are also encouraged to facilitate gatherings on topics that interest them, such as demonstrating a hobby or creating arts & crafts. Combined, these elements create a foundation of success with positive long-lasting results.
- **Resource Referrals** - We coordinate with a growing list of community partners to increase our residents' access to services. Examples include Harbor House, Lutheran Social Services, and Ventura County Homeless Services Agency (support for homeless individuals and families), Department of Rehabilitation (employability skills and enrollment services), County Registrar (how to vote), Ventura County Agency on Aging (support for senior residents), Ventura County Behavioral Health (mental health services), Whole Person Care (access to healthcare and other social services), Ventura County Public Health (nutrition workshops), Ventura County Veterans Services (support for resident veterans), Community Action of Ventura County (utility assistance support), and United Way of Ventura County (free income tax preparation).

Many Mansions receives referrals for our Permanent Supportive Housing program through Ventura County's Pathways to Home Coordinated Entry System (CES), which prioritizes resources for those with the greatest need and connects them with services aimed at reducing homelessness. In addition, we participate in the Homeless Management Information System (HMIS) to collect, analyze, and report on client-level data.

Our comprehensive approach has led to demonstrated success, with 95% of Many Mansions residents achieving housing stability and improved quality of life over the past five years.

## **Program Goals**

With a focus on the most vulnerable members of our community, the Supportive Services program promotes housing stability, increased life-skills, and greater self-determination. To ensure program quality, Many Mansions analyzes case management activities, tracks training participation, and monitors outcomes for program participants.

Resident focused outcomes for FY2023-24 include:

### *Housing Stability*

- 95% will remain housed during the year or move to more independent housing
- 80% will pay their rent on time or create a monthly payment plan

### *Life Skills*

- 80% will complete and/or update a budget annually
- 75% will participate in life skills workshops, volunteer activities, and social events

### *Wellness & Self-Determination*

- 75% will actively engage with case management staff and the services they offer
- 75% will establish personal goals and show progress towards achievement

## **Community Need & Benefit to Simi Valley**

According to the 2023 Homelessness Plan, the number of people experiencing homelessness in Ventura County over the last six years increased by an astounding 86%. In addition, The Continuum of Care reports that between the years 2022 and 2023, the homeless population in the county rose by 9%—with a 25% increase in individuals who experience chronic homelessness.

The 2023 Point in Time Count shows that the total number of unhoused individuals in Simi Valley rose by 6%, while the total number of unsheltered individuals increased by 19%. The following data provides additional insight into the growing need for Supportive Services in the City:

- 44% of unsheltered adults in Simi Valley are chronically homeless
- 32% of unsheltered adults in Simi Valley live with a physical disability
- 31% of unsheltered adults in Simi Valley live with a chronic health condition
- 25% of unsheltered adults in Simi Valley live with a mental illness
- 22% of unsheltered adults in Simi Valley struggle with substance use disorder

Without targeted resources and support, these factors impact unhoused residents' ability to access and maintain housing, further contributing to the growing issue of homelessness.

By addressing the need for housing in tandem with the root causes of homelessness, Many Mansions helps to create stability and expand opportunities for those who need it most in Simi Valley.

## **Program Feasibility**

For the past 45 years, we have provided quality affordable rental housing in Ventura County and services that encourage our residents to thrive. We currently own and operate 22 apartment communities, housing more than 1,700 residents in over 734 units in Los Angeles and Ventura Counties.

Many Mansions is proud to be a current and former recipient of grant funding from the City of Simi Valley. Our responsible stewardship practices have resulted in a demonstrated ability to expend the award funding within the allotted time period and adhere to official reporting guidelines. Many Mansions maintains strict financial controls and oversight over the use of funds, including city, state, and federal grant awards received. This also encompasses policies on reporting, procurement, conflicts of interest, auditing, etc. At the staff level, Many Mansions has a separate Finance Department which oversees all financial matters, including the administration of grants. The Finance Department follows the policies and procedures set forth in written Board-approved Financial Management Policies.

Many Mansions' decades of experience in delivering these services have demonstrated strong results. As outlined in our FY2023-24 Community Projects Grant Q2 report, 96% of program participants in Simi Valley remained permanently housed. In addition, 85% participated in trainings and workshops, 93% engaged with case managers to receive wraparound services and 92% made advancements in reaching personal goals, further illuminating the effectiveness of Permanent Supportive Housing in addressing homelessness.



## Budget

The budget for the Many Mansions Supportive Housing Program in Simi Valley is approximately \$139,000 a year.

### **Description of Community Services Provided:**

New West Symphony, in its 30<sup>th</sup> season in 2025, is a professional orchestra under the direction of Grammy Award-winner Michael Christie, draws its players from the world's most accomplished musicians and presents 12 concerts annually in Thousand Oaks and Camarillo. NWS Education and Community Engagement Programs help build young audiences and educate teachers, families, and community members. These programs inspire passion for music through interactive performances and education. New West Symphony musicians also perform in a variety of Outreach Events which include performances, clinics, workshops, and masterclasses at community events, schools, and festivals. Musicians are members of musicians' union Local 47 and guest artists are from around the region and world.

New West Symphony presents Symphonic Adventures each year with a slightly different theme. In 2023 it was CIRQUE DE LA SYMPHONIE. Beauty and thrills are on display! Jugglers, aerialists, contortionists, and strongmen will perform circus acts synchronized to symphonic masterpieces played by the New West Symphony. Experience majestic classics like never before! Featuring Music Director Michael Christie, guest artists and the orchestra present a fun and amusing demonstration of how sound creates a visceral emotional response. For 2025, we are still developing the various aspects but will provide a similar program that serves the children of Simi Valley.

Local districts renewed their commitment to the arts but find it difficult to maintain the high standards they once had for music education. Art is offered mostly after school and for a fee. Many families do not have resources for music education or to attend concerts. We have seen that the impact of hearing a live orchestra, meeting a musician, or simply being exposed to and learning a musical instrument is immeasurable. Music education develops engaged, creative, expressive, responsive, and artistically literate citizens who connect through arts experiences that transcend historical, cultural, and societal contexts.

### **OBJECTIVES:**

Symphonic Adventures: Develops an awareness of the art of movement, special relations and its relation to sound. How it interacts and provides an experience like no other. Students will be awed and mesmerized by the music and program.

### **OUTCOMES:**

Students' awareness of the various attributes of sound and how it can be recognized as music are improved.  
Students understand the influence of music on their emotional & physical condition.  
Students acquire an understanding of the basic elements of music, rhythm, melody and tempo, and can identify the instruments that produce those elements. And do so with visual cues from the performers.  
Students gain a broadened knowledge of different musical genres and consider creating their own "life soundtracks."

In prior years, NWS regularly hosted approximately 5,300 third- to fifth-grade students from over 200 classrooms, 45 schools and 17 school districts in Ventura County for Symphonic Adventures. We included teachers, parents and guests from the community.

With online programming we have developed since Covid, we can increase access because schools will no longer need costly transportation, allowing nearly every child in the county to participate at a time convenient to them. The primary student population in Ventura County served by NWS is from schools with a majority (84%) of the students meeting Federal Title 1 criteria of being under resourced and at-risk of not successfully completing high school, or from low-income families. Many are designated with disabilities.

The New West Symphony humbly seeks a \$50,000 contribution towards our Symphonic Adventures program. Since 2001, we have proudly offered this program, along with other educational initiatives, benefiting up to 260 children in Simi Valley annually (with the exception of the COVID years). Despite serving the community diligently, we have not received any financial support from the City of Simi Valley for these endeavors.

Our Symphonic Adventures program, which serves all Ventura County Schools, operates on a budget of \$84,500 annually. However, the allocated amount for Simi Valley, considering the number of students served and the funds expended, amounts to only 4% of our budget.

We sincerely hope you recognize the necessity for additional funding. While we are committed to providing these services and will continue to support Simi Valley, we believe it's reasonable to seek financial assistance given the significant value our program brings to the community.

### **Additional Information**

NWS relies on grant funding for Symphonic Adventures. For Symphonic Adventures and education programs, NWS has received funding from Smith Hobson Foundation, Meadowlark Service League and California Arts Council in 2023 totaling \$74,000. If we cannot raise the full amount, the project will be viable on a modified scale to reduce costs. This is an existing project that has been funded through government, foundations and private donors for more than 21 years. The New West Symphony provides additional funding from it's general funds, along with staff time for this important educational program.

PathPoint estimates that between 37 to 45 people with intellectual and developmental disabilities (I/DD) will be directly served through this project. Grant funding will benefit people in Discoveries, which is PathPoint's licensed Adult Day Program in Simi Valley. Additionally, we estimate that somewhere between 75 to 150 family members and support networks of the people in these services will also benefit, as their loved one will have access to the resources and tools needed to thrive.

Out of the 37 individuals currently served, 92% are residents of Simi Valley, with the remaining 8% holding residency in surrounding cities. Though we currently serve 37 people, the service is licensed to support up to 45 and we are actively working with Tri-Counties Regional Center (our funder, who is contracted with the CA Department of Developmental Services to provide sustainable operational funding to service providers like PathPoint) to offer support to more community members. As previously mentioned, grant funding will directly benefit these 37- 45 individuals as the improvements will enrich daily programming and provide added resources that allow people to achieve their personal goals. Indirectly, however, somewhere between 75 to 150 Simi Valley families and support networks (siblings, grandparents, extended family, kinship family, etc.) of the people served will also benefit. When their loved one can access services that enhance independence, choice, and self-confidence, the entire family and extended family unit is elevated. PathPoint's entire service model is aimed at incorporating the family into service provision. For one thing, each person served receives an Individualized Support Plan (ISP), outlining their goals, strengths, opportunities for growth, and how staff can best support them. Families and support networks are actively involved in this process, so they can offer input and personally evaluate the ways that they support their loved one. PathPoint also offers many opportunities for families to be involved and provide feedback for our organization-wide initiatives. We host live Family Virtual Gatherings with leadership, send an annual Services Survey, and Program Coordinators and Managers are frequently in contact to provide operational updates. In sum, PathPoint's services aim to provide the hands-on support, knowledge, and resources that families need to help their loved one live the life they choose.

### 9. Is your organization a 501(c)(3)?

PathPoint is a 501(c)(3) nonprofit that supports people in living the life they choose. We partner with people with disabilities and people with behavioral health diagnoses to pursue their hopes and dreams through strengthening workplace abilities, building life skills, and developing meaningful relationships. Established in 1964, we've since grown to serve nearly 2,300 people across five counties: Ventura, Santa Barbara, San Luis Obispo, Los Angeles, and Kern. Throughout Ventura County, PathPoint serves 320+ people with a wide array of intellectual and developmental disabilities (I/DD) including: autism (31%), behavioral disorder (7%), cerebral palsy (7%), Down syndrome (9%), intellectual disability (30%), seizure disorder (2%), other I/DD (10%), other physical disability (2%), and unreported (2%). We receive base/ operational funding from Tri-Counties Regional Center and fundraise to cover additional needs (i.e. improvements, new supplies, and other items that enhance service delivery). We provide three different service types: Community Integration Services (CIS) – offered during standard business hours, 5 days a week. Services support people to reach their personal goals, learn new skills (such as art, cooking, pre-vocational training, etc.), and engage with their community. Discoveries is part of CIS. Employment Services (ES) – staff work with people served to complete goal assessments, increase job skills, and secure gainful employment. Services include training, job coaching, and direct job connection. Independent Living Services (ILS) – provide integrated housing support to people who have the ability and desire to live on their own. Staff work with residents to achieve daily living goals and learn new skills such as cooking, cleaning, shopping, self-care, etc. In Ventura County, PathPoint also offers the Life Skills Center – a day rehabilitation program that supports 84 people with psychiatric diagnoses/ chronic mental illness to achieve recovery.

## PathPoint's Scope of Work (SOW) – “Developments for Discoveries Day Service” City of Simi Valley Community Projects Grant 2024



### Project Overview

PathPoint respectfully requests \$20,000 towards improvements that will benefit our Discoveries Day Service in Simi Valley, which supports people with an array of intellectual and developmental disabilities (I/DD) to reach their personal goals, hone their interests, and increase social aptitudes. All funding will be utilized towards three different categories of improvements that directly impact our individuals: kitchen upgrades, furnishings, and curriculum supplies & technology. The grant goal is to provide a high-quality environment, equipped with the tools and resources that our individuals need to learn new skills, build relationships with others, and ultimately, live the life they choose.



### Benefit to Simi Valley

The question on nearly every parent and family member's mind as they and their loved one navigate the range of options for people with I/DD is “How do I ensure my child lives a good life, is independent, and is able to live and enjoy life alongside people without disabilities?” That's where PathPoint comes in – we support people to live the life that *they choose*. Since 1986, our organization has provided quality-of-life altering services for people with I/DD across Ventura County. Our services have played a crucial local role in eradicating the tumultuous history of institutionalization, “otherness,” and lack of choice that this population has historically faced. Organization-wide, our dedicated staff provide person-centered planning that truly puts the individual at the forefront of their care plan, empowers them to develop goals specific to their desires and interests, and gives them the tools, support, and self-confidence necessary to achieve these goals.

In the Simi Valley community, there are few other service providers that do precisely what PathPoint does, especially in Discoveries. PathPoint's philosophy is that people with I/DD belong in the community, as valued friends, neighbors, co-workers, and community members. All the items requested in this proposal – kitchen upgrades, furnishings, and curriculum supplies & technology – are aimed at providing people with the tools needed to reach this goal. For instance, as part of our proposed budget, PathPoint will procure desktop computers, which will enable people served to learn how to safely surf the web, find reliable informational articles on topics they are interested in, or perhaps create a resume for a job interview. In another example, PathPoint has requested funding for kitchen upgrades, which will be used to teach individuals how to grocery shop, prepare healthy recipes, safely store their food, and effectively clean their cooking space. In a final example, PathPoint has also requested community integration materials such as backpacks, first aid kits, bus passes, entrance fees, etc., all of which will provide opportunities for engagement and inclusion, directly in the Simi Valley community. Overall, PathPoint's Discoveries Day Service offers a huge benefit to Simi Valley, by teaching people with I/DD the skills they need to gain confidence, independence, live fulfilling lives, and contribute to their community.



### Ability to Complete the Project

Our organization has a history of strong grant management and administration. Over the years, we have managed funding from local sources – such as community foundations, city governments, private donors – as well as large-scale funding from statewide agencies such as Department of Developmental Services (DDS), Department of Health Care Services (DHCS), CA Department of Transportation, and many more. On a consistent basis, we are able to adhere to our proposed budget and meet all reporting and

spending deadlines. With funding from the City of Simi Valley, we will be able to exhaust all funds by June 30, 2025.



## Community Needs

This fiscal year, there are nearly 25,000 more individuals projected to enter California’s Developmental Disabilities System, bringing the total to more than 450,000 people statewide. Additionally, recent national data from the Center for Disease Control (CDC) reflected that the number of children with developmental disabilities is on the rise, as one in eleven kids are diagnosed with autism, an intellectual disability, or a developmental delay. Between 2019 and 2021, the incidence of developmental disabilities grew from 7.4% to 8.56% among children ages three to seventeen across the county. In Ventura County specifically, the 2021 Census reported that 7% of the population under 65 have a disability (though no data is made available on the prevalence of I/DD specifically). Now more than ever, service providers like PathPoint are needed to meet the growing need and provide strengths-based support that allows this vulnerable demographic to thrive. Service providers like PathPoint allow this population to avoid negative outcomes – such as homelessness, institutionalization, interaction with costly emergency services like jails, hospitals, shelters, etc. – and instead lead fulfilling, healthy, and productive lives as valued community members.



## Cost Breakdown

Please see our attached budget for a complete breakdown of our costs and revenue sources for this project. Please also note that PathPoint is appreciative of any funds the city can offer towards this project, whether it be the full or partial requested amount. Funds will enhance the quality of services equally for the 37-45 people served in Discoveries (and enable more people to join the service in the coming years), as they are communal items – rather than individual items that someone may take home – that everyone will have the opportunity to utilize.

## Sarah's House Maternity Homes

Sarah's House has been going strong for 33 years. Our two homes provide shelter, love, care and education in an undisclosed residential setting in Simi Valley. Our program is available to expectant and single women who are 18 years or older. Our program assists women that find themselves with little or no support during pregnancy and/or on their journey as single mothers. These women, through their own hard work and the love given by their new Sarah's House family, find the firm foundation they need to make positive changes in their lives.

Our program provides housing, weekly counseling, classes on nutrition, job placement and educational counseling, birthing, financial management, adoption support, single parenting, infant care, grocery shopping, meal planning and cooking. Each woman must follow established guidelines with regard to working, attending school, household responsibilities and savings. Our program is a full wrap around program providing case management, life skills training, career and job development, household responsibilities, classes and assistance in beginning a changed life, and breaking the cycle of poverty and abuse.

Our residents are required to save 80% of their expendable income to be used for a necessity such as a car, emergency fund, and first and last month rent as they transition to independent living. All of our residents are required to work or go to school at least 20 hours a week during their pregnancy and 32 hours a week after release from the doctor's care after the birth of their babies. Many of these hard working moms do much more.

### **Scope of work:**

Sarah's House is in need of financial resources to meet the needs of homeless expectant and single mothers and children in Simi Valley. Sarah's House would like to request \$35,000.00 to support our homes and the women and children we serve. All projects/programs will begin July, 2024 and conclude no later than June, 2025.

Sarah's House is in need of a new roof at our maternity home. We would like to request funding to replace the roof in the amount of \$20,000.00. Our home is 58 years old and has had one roof replacement approx. 32 years ago. By replacing the roof we will insure that we will not have water damage, possible mold and/or additional drywall repair. The health and safety of the women and children is first and foremost at Sarah's House. This grant will help us create a safe and healthy home for the women and children we serve.

In addition, we would like to request funding for our Education Program in the amount of \$10,000.00. The scope of our Education Program includes assisting women with class room and study materials, books, tuition and transportation for GED programs, Moorpark College classes, and Simi Valley Institute for Careers and Education programs. Education is essential to a single mom's ability to further their career and transition to independence. The women in our program are often fleeing abuse and/or come from dysfunctional living environments. Education and a path forward are key to beginning a new life.

Furthermore, we are in need of window coverings for twelve (12) windows. All of our current blinds (9) do not operate properly and we are in need of drapes and rods for 3 windows. Properly operating blinds and drapes will help save on utilities and further secure our home.

## *Until All are Fed...*

February 14, 2024

To whom it may concern,

Still Waters, a ministry of Shepherd of the Valley Lutheran Church in Simi Valley, CA, has been committed to fighting hunger within our community since 2009. At its inception, Still Waters Café provided a weekly home-cooked, hot meal with limited pantry offerings for all in need, creating space for members of our community to come together for conversation, care, and nourishment. The COVID pandemic challenged us to reinvent our ministry in a way that was safe for our volunteers and patrons to meet, and to provide for the extensive needs that emerged from this challenging time. It was in mid-2020 that Still Waters Pantry was born; a departure from the Café model, but one that continued our mission.

Over the last four years, Still Waters Pantry, has seen a huge rise in the number of individuals and families within the community needing assistance. The high cost of inflation along with COVID have sent people from all backgrounds to seek help. In 2023, we had 10,238 families seek help, which amounts to over 33,871 people fed or statistically, Still Waters Pantry has provided 3 meals a day for 3 days for families. Up until this point, we have been able to meet this great need thanks to our generous local donors and amazing volunteers. However, in 2022 and 2023, we have seen a decrease and even shortage in donations, including those from USDA, that jeopardizes our work.

This grant would help to ensure the needs of the hungry are met within our community.

This grant money would allow us to:

- Continue supplementing our donations with \$200-\$500/week of meat, produce and bread to provide for our usual 230 to 250 families
- Continue purchasing \$250/month of storage bags to allow us to make smaller family size portions
- Replace 2 of our old failing freezers, costing roughly \$3600, and in doing so, cut down on our electricity
- Purchase 12 new tables for the pantry

With the money from this grant, we are hopeful that we will be able to continue helping our community until all are fed. Thank you for your consideration.

Simi Valley Girls Softball recently got approval from the City of Simi Valley to build batting cages on the property at our Big Sky fields. These batting cages would be used by the young athletes involved in the league and is in no way intended to generate income. The intent in building the batting cages is to lower the overall cost for families involved in the league who all reside in Simi Valley. These batting cages would give access to supervised/secure athletic instruction. The cost of the batting cage project is significant. Any funds received would be used towards the cost to complete the project. A trip to the batting cages for a team can range anywhere from \$75-\$100 per hour and with the limited field space for teams to practice, it's a general rule these teams will be at the cages three to four times a month. These cages would offer a long-term solution for the teams of Simi Valley Girls Softball and help families for years to come.

Simi Valley Girls Softball fields (Big Sky Park) was built in 2004 and since then there have been no upgrades to the scoreboards. The boards have started to breakdown and are no longer able to be repaired. Our goal is to provide the young athletes and their families an experience that will keep them coming back and keep their children in sports. It is our belief that team sports and athletics in general has a tremendous benefit that far outweighs the score on these scoreboards, but having an operable scoreboard is a reflection on the memories these kids have when the question comes up next year "do you want to play softball again"?

**Mission:**

We serve all members of the greater Southeast Ventura County community. Our Y's currently serve over 15,000 members in our local community.

**Purpose of the Grant:**

The purpose of the grant is to provide children in our Simi Valley Community an opportunity to learn basic safety water skills at no-cost to these families.

Every day, two children die as a result of drowning. In fact, drowning is the leading cause of death for children between the ages of 5 and 14. The Southeast Ventura County YMCA believes all children deserve an opportunity to learn how to be safer around water. We are committed to making drowning prevention a priority for our community. Not only will we work to prevent these tragic events, but we will also ensure that all children can safely enjoy the health and recreational benefits of swimming.

**Duration of program:**

July 2024 – June 2025

**Scope of work:**

The Southeast Ventura County YMCA seeks funding for our Safety Around Water program to teach basic water safety skills to youth between the ages of 5 and 13. The program introduces a new skill each day which builds to create two sequences that teach a child how to safely move across the water and exit the pool: Swim, Float, Swim and Jump, Push, Turn and Grab.

Our swim instructors are SEVYMCA trained to effectively teach the SAW curriculum set forth by Y-USA and are also Red Cross Lifeguard Certified.

The Y is committed to the following six goals to support our focus on drowning prevention and to promote the health benefits of swimming:

- Educate our community members about drowning prevention strategies.
- Provide safe spaces and opportunities for swimming.

- Encourage investments in drowning prevention in our community.
- Engage/partner with public officials, public health departments and first responders in drowning prevention advocacy.
- Use Y-USA developed drowning prevention key messages to strengthen collective messaging.

Utilize Y-USA provided program criteria, materials, name and impact measurements for our SAW program.

For the 2024 – 2025 fiscal year, we would like to offer SAW to 40 children per session, with 7 sessions per year: Summer 1, Summer 2, Fall 1, Fall 2, Winter, Spring 1 and Spring 2.

We plan to offer 4 classes per week for 6 weeks per session with a maximum of 10 swimmers per class. This would allow for 40 children to learn basic water safety skills each session for a total of 280 children per year.

The amount of \$17,249.52 would cover the costs for all instructors and lifeguards per each session for the entire year.

**Measurements of success of the program:**

- With each session, we open an application to the entire community to see who qualifies for the program.
  - The two basic qualifications are:
    - 1) You do not know how to swim
    - 2) You have never taken a swim lesson before
- At the end of each session, we offer each child a card that either invites them to take swim lessons at the Y or participate in another session of SAW depending on their development during the 6-week session.
- Conduct parent evaluations, student participation and attendance.
- Conduct staff surveys and end of session analysis.
- We run our SAW program with this model at our Yarrow Family YMCA facility and have seen great success.
- We have run the SAW program at our Simi Valley Family YMCA facility previously and have seen its success and need in our community.

**Budget:**

The staffing is the greatest cost of this program for the upcoming year. Any equipment that can be used throughout the program is currently also used during our swim lessons.

**PROJECT SUMMARY**

The Arc of Ventura County (The Arc) is pleased to submit the following grant request for consideration of a Community Projects Grant for FY 2024-2025. We are respectfully seeking funding in the amount of \$34,806 that will be utilized to improve The Arc's Community Integration Day Program, located at 5143 Cochran Street in Simi Valley. This program site provides a variety of services and supports for 76 individuals with intellectual and developmental disabilities (IDD) who reside in the city of Simi Valley and surrounding communities. Our grant request represents 80% of the total project cost of \$43,507.

**ORGANIZATION'S MISSION AND SERVICES**

Established in 1954, The Arc of Ventura County is celebrating its 70<sup>th</sup> year of serving and supporting individuals with intellectual and developmental disabilities (IDD) to achieve their goals toward a life of opportunity, choice, participation and contribution.

The Arc's primary services include Community Integration Day Programs, Community Employment Services and Independent Living Services that benefit over 700 individuals throughout Ventura County. All programs are person-centered and empower participants to access and be a part of their communities in order to achieve greater independence and self-determined lives. The agency employs a team of 200 dedicated employees who are essential to the success of the individuals we proudly serve.

**COMMUNITY NEED**

The Arc's Cochran Day Program in Simi Valley is one of seven (7) Community Integration Day Programs available throughout Ventura County. The property, purchased by the organization in 2006, is situated on approximately 1.3 acres and includes an 8,300 square foot building where the program's services are provided. The Arc also offers a second Day Program, located at 3340 E. Los Angeles Avenue in Simi Valley that is leased from the Simi Valley Unified School District. Together, these two programs serve 105 individuals in the City of Simi Valley.

The Cochran Day Program is a vital resource for individuals with IDD, their families, care providers, and the community of Simi Valley. With the support and mentorship of 21 dedicated employees, the program serves as a welcoming place where individuals come together to develop friendships, express creativity and further their independence. They are inspired to access and volunteer in their community, expand their education, receive job development training and employment placement assistance, improve health and wellness and express artistic creativity.

As the Cochran Day Program continues to increase enrollment and to protect the privacy and safety of individuals served, The Arc is requesting funding to conduct the following improvements:

1. **Modify Large Room for Improved Use** - Currently, this open room serves multiple functions, including housing our program manager and supervisor offices, while also accommodating our meeting and training needs. Due to

the increased request for our services and the need for more privacy and functionality, it is essential to restructure this space. The proposed remodel will involve dividing the existing large room (616 sq. ft.) into two separate office spaces and a designated meeting area. The office spaces will provide private work environments for our program manager and case manager, as well as a separate area for meeting and training needs.

The creation of individual office spaces will lead to increased productivity and effectiveness in managing the program and serving the needs of our participants. The separate meeting space will allow our staff to conduct important meetings with participants, their families and circle of support in a private setting, while offering a dedicated space for group activities and training sessions.

2. **Remove and Replace Sidewalk with ADA Ramp** – The Cochran Program currently serves 11 individuals who are non-ambulatory and utilize a wheelchair. An ADA wheelchair ramp will be constructed in the outdoor program space for egress during an emergency. The ramp will also provide easier access for our non-ambulatory participants and their support staff to depart for activities in the community as it will be located near the program’s entrance at Cochran Street. The addition of the ramp will contribute to our efforts to protect the safety of the individuals we serve and will meet our needs well into the future.
  
3. **Repave and Restripe Driveway and Parking Lot** – This project is greatly needed and will include 22,325 square feet of asphalt to be air broom cleaned and sealed. Estimated 560 lineal ft. of cracks to be treated and filled. Restripe of 25-single line parking stalls; 2-Handicap stalls; and 5-Directional arrow stencils.

Funding received in support of this project will enable The Arc to devote our limited resources to providing services that directly benefit and enhance the quality of life for the program’s participants. If awarded, The Arc is committed to successfully completing the project by June 30, 2025.

**Introduction**

The mission of the Samaritan Center is unwavering and offers people experiencing homelessness and food insecurities with supportive services essential to human dignity. The Center offers case management that supports the unhoused in becoming healthy, housed, and self-sustained. We meet their basic needs (e.g., hot meals, showers, toiletries, clothing, mailing address, etc.) while our case workers help clients design and follow an action plan to overcome their obstacles to independence. Typically, action plans also include referrals to community resources for assistance. The demographic of the unhoused we serve in Simi Valley have very low or no income. The Samaritan Center also helps at-risk families and individuals stabilize and avoid homelessness by offering a weekly drive-through food pantry, utility, and rental assistance. For the housed people we serve, the drive-through food pantry helps reduce their weekly food costs, thereby stretching their limited budgets. The Samaritan Center is the only full-service drop-in center within our community.



## **Problem / Project**

As mentioned above, a key element of our supporting services is to provide a hot meal and food to the unhoused or people in need within our community (Simi Valley) as they work through their challenges and obtain assistance from the Samaritan Center. Recently, however, the commercial gas range/oven at the Samaritan Center is starting to have problems due to being 11 years old. One of the oven doors is failing, limiting its use and it is expected that the remaining oven door and other components will start failing as well. In fact, last year we had to replace the oven pilot and temperature control multiple times. Repair parts for the range and oven door assembly have limited availability (due to the age of the unit) and are very expensive making it not a good investment to repair.

## **Community Benefit**

The Samaritan Center uses the oven daily to prepare a hot breakfast for our unhoused clients and people in the community experiencing food insecurity. During the calendar year 2023 the Samaritan Center served over 5,700 breakfast meals at the center.

In addition to breakfast, the Samaritan Center also serves dinners and the oven is often used to warm food donated by our community partners. During the calendar year 2023 the Samaritan Center served over 6,000 dinners at the center.

The meals served by the Samaritan Center greatly help members of our community that are struggling. By offering the meals at the Samaritan Center those in need can come to a safe place and get the assistance they need.

## **Grant Request**

The Samaritan Center requests funding for a new commercial gas range / oven to support our ongoing mission to serve the most vulnerable within our community. It is estimated that a new commercial oven will cost \$10,708 (See price quote on page 4 & 5).

Once the grant is awarded, The Samaritan Center will place the order and expend all of the awarded funds within the period of performance.
