# 1. Call to Order/Pledge of Allegiance/Welcome

#### 2. Agenda Review

### 3. Approval of Minutes

A motion was made by Peter Carrube and seconded by Jon Gatewood to approve the July 11, 2024 minutes as presented. The motion passed unanimously.

#### 5. Public Statements/Comments

A resident raised concerns following a dog-on-dog attack where the owner of the leashed dog was also bitten while trying to intervene. The resident expressed apprehension that neither the Police nor Ventura County Animal Services did not remove the aggressive dog, which was off the leash.

A resident reported witnessing and recording the dog-related incident lasting about ten minutes. The dog was allowed to remain in the neighborhood, raising concerns due to fears that the dog could be dangerous. The resident strongly disagreed with the decision to not take the dog and instead allow the dog to quarantine at the discretion of the owner and is now seeking transparency from the City and Ventura County Animal Services, as well as, proposing procedural changes for handling such incidents in the future.

#### 6. Informational Presentation(s)

# a. Gauge Your Emergency Preparedness: Are You Prepared?

Bob Maas, Technical Reservist with the City's Emergency Services, highlighted key aspects of emergency preparedness. In any crisis, if the danger is inside, evacuate; if it's outside, shelter in place. The main actions to prioritize are personal safety, assisting others if possible, and maintaining communication with loved ones. Staying informed is crucial. For reliable updates from local

emergency services, residents are urged to sign up for VC Alert at https://local.nixle.com/simi-vallev-policewww.vcalert.org and Nixle at department/. Resource apps include MyShake App, FEMA App, and the Red Cross Emergency App. Know your evacuation routes and have a family emergency plan with accurate contact information. The plan should have petfriendly options if applicable and backup meeting locations. Establishing an emergency support network with at least two contacts, including one out-ofstate person, is essential for maintaining communication during a disaster. Utilize secure bank and insurance apps for critical documents and consider securely storing documents on a password protected flash drive. Preparedness also involves go kits and shelter in place kits with essentials such as water, medications, and pet supplies. Residents can get trained for free with the Community Emergency Response Team (CERT), taught by the Ventura County Fire Department and hosted by the Simi Valley Office of Emergency Services. The next CERT training taught in English runs September 11, 2024 through October 16, 2024 on Wednesdays from 6:00 p.m. to 9:00 p.m. CERT, taught in Spanish, runs September 10, 2024 through October 15, 2024 on Tuesdays from 6:00 p.m. to 9:00 p.m. For more information contact Eileen Connors at econnors@simivalley.org or 805-583-6982.

### 8. City Staff Comments

Kelly Duffy, Community Services Coordinator, emailed all Executive Board members the August City Focus Newsletter link. Jon Gatewood expressed interest in speaking with the public speaker after the meeting regarding the dog incident.

Andy Goitia sought additional details regarding the dog incident. City staff member, Kelly Duffy, stated that the investigation is ongoing, limiting the City's ability to comment. In general, there are varying degrees of dog bites, each handled accordingly.

Fred Peterson expressed sympathy for the public speaker's concerns and suggested that the City explore potential changes regarding similar incidents.
