  - a. Discussion of the 2024-25 YES Advisory Board Work Plan

Chair Gloria Bowman reviewed the purpose of the Work Plan and events that the YES Advisory Board has previously hosted. Dr. Angelica Chavez asked what the purpose of the YES Advisory Board is and Ms. Bowman read the YES Advisory Board mission statement. Bernardo Perez asked about the city's economic development plan and Ms. Bowman stated that in the past the YES Advisory board has received informational presentations from the City and the County regarding economic development. The Interview Skills Workshop in February, the City Expo at the October Street Fair, and the Summer Workshop Series were all discussed and added to the work plan. Hosting a Volunteer Fair was discussed, and tentatively scheduled for November 13 at the Boys & Girls Club, with November 14 as an alternate date. Jennifer Wigdor stated that a flyer be created and submitted to the school district for approval. Hosting a Job & Career Fair was discussed, and the board suggested adding an "Alternatives to College" workshop and a "Financial Literacy" workshop to the Job & Career Expo.

**ACTION:** A motion to approve the 2024-25 YES Advisory Board work plan (Participation in the Street Fair, Volunteer Fair, Interview Skills Workshop, Job & Career Fair with Alternatives to College and Financial Literacy Workshops, and Summer Workshop Series) was made by Anthony Angelini and seconded by Vice Chair Al Brown.

YES Advisory Board Vote: 10 Ayes; 0 Noes; 0 Abstentions The motion passed.

b. Discussion of the Date for the 2025 Yes Job and Career Fair

Chair Gloria Bowman stated that the Job & Career Fair is typically held in April. After discussing various holidays in April, High School Prom dates and High School testing dates, the board suggested April 26, 2025 as the date for the Job & Career Fair, to be held at the Simi Valley Public Library. April 5, 2025 was suggested as the alternate date. Kelly Behle indicated that she would check the Library's schedule to see if April 26, 2025 was available. There being no objections, Ms. Bowman continued voting on the proposed date of the Job and Career Fair to the next YES Advisory Board meeting, when Ms. Behle could confirm the Library's availability.

9. Youth Employment Service Advisory Board Reports and Comments

Anthony Angelini shared that the Sunrise Rotary Club was hosting its annual Octoberfest Event on October 5. Mr. Angelini also stated that the Chamber of Commerce's Street Fair on October 26 was sold out. Kelly Behle shared that the Simi Valley Public Library was hosting a Casino Night the evening of October 5. Chair Gloria Bowman shared different options she was considering for items to give away at the Street Fair and asked for the board's feedback.

which the YES Advisory Board had a booth at. Board members stated that it was a well-attended and well organized event. Mr. Fowler stated the Youth Council was hosting a Rock Painting Night for suicide prevention on September 20.
