SECTION 2: GENERAL REQUIREMENTS

I hereby certify that:

- The above described site is residential and is located in a horse or animal overlay zoning district.
- The residential composting bin will be accessible by the hauler on collection day, that any obstruction will result in service not being provided, and that I am responsible for eliminating the obstruction and calling the hauler for a non-contracted pickup of the bin.
- The residential composting bin is for YARD WASTE AND/OR HORSE MANURE ONLY and that any contamination will result in service not being provided. I am responsible for eliminating the contamination and calling the hauler for a non-contracted pickup of the bin.
- The residential composting bin service does not violate my homeowners' association rules and regulations, if appropriate at this site.
- The 71-gallon trash and recycling containers are part of the residential composting bin level of service and shall be placed at the street for collection only between the hours of 4:30 p.m. the day prior to collection until 10:30 p.m. the day of collection, in accordance with Simi Valley Municipal Code Section 6-3 12(b)
- The residential composting bin and the 71-gallon trash and recycling containers shall be collected at least weekly.
- Trash collection service shall be maintained at all times at the site address, in accordance with Simi Valley Municipal Code Section 6-3.04.

SECTION 3: CHOOSE ONE OF THE FOLLOWING SERVICE LEVELS AND BIN SIZE OWNER TO MANEUVER BIN TO AND FROM STREET Α. I will maneuver my residential composting bin to and from the street. I hereby request a 1.5 cubic yard bin 3 cubic yard bin. I hereby agree: That the residential composting bin may be placed at the street only between the hours of 4:30 p.m. the day prior to collection until 10:30 p.m. the day of collection, in accordance with Simi Valley Municipal Code Section 6-3.12(b). That at all other times the residential composting bin will be located behind a side yard fence, gate, or wall, in accordance with Simi Valley Municipal Code Section 6-3.12(c) or placed on the property where it is not viewable from the public rights-of-way. To place the residential composting bin at the street at an agreed upon location and angle, approved by the City and as indicated in the site plan above, so that the hauler will not have to maneuver the bin to provide service. OR HAULER TO COLLECT BIN ON OWNER'S PRIVATE PROPERTY B. I will authorize my trash hauler to enter my private property to provide residential composting bin service. 1.5 cubic yard bin 3 cubic yard bin. I hereby request a I hereby: Agree that at all times, other than between the hours of 4:30 p.m. the day prior to collection until 10:30 p.m. the day of collection, in accordance with Simi Valley Municipal Code Section 6-3.12(b), the residential composting bin will be located behind a side yard fence, gate, or wall, in accordance with Simi Valley Municipal Code Section 6-3.12(c) or placed on the property where it is not viewable from the public rights-of-way. Certify that this site's driveway, road, easement, etc. is capable of supporting a fully loaded trash truck with a total truck weight of 57,500 lbs., with the front axle weighing 20,000 lbs., and the rear axles weighing 37,500 lbs. Give permission to G. I. Industries or Anderson Rubbish Disposal to enter the above site address for the purpose of providing residential composting bin collection service. Agree to indemnify and hold G. I. Industries or Anderson Rubbish Disposal and the City of Simi Valley, their employees, and their agents harmless, from any and all liability, expense, and claims for damages of any nature arising from or connected with the provision of residential composting bin collection service. **SECTION 4: COMPLIANCE** The City of Simi Valley reserves the right to revoke the residential composting bin service authorization, upon adequate due process, for failure to comply with federal, state, or local laws regarding solid waste and/or the conditions authorizing the composting bin are violated, including repeated contamination found in the composting bin, which causes the load to be rejected by the composting facility. **SECTION 5:** STATEMENT I hereby certify under penalty of perjury that I have read and understand the information contained in this application, that it is true and correct, and that this application is being submitted with the consent of the subject property owner.
