DRAFT MINUTES

- 1. Call to Order and Pledge of Allegiance Toni Olson called the meeting to order at 1:00 p.m. David Kennedy led the Pledge of Allegiance.
- 2. Roll Call Members present were Barbara Durham, Al Fournier, Fred Goldberg, Richard Harper, David Kennedy, Toni Olson, Lucy Schwartz, Frank Sinsheimer, and Bill Witt.
- 3. Agenda Review By consensus of the Executive Board, the agenda was approved as presented.
- 4. Approval of Minutes The minutes of December 9, 2013, were approved by a consensus of the Executive Board.
- 5. Report of COA Chair Chairman Toni Olson wished everyone a Happy New Year. She also announced that the City of Simi Valley "Fast Facts" sheet was available on the information table.
- 6. Representative Reports
 - A. City Council Liaison Council Member Mike Judge had no report, but made himself available for questions.
 - B. Deputy Director/Community Programs & Facilities Director of Community Services Sommer Barwick introduced and welcomed the new Deputy Director, Rob Bruce. Mr. Bruce comes to this position from the City of Simi Valley Environmental Services Department.
 - C. Senior Services Manager Laurie Dickinson announced that Ridone Inc. would be recognized at tonight's City Council Meeting for the cosmetology services it provided to over 100 seniors on Thanksgiving Eve.
 - D. Area Agency on Aging Representative Karen Cline announced that there were four new positions added to the Area Agency on Aging Advisory Board. There will be a representative from Behavioral Health, the caregiving community, the LGBT community, and a veteran. In addition, she mentioned that UCLA would be hosting a health event for seniors on February 5, 2014 in Westlake Village. The event will feature several speakers, most of whom are physicians on senior health and wellness related topics. She recommended people call (818) 880-1084 to make a reservation to attend.

Toni Olson stated that the next Nutrition Committee meeting was scheduled for January 27, and that she would be attending.

- E. Simi Valley Community Council David Kennedy stated that he has no report since the meeting is next week.
- F. Simi Valley Transit Deputy Director Chuck Perkins was not present. Director of Community Services Sommer Barwick announced that the next ADA Paratransit Advisory Committee meeting would take place this coming Thursday, January 16 at 3:00 p.m. at the Senior Center.
- G. Task Force On Homelessness June Marie Von Osinski told members the following three suggestions would be presented to City Council at tonight's meeting: signage should be posted at City bus stops urging citizens not to support panhandlers; a 72 hour notice should be posted requiring transients to vacate property and then the Police Department should have the authority to clean up the area; and a program should be established to reunite homeless individuals with their families, providing them with the means to return home.

Wayne Templeton Volunteer of the Year Award

 - 2. Treasurer Barbara Durham reported that the COA is at the half way point for this fiscal year. Presently the budget is showing a net income of \$6,144.52 versus the budgeted amount of (\$3,082.91).

- currently 97 active Senior Share recipients and they will begin adding seniors from the waiting list.
- 3. Housing Liaison Judy Pepiot updated members on the Camino Esperanza proposed low income 31 unit senior apartment project. The major grant needed to build this project was awarded to Cabrillo Economic Development Corp. in December. Construction is estimated to begin in August 2014. Right now, it is too early to fill out an application or be placed on a waiting list.

- 5. Meals On Wheels Liaison John Williams indicated that there are currently 139 Meals On Wheels recipients. The average age of recipients is 80.

January 27th – There was a Public Hearing Pre-Screening before City Council to consider a new proposal by RAVELLO HOLDINGS, INC. to build up to 182 housing units on the 15.40 acre site at the southeast corner of L.A. Ave/Madera Rd.

- 154 single-family houses, both attached & detached (moderate density)
- 28 apartments or townhomes (high density)
- All market rate but gearing toward entry level buyers
- No age-restricted units

This site was formerly approved in 2008 for 266 units (high density), but never built. That plan included:

- 55 single story living, age restricted condos of various sizes/bedrooms
- Total 67 affordable units between senior/multifamily
- Universal Design to aid independent living

I requested that the 28 high density units be considered for age-restricted rental apartments & sited the lack of availability in Simi. Council members Steve Sojka & Glen Becerra requested the developer to consider the possibility of a senior component & Mayor Huber also mentioned the Affordable Housing Sub-Committee as a process to determine if any affordable units can be included.

The council unanimously voted to let the project proceed through the formal application process.

January 28th – Senior Concerns hosted a presentation, "Creative Housing Choices for the Second Half". The evening workshop was an ongoing commitment to provide life-planning education for seniors.

As we age, housing is a complex picture that demands creative, flexible, affordable & easy, adaptable solutions. Some topics included:

- Dangers of waiting until a crisis to investigate choices
- Hidden dangers of staying-put in the paid-off family home
- Understanding housing vocabulary terms, i.e., Co-Housing, Continuing Care Retirement Communities etc.
- Exercise packet to help seniors figure out what they want/need most in future housing <u>(See me for copies of this packet)</u>

Public Housing Waiting List opened on Feb 3rd:

The Area Housing Authority of Ventura County is now accepting applications – only from very low income individuals or families. Combined income, adjusted for size, must not exceed 50% of the County Median Income limit. Simi Valley does not have any Public Housing, however, anyone wishing to apply for any county units can now apply. Qualified applicants will be placed in ranking order by date/time of receipt.

CALIFORNIA SENIOR LEGISLATURE FACT SHEET

In 1980, the State Legislature requested the California Commission on Aging to develop a forum through which older Californians could develop their legislative priorities. After consultation with major seniors' groups, the Commission and the State Legislature convened the first session of the California Senior Legislature (CSL) in 1981.

The CSL is a non-partisan, volunteer organization made up of 120 elected members, 60 years of age and older. The 40 Senior Senators and 80 Senior Assembly Members are elected by their peers to represent seniors throughout the state. Elections are coordinated by the 33 Area Agencies on Aging every four years. Any person 60 years of age or older, who is a registered voter and a permanent resident of his/her Planning and Service Area, is eligible to run for the CSL.

The CSL gives senior citizens the opportunity to become familiar with the legislative process through actual involvement, and provides them a forum to present their legislative priorities to the State Legislature.

Each October, the CSL meets in Sacramento to convene a legislative session in the chambers and hearing rooms of the State Capitol. During the session, CSL members participate in presenting and hearing testimony, debating issues and voting approval or disapproval of their senior legislative proposals. Of the approved proposals, the members adopt 10 state and 4 federal priorities, which then receive special attention throughout the year.

Senior Legislators seek state lawmakers to author the CSL priority proposals and then work through the year to ensure adoption of the legislative bills. Since its inception, the CSL has had an excellent track record of accomplishments with better than 45 percent of its priority proposals enacted into law.

The Joint Rules Committee (JRC) has twelve members. During the Annual Legislative Session, five Assembly Members are elected in odd-numbered years and five Senators are elected in even-numbered years, each for four-year terms. The Chair of the Legislative Committee is an ex officio voting member and the Immediate Past-Chair of the JRC is an ex officio non-voting member. The JRC meets no less than six times and the Legislative Committee meets no less than four times annually.

The CSL is funded by the California Fund for Senior Citizens, a voluntary donation check-off item on the California State Income Tax Form. Donations are also made through its CSL/California Foundation on Aging Fund. <u>AP-10: Mandatory Emergency Treatment.</u> This proposal requires all independent living facilities for seniors to have at least one staff member trained in basic emergency treatment.
