DRAFT MINUTES

- 1. Call to Order and Pledge of Allegiance Toni Olson called the meeting to order at 1:00 p.m. Frank Sinsheimer led the Pledge of Allegiance.
- 2. Roll Call Members present were Al Fournier, Fred Goldberg, Richard Harper, David Kennedy, Sharon McCann, Toni Olson, Kenneth Sinn, Frank Sinsheimer, and John H. Williams.
- 3. Agenda Review By a consensus of the Executive Board the agenda was reordered to have item 11.A Election of Officers, to follow the Approval of the Minutes.
- 4. Approval of Minutes The minutes of January 13, 2014 were approved by a consensus of the Executive Board.
- 11. New Business
 - A. Election of Officers for the Council On Aging Executive Board

- 5. Report of COA Chair Antoinette Olson thanked the outgoing Board members for their dedicated service.
- 6. Representative Reports
 - A. City Council Liaison Council Member Mike Judge clarified that the City Council is addressing the problem of homeless individuals who commit crimes, not those who abide by the law. He went on to say the City Council will not tolerate criminal behavior in our City. He informed members that there is a Task Force on Homelessness meeting on Thursday, February 13 in the Community Room at City Hall at 3:30 p.m. He also mentioned that the City has a balanced budget and that City Council was able to give staff a small salary increases to offset the pay reductions that were put in place a couple of years ago. A member asked about a rumor that a fourth Walmart was being proposed for Simi Valley.

Council Member Judge said that he is not aware of a fourth Walmart, however, the Walmart on Tapo Street will be opening on March 22. Another member asked about the empty storefront in Woodranch where a Fresh and Easy grocery store was supposed to open. Council Member Judge said Fresh and Easy will not be going into that space and no other tenant is interested at this point. He also told members to be on the lookout for information on several community events coming up in the next several months including the Roundup on April 12, the Street Fair on May 10 and the Cajun Festival on May 24 and 25.

- B. Deputy Director/Community Programs & Facilities Rob Bruce announced that nominations are being sought for the Community Volunteer of the Year Award and applications are available at the front desk at the Senior Center and on the City's website www.simivalley.org The award is given to a City of Simi Valley resident for extraordinary volunteer service to the community. Laurie Dickinson reminded members that last year, Judy Pepiot, the COA Housing Liaison, was the recipient of the City Volunteer of the Year Award.
- C. Senior Services Manager Laurie Dickinson explained that the Moorpark College oral history project had its orientation meeting. The project partners seniors with college students from a U.S. History class. Students meet with their senior partner at least twice to share their memories of historical events. The student then creates a poster depicting the senior's life to display in the Senior Art Gallery during the month of June. She also announced that there is a presentation by the U.S. Postal Service on fraud at the Senior Center on February 25 at 1:30 p.m.
- D. Area Agency on Aging Representative(s) Toni Olson stated that the Board meets next week. She said she is a member of the Senior Nutrition Committee and that two of the Senior Nutrition sites did not appropriately utilize funds that were given to them.
- E. Simi Valley Community Council David Kennedy stated the Council will meet on February 13 at the Junk Yard Café and he will pass out Bingo Bonanza flyers to the attendees.
- F. Simi Valley Transit Transit Supervisor Christopher Latham announced that applications for the ADA Paratransit Advisory Committee are being accepted through February 21 and are available at the Senior Center main reception desk or on the City website at www.simivalley.org. He told members a Transit Awareness workshop was held at the Senior Center on February 5 and approximately 30 people attended. He also said the Ventura County Transportation Commission is holding meetings throughout the County for the public to address unmet transit needs and

that flyers with the times and locations of the meetings are at the main reception desk at the Senior Center.

- G. Task Force on Homelessness June Marie Von Osinski had no report.
- H. California Senior Legislature Bill Witt told members the CSL is a volunteer body that meets in Sacramento each October to author priority proposals relating to senior concerns. He then explained some of the top legislative proposals the CSL supported in 2013.

7. Presentations

- A. Volunteer of the Month Laurie Dickinson presented the Volunteer of the Month award to Jean Bennett. Jean has been a Meals On Wheels driver for 16 years, she teaches an AARP driving course for seniors, and served on the COA Executive Board.
- B. The Brown Act Assistant City Attorney Felicia Liberman gave a presentation on California's "sunshine law" which known as the Brown Act. She explained the caveats involved when serving in public office, and offered advice on how to handle certain situations.
- 8. Public Statements Everett Johnson requested information about a five thousand dollar grant application opportunity for MPR entertainment. COA Chair Olson said she would look into the situation and get back to Mr. Johnson.
- 9. Officer, Liaison, Program Manager, and Ad Hoc Committee Reports

A. Officer Reports

- 1. Vice Chair Al Fournier had no report.
- 2. Treasurer Sharon McCann briefed the members on the financial status of the COA and stated that the COA is in great financial shape.
- 3. Corresponding Secretary Frank Sinsheimer had no report.

B. Liaison & Program Manager Reports

- Speakers Bureau Program Manager John Williams had no report.
- 2. Senior Share Liaison Joe Beautz reported that extra food is being donated which requires more driving to pick it up. He is requesting anyone who might be interested in driving to pick up food from the

grocery stores when the regular drivers are absent to contact him. He also told members that several clients have been removed from the program, so six clients will be added from the waiting list.

Housing Liaison – Judy Pepiot attended a public hearing prescreening before the City Council to consider a new proposal by Ravello Holdings, Inc. to build 182 housing units at the corner of Los Angeles Avenue and Madera Road. She said that several years ago when the project was proposed for this property, it included senior housing, but this new project does not. Ms. Pepiot said she requested that the 28 of the high density units in this project be for age restricted rental apartments.

Ms. Pepiot attended a presentation given by Senior Concerns on "Creative Housing Choices for the Second Half" which discussed planning your housing needs as you age. She also announced that the Area Housing Authority of Ventura County is now accepting applications for the public housing waiting list. There are presently no public housing units in the City of Simi Valley.

- 3. Lifeline Liaison Don Novell gave a summary of the Lifeline Program. The program has expanded service to Newbury Park, Camarillo, and Thousand Oaks, as well as Simi Valley and Moorpark. He also informed members he is willing to look into a system that can be used by subscribers who have cell phones but do not have landlines.
- 4. Meals On Wheels Liaison John Williams reported the program added 13 new clients, for a current total of 140 clients. Currently there are 28 volunteer drivers so there is no need for more drivers at this time. On behalf of the drivers and Meals on Wheels Coordinator, he congratulated Jean Bennett for being named Volunteer of the Month and said she also is the one who sends birthday cards to all of the MOW recipients.

C. Ad Hoc Committee Reports

 Dance Committee – Richard Harper announced the Valentine's Day dance is this Friday, February 14. He said the dances are doing well and net a small profit. He thanked the Dance Committee members and said they could use a couple more volunteers to help out at the dances.

- 2. Annual Fund Drive Committee Sharon McCann stated that the fund drive was over and it raised \$10,000. However, she said that business contributions were down.
- 3. Bingo Bonanza Committee Sharon McCann reported that they have sold 74 tickets to date which is about average. She also reported that an opportunity drawing for chances to win a Ridealong with a Simi Valley police officer is available this year. She also added that she would welcome more volunteers to help on the day of the event.
- 4. Arts & Crafts Fair Committee Toni Olson announced that the Spring Arts and Fair will be held on March 28 and 29 and that they increased the price for a table from \$40 to \$50 this year. Even so, all but six tables have already been sold.
- Wellness Expo Committee John Williams, who is co-chairing this event with Barbara Durham, reported that the advertising campaign was initiated that morning. Letters have been sent out to previous advertisers and new advertisers will be sought. He encouraged members to approach businesses they frequent to purchase a \$50 business card advertisement.

By a consensus of the Executive Board, Barbara Durham was appointed to serve as the COA representative to the Special Event Support Review Committee.

- 12. Announcements of Upcoming Events Judy Pepiot announced the Civil War Encampment at Strathearn Historical Park will take place on February 15 and 16. She also announced there will be pre-round up pancake breakfast on March1 at the barn at Hummingbird Nest Ranch and told members to come to her for more information.

Home Rehabilitation Program - CITY OF SIMI VALLEY (REMINDER OF AVAILABILITY)

Is your home in need of health and safety related repairs? Does your roof leak? Do you need plumbing, heating, or other repairs? Do you need to accommodate handicapped residents?

Although interest rates are at historical lows, many homeowners find it difficult to obtain a home improvement loan in today's lending environment. As a Simi Valley resident, you may qualify for assistance under the City's Home Rehabilitation Program. Since 1981, the City has provided loans to over 700 households.

The Program offers low interest deferred loans to low-income homeowners. Qualified owners of detached single-family residences are eligible for a deferred 2% loan with no monthly payments. Full repayment is required when the property is sold, refinanced, leased, or changes title. The maximum loan amount is \$50,000.

The household's anticipated gross income (income before taxes) cannot exceed the limits found on the <u>Affordable Housing page</u>.

The Home Rehabilitation Coordinator will assist with the following items:

- Identify health and safety hazards in your home;
- Assist the homeowner in the application procedure;
- Help the homeowner obtain and select estimates from qualified contractors.

The <u>Home Rehabilitation Program Application</u> and the <u>Program's Policies and Procedures Manual</u> are available in electronic format, or by calling the Home Rehabilitation Coordinator at (805) 583-6757. Complete and return the application and all required documents to the Home Rehabilitation Coordinator at City Hall, <u>2929 Tapo Canyon Road</u>, Simi Valley.
