7. Informational Presentations

a. Youth Council Purpose, Goals, By-laws, Organization and Meetings

Ms. Tignac provided an overview of the Youth Council Purpose, Goals, By-Laws and Organization of the Youth Council and highlighted some of the Youth Council accomplishments to date.

Ms. Tignac also discussed the importance of the Youth Council's Work Plan in order to accomplish the Youth Council goals that members would set during the October Youth Council meetings.

b. Overview of the Role of the City Attorney and Ralph M. Brown Act, Felicia Liberman, Assistant City Attorney

Assistant City Attorney Felicia Liberman gave a brief overview of the role of the City Attorney's office and provided an interactive presentation on the purpose of the Ralph M. Brown Act, known as the "Sunshine", or "open meeting" law.

8. New Business

f. Discussion of Teen Town Hall on Thursday, October 2, 2014

Anthony Pennay, Director of the Walter and Leonore Annenberg Presidential Learning Center, announced that they would be hosting a Youth Town Hall on Thursday, October 2014, at the Ronald Reagan Presidential Library and Museum with a panel comprised of; 38th District Assemblyman Scott Wilk, Ventura County Superintendent of Schools Stanley C. Mantooth, Simi Valley Mayor Bob Huber, and Deborah Salgado, Simi Valley Unified School District's Director of Secondary Education.

To help the event be youth-led, Mr. Pennay invited the Youth Council to help with pre-event activities and to assist at the event as youth moderators. He stated that he has invited all Simi Valley Unified School District middle and high schools to each send 40 to 50 students. He anticipates 500 to 1,000 students will attend.

a. Officer Duties and Election of Officers

Ms. Tignac gave a brief overview of the Youth Council Officer duties and responsibilities. The following Youth Council members were nominated for the position of Chair: Nicholas Becerra and Nicolas Mintzer. Nicholas Becerra received the most votes and was selected as Chair.

The following Youth Council members were nominated for the position of Vice Chair: Chris Busco, Alex Judge, Nicolas Mintzer and Nick Steinwender. Nick Steinwender received the most votes and was selected as Vice Chair.

The following Youth Council members were nominated for the position of Sergeant-at-Arms: Hannah Faulwell, Alex Judge, Leah Nohrenberg, Kellie McManamon and Nicolas Mintzer. Kellie McManamon received the most votes and was selected as Sergeant-at-Arms.

The following Youth Council members were nominated for the position of Secretary: Chris Busco, Annika Paseta, Kailey Printz, Veronica Martinez and Nicolas Mintzer. Veronica Martinez received the most votes and was selected as Secretary.

Nicolas Mintzer made a motion to approve Nicholas Becerra as Chair, Nick Steinwender as Vice Chair, Kellie McManamon as Sergeant-at-Arms and Veronica Martinez as Secretary for the 2014/15 Youth Council term. Nick Judge seconded. The motion passed unanimously.

b. Selection of Youth Council Representatives to: Task Force on Homelessness and Youth Employment Service Advisory Board

Kristin Tignac gave a brief overview of the Task Force on Homelessness and Youth Employment Service Advisory Board, as well as, the Youth Council representative's required responsibilities.

The following Youth Council members were nominated for the position of Youth Council representative for the Task Force on Homelessness: Zalma Quezada and Nick Steinwender. Nick Steinwender received the most votes and was selected as the Youth Council representative for Task Force on Homelessness and Zalma Quezada was selected as the alternate, if Mr. Steinwender is unavailable to attend a meeting.

The following Youth Council members were nominated for the position of Youth Council representative for the Youth Employment Service (YES) Advisory Board: Veronica Martinez and Nick Steinwender. Veronica Martinez received the most votes and was selected as the Youth Council representative for YES Advisory Board.

Nick Steinwender made a motion to approve the following Youth Council representatives to other City boards: Nick Steinwender as the Task Force on Homelessness representative; Zalma Quezada as the Task Force on Homelessness alternate; and Veronica Martinez as the Youth Employment Service (YES) Advisory Board representative. Alex Judge seconded. The motion passed unanimously.

c. Selection of the 2015 Youth Summit Committee

Ms. Tignac gave a brief overview of the role and responsibilities of members of the Youth Summit Committee. She stated that Youth Summit Committee meetings would be held at 4:15 p.m. immediately preceding the regular Youth Council meetings held on the first and third Tuesdays of each month.

Chair Nicholas Becerra asked for volunteers to participate on the Youth Summit Committee. After a lengthy discussion, Chris Busco, Allison Gillies, Nick Judge, Veronica Martinez, Kellie McManamon, Nicolas Mintzer, Leah Nohrenberg, Kailey Printz, Zalma Quezada, Nick Steinwender and Alex Judge as an alternate were selected to serve on the 2015 Youth Summit Committee. A motion to approve the committee as presented was made by Leah Nohrenberg and seconded by Zalma Quezada. The motion passed unanimously.

d. Discussion of the re-scheduled date for the Youth Council-inspired Teen Drive-in Movie Night on Friday, September 19, 2014

Ms. Tignac stated that the Rancho Simi Recreation and Park District and Simi Valley High School had selected a date for the Youth Councilinspired Teen Drive-in Movie Night which was cancelled last October due to high winds. The re-scheduled date for the screening of the Avengers movie would be on Friday, September 19, 2014, with the gates opening at 6:30 p.m.

Ms. Tignac stated that the Youth Council has been asked to help coordinate during the event.

Chris Busco made a motion to approve Youth Council's participation in the Youth Council-inspired Teen Drive-in Movie Night on Friday, September 19, 2014.

e. Discussion of Suicide Prevention Awareness event in collaboration with the Simi Valley Public Library on Monday, September 29, 2014

Ms. Tignac announced that the Youth Council had an opportunity to collaborate with the Simi Valley Public Library for a suicide prevention awareness event on Monday, September 29, 2014, as well as request that the City Council proclaim September 2014 as Suicide Prevention Month. To prevent suicide and allow a youth-led discussion on the topic, Youth Council may offer a film screening and follow-up discussion of the California Mental Health Services Authority (CalMHSA) Directing Change Student Public Service Announcement (PSA) Contest regional and statewide winners in the categories of suicide prevention and ending the silence of mental illness.

Veronica Martinez made a motion to approve the Youth Council's involvement in hosting a suicide prevention film screening followed by a Youth Council led group discussion for Suicide Prevention Month. Leah Nohrenberg seconded. The motion passed unanimously.

She stated that City of Simi Valley and Rancho Simi Recreation and Park District staff have coordinated a multiagency Anti-Bullying Forum and Resource Fair to take place on Thursday, October 2, 2014, from 6:00 p.m. to 8:00 p.m. in the Simi Valley Public

Library's community room, which would be during National Stop Bullying Month. The panel presenters include representatives from the Ventura County District Attorney's Office, Simi Valley Police Department, Simi Valley Unified School District and Ventura County Behavioral Health.

Chris Busco made a motion to approve the Youth Council's participation in the Anti-Bullying Forum and Resource Fair on Thursday, October 2, 2014. Hannah Faulwell seconded. The motion passed unanimously.

h. Discussion of the Youth Council's potential participation in the Living Green Expo on Saturday, September 27, 2014
